



The Private Planning Association of Canada is an independent, non-profit economic research organization. Established in 1958, it is sponsored by a large number of private donors, mainly business firms, labour unions, agricultural federations, and similar bodies, which make annual financial contributions in support of the Association's work. Specific research studies or study programs have, from time to time, also received assistance from such institutions as the Ford Foundation, the Economic Council of Canada, and (under carefully defined conditions) the federal and some provincial governments.

It is the purpose of the Association to commission research studies on problems of major national and international importance, publishing the resulting reports and distributing them widely among interested people in business, academic life, government, and elsewhere, throughout Canada and abroad. The research work is undertaken by professional economists and other specialists, who are chosen for their technical knowledge of the fields concerned. Under the direction of the Association's permanent staff, the resulting reports are subjected to a process of examination and discussion by groups of businessmen, labour leaders, and similar "men of affairs," before being published. At all times the aim is to present the activated developed in a style that is clear and concise, so that it may be considered to people not trained in economics. In this way the Association endeavours to make a contribution to the quality of public discussion of policy issues.

The Association is representative of the private sector only, not because it is in any way opposed to governmental activities, but because its members believe that governments are now well equipped with professional skills and technical understanding in the relevant fields, whereas private firms, labour unions, agricultural federations, and so on, are sometimes not adequately informed on complex issues. It enjoys excellent relations with governments, at all levels, even though their elected representatives and civil servants are not permitted an active role in the Association's affairs.

The Private Planning Association is essentially an administrative unit, under the auspices of which are operated various activities. The most important of these are the Canadian Trade Committee and the Canadian-American Committee.

The Canadian Trade Committee

The Canadian Trade Committee is a group of senior businessmen, labour leaders, directors of farmers' organizations, university professors, and similar individuals representative of a broad cross-section of interest and opinion throughout Canada. At meetings twice each year, and through communication with the Committee's staff at other times, this group gives direction to a continuing program of research into problems and opportunities confronting Canada, particularly (as the name implies) regarding trade and other international economic relations, but also with respect to more purely domestic issues.

This research program, which is organized and administered by a small secretariat in the Committee's offices in Montreal, frequently involves the commissioning of studies which are undertaken either by professional economists on the staff or by outside specialists. The resulting reports are published as the work of the author(s) concerned, but they carry the signed approval of Committee members as to quality of content, if not necessarily as to views expressed or conclusions drawn. Members are provided the opportunity to make comments qualifying, expanding, or dissenting from the author's points, and these are frequently included in the reports as footnotes.

The Canadian-American Committee

The Canadian-American Committee differs from the Canadian Trade Committee in that it is jointly operated by the Private Planning Association of Canada and the National Planning Association in Washington. In most other respects, however, the two Committees are very similar. The Canadian-American Committee includes business, labour, farm, university, and professional leaders, but in this case from both Canada and the United States. Meetings of this group are held twice a year, when an ongoing research program is discussed and new studies are initiated.

As with the other Committee, the reports of the Canadian-American Committee are prepared either by its professional staff (in Montreal and Washington) or by outside experts (in Canada or the United States). The studies published bear the members' signatures only as to the quality and importance of the work, not necessarily as to the authors' views or findings.

Occasionally, however, the Committee publishes a different type of document, a policy statement, in which it sets forth its own attitude to a problem or issue of the day, the members in this case signing the report itself.

The Atlantic Economic Studies Program

In 1965 the Private Planning Association of Canada commenced a large-scale research project financed in part by the Ford Foundation. This undertaking, the Atlantic Economic Studies Program, is designed to explore the implications for Canada of growing economic interdependence among the industrialized nations of North America and Western Europe. Its twenty-odd studies are being published by the University of Toronto Press during 1968 and 1969.

Other Activities

Recently the Private Planning Association has embarked on some assignments organized in a rather different way than its usual study programs. Under its terms of reference, the Association may undertake, on a contract basis, any study of issues that have a sufficiently broad economic and social significance. The board of directors has approved a few such contract assignments, to be carried out for particular public agencies. They include an appraisal of provincial economic policies and a study of the probable impact of closer trade relations between Canada and the Commonwealth Caribbean countries.

Membership

Membership in the Association is secured through an annual contribution to its work, the amount of which is at the discretion of the donor organization. Such contributors receive complimentary mailings of all the publications of the two Committees, as well as other appropriate material. (Membership in the Canadian Trade Committee and the Canadian-American Committee is by invitation, following a decision of the relevant nominating committee.)


