## Are you First Nations, Inuit, or Métis?

Doing your taxes has benefits.

### How do you get benefits and credits?

You and your spouse or common-law partner need to do your taxes by April 30 each year to get the benefits and credits you may be eligible for, even if your income was tax exempt or you had no income. If you live in Quebec, you also have to do a provincial tax return. To do your taxes and apply for benefits and credits, you need a social insurance number. ### How much could you get per year?

**CCB** – up to **\$7,437** for each child under 6 years of age and up to **\$6,275** for each child aged 6 to 17. Apply for all children in your care if you have not applied previously and nobody is receiving it for them. Claim child care expenses if you paid to have someone look after your children.

**GST/HST credit** – up to **\$496** for an eligible individual and up to **\$992** for an eligible couple with two children.

**Canada workers benefit** – up to **\$1,518** for an eligible individual and up to **\$2,616** for an eligible family. This refundable credit reduces the tax you owe first and any remaining credit is refunded to you.

To apply for the **Canada child benefit (CCB)** and to register the children in your care for the **goods and services tax/harmonized sales tax (GST/HST) credit**, use "Apply for child benefits" in My Account or go to [canada.ca/cra-forms](https://canada.ca/cra-forms) and complete Form RC66 Canada Child Benefits Application.

**Disability tax credit** – eligible individuals with a disability or their supporting family member may claim **\$9,428** as a non-refundable tax credit. Persons under 18 years of age at the end of the year may also claim an additional amount of up to **\$5,500**. Go to [canada.ca/disability-tax-credit](https://canada.ca/disability-tax-credit).

**Northern residents deductions** – you may qualify if you lived in a prescribed zone for a continuous period of at least six consecutive months. For more information, go to [canada.ca/taxes-northern-residents](https://canada.ca/taxes-northern-residents).
