



Figure 55 Basement floor drains

"(1) Except as otherwise required in Articles 7.5.1.2. to 7.5.1.4., a section of a soil-or-waste stack or of a branch that is extended as a continuous vent may serve as a vent pipe for not more than

(a) one water closet and three other fixtures installed on the same floor, provided

(i) the developed length of each fixture drain does not exceed 5 ft (1.5 m).

(ii) all fixtures connect separately and directly into the soil-or-waste stack or branch,

(b) two water closets and three other fixtures installed on the same floor provided the installation conforms to the requirements of Clause (a) and the water closets are connected separately and directly into the stack through an approved double fitting."

Delete and substitute:

"at least 3 ft (0.9 m) above or 12 ft (3.7 m) in any other direction from every air inlet, openable window or door".

At the end of the clause add "and".

Add new clause as follows:

"(d) at least 6 ft (1.8 m) from every property line."




Figure 68 Location of vent pipe terminal
