Council members approved the following amendments after internal analysis and careful review of supporting documents and rationale provided.

January 23, 2024

The first amendment was to the Canadian Hatching Egg Producers Quota Regulations, submitted by the Canadian Hatching Egg Producers (CHEP). After a thorough review and internal analysis, Council members approved the amendments to the 2024 revised

allocation of 897.3 million broiler hatching eggs, a decrease of 1.4%. The 2024 allocation runs from January 1st, 2024 to December 31, 2024. The second amendment was to the Chicken Farmers of Canada (CFC) General By-Laws submitted by the agency on December 11, 2023. Council members reviewed the proposed amendments for the Chair and Directors' per diem fees. Following a thorough review of the rationale provided and internal analysis, Council members considered and approved the changes requested.

The second amendment was to the Canadian Turkey Marketing Levies Order (2019) further to Turkey Farmers of Canada (TFC)'s letter of January 15, 2024, requesting the extension of the production levy with an expiration date of March 31, 2025. TFC's Board of Directors approved the 2024 budget, which is supported by a production levy rate of

March 21, 2024 During this meeting, Council members reviewed the following amendments:

The first amendment was to the Canadian Chicken Marketing Quota Regulations, submitted by CFC on February 12, 2024. Council members carefully reviewed the request and concluded that the revised quota allocation for period A-189 was necessary for the implementation of CFC's marketing plan. Council members approved the proposed total

allocations (domestic, market development and specialty) of 297,341,007 kg live weight. Council members reviewed a request submitted on January 22, 2024 by TFC to amend the Canadian Turkey Marketing Quota Regulations 1990, to set the federal quota of turkey at 172,488,502 kg for the 2024/2025 control period. The turkey market conditions changed significantly since this decision was made in November 2023, which resulted in TFC amending the Quota Regulations for the 2024/2025 control period at its meeting on March 20, 2024. Considering this recent decision by TFC, Council members were not satisfied that the proposed Quota Regulations were necessary for the implementation of the marketing

plan as contained in the Canadian Turkey Marketing Agency Proclamation. Council

members await TFC's revised Quota Regulations submission. Farm Products Council of Canada Levy Committee December 14, 2023 FPCC's Levy Committee approved the proposed amendment to the Canadian Chicken Marketing Levies Order. The amendment reflects an increase in the Total levy rate from 1.63 to 1.65 cents per kg (live weight) for Newfoundland and Labrador's assessment on chicken producers of its province for the marketing of chicken in interprovincial and export trade.

FPCC's Levy Committee approved the proposed amendments to the Canadian Broiler Hatching Egg Marketing Levies Order, as requested in CHEPS' letter of November 23,

2023. The amendments reflect an increase in the provincial levy in Saskatchewan from \$0.0100 to \$0.0184 per broiler hatching egg, which has caused the levy for eggs marketed from a non-signatory to a signatory province to increase from \$0.014737 to \$0.016137 per

broiler hatching egg. The proposed Levies Order came into force on the date of registration

and will expire on June 23, 2024. **January 24, 2024** FPCC's Levy Committee approved the proposed amendments to the Canadian Egg Marketing Levies Order. This request is in accordance with Egg farmers of Canada's process to amend the Federal Levies Order upon notification of changes to provincial/ territorial levy amounts. - On December 4, 2023, FPCC received a complaint from Simple Path Farms and Poultry Ltd. against Chicken Farmers of Canada (CFC) regarding CFC's November 2, 2023, Market Development Final Assessment for periods A-174 and A-175.

FPCC Chair, Brian Douglas, in accordance with section 18 of the FPCC Complaint By-Law, formed the Complaint Committee and appointed Maryse Dubé as Chair and Council Vice-Chair Bonnie den Haan as an observer. The Complaint Committee granted the Intervener Status request of the Chicken Primary processing sector of the Canadian Poultry and Egg Processors. The Hearing was held on April 17th, 2024. The documents related to the

complaint are posted on FPCC's website. NAASA January 16, 2024 meeting The National Association of Agri-Food Supervisory Agencies (NAASA) held a virtual meeting on January 16, 2024, which focused on inflation. Members heard from Graeme

Crosbie, Senior Economist at Farm Credit Canada who provided an in depth analysis of the impacts of inflation on the agriculture and agri-food industry. A special presentation was also provided by Michael Laliberté, Executive Director of Chicken Farmers of Canada on their Animal Care Program and their efforts in obtaining government recognition for the

provincial roundtable session. The meeting also included a presentation from the Canadian Poultry and Egg Processors (CPEP) on their current challenges. This meeting was the last meeting for Peter Donkers from British Columbia as Chair of NAASA and for Ginette Bureau from Quebec as Vice-Chair. NAASA members unanimously selected the next Chair, Amy Cronin from the Ontario Farm Products Marketing Commission and Vice-Chair, Kerrie Halet from New Brunswick Farm Products Commission.






