The Supreme Court consists of the Chief Justice of Canada and \_\_\_\_\_\_ puisne judges. The judges are appointed by the Governor in Council from among superior court judges or Canadians who have been lawyers for at least \_\_\_\_\_\_ years. A judge holds office until they retire or attain the age of \_\_\_\_\_\_ years.


Of the \_\_\_\_\_\_ judges, the *Supreme Court Act* requires that \_\_\_\_\_\_ judges be appointed from Quebec. 



1. The Court's flag that flies on the pole to the east is hoisted daily.



There are 2 flagpoles in front of the building. The Canadian flag flies permanently on the west pole, while the Supreme Court's flag is raised on the east pole only when the Court is sitting.

2. The statues *Justice* and *Truth* were found in a parking lot.



The statues were created by Walter S. Allward for a memorial to King Edward VII, which was never finished. Forgotten, they were rediscovered buried in a parking lot in 1969. They were then placed in front of the Supreme Court in August 1970.

3. Judges of the Supreme Court of Canada are appointed for life.



Judges of the Supreme Court can remain in office until the age of 75, at which time they must retire.

**4.** The Chief Justice of Canada has the final say in all the Court's decisions.



Decisions of the Court are made by the majority of judges. Judges who disagree with the majority result are "dissenting". Any judge can explain their opinion in writing if they want to.

**5.** The Supreme Court of Canada has always been made up of 9 judges.



When the court first sat in 1876, the bench was composed of 6 judges. The number was increased to 7 in 1927 and to the current 9 in 1949.

**6.** Members of the public can attend hearings of the Supreme Court of Canada.



In addition to people involved in a specific case, members of the public can attend hearings.


**7.** At Supreme Court of Canada hearings, *interpreters* translate everything from English to French, and from French to English.






The Supreme Court consists of the Chief Justice and **8** puisne judges. The judges are appointed by the Governor in Council from among superior court judges or Canadians who have been lawyers for at least **10** years. A judge holds office until they retire or attain the age of **75** years.

Of the **9** judges, the *Supreme Court Act* requires that **3** judges be appointed from Quebec. Traditionally, the Governor in Council appoints **3** judges from Ontario, **2** from the Western provinces or Northern Canada and **1** from the Atlantic provinces. The judges must devote themselves exclusively to their judicial duties and must reside within **40** km of the National Capital Region.

The Right Honourable Richard Wagner was appointed to the Supreme Court of Canada on October 5, 2012 and appointed Chief Justice of Canada on December **18**, 2017.
