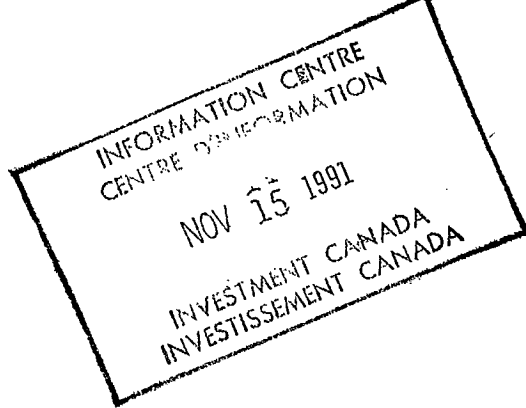

acquisition of control of its parent outside Canada. It will be obvious to readers that indirect and incidental investments are of limited value in analyzing investors' preferences for locations within Canada as in most cases the primary focus of such investments are business operations in one or more other countries.

Two further qualifications of the data and hence the analysis based on it should be noted. First, within the Investment Canada database each investment is identified with a single province - the one with the largest number of employees of the business being acquired. In many cases, there are other provinces in which the acquired business has significant operations. Second, the data for urban centres were compiled on the basis of postal codes and the definitions of urban centres were those used by Canada Post. These definitions are somewhat narrower than the definitions of Census Metropolitan Areas used by Statistics Canada.

## PREFACE

The analysis in this report is based on investments filed with Investment Canada, either as notices of non-reviewable investments or as applications for review, in the period June 30, 1985 to March 31, 1990. The primary purpose of the analysis is to identify investors' locational and sectoral preferences as reflected in their investment decisions.

For completeness, the analysis is based on frequency of investments (number of transactions) and asset values. However, the frequency data are much more useful for purposes of analysis. The asset value data are of limited value in indicating investors' preferences for a number of reasons. The values used are not transaction values. They are planned investments in the first or second year of operations in the case of new business investments and the book value of the Canadian business in the case of acquisitions. The value data are also significantly skewed by a few large acquisitions. Finally, the data have not been adjusted to eliminate proposed transactions that are known not to have been implemented. This latter weakness in the database is not statistically significant with respect to the analysis based on frequency of investments but does further distort the analysis based on asset values.

Also for completeness the data include direct, indirect and incidental investments although each section contains a separate analysis based only on direct investments. Direct investments are investments for the establishment of new businesses and acquisitions of Canadian businesses, either through the acquisition of their voting interests or assets, where the transaction took place in Canada but exclude those acquisitions where the Canadian transaction was part of, or incidental to, a larger international transaction. The latter are referred to in this report as incidental investments. An indirect investment is the acquisition of control of a Canadian business through

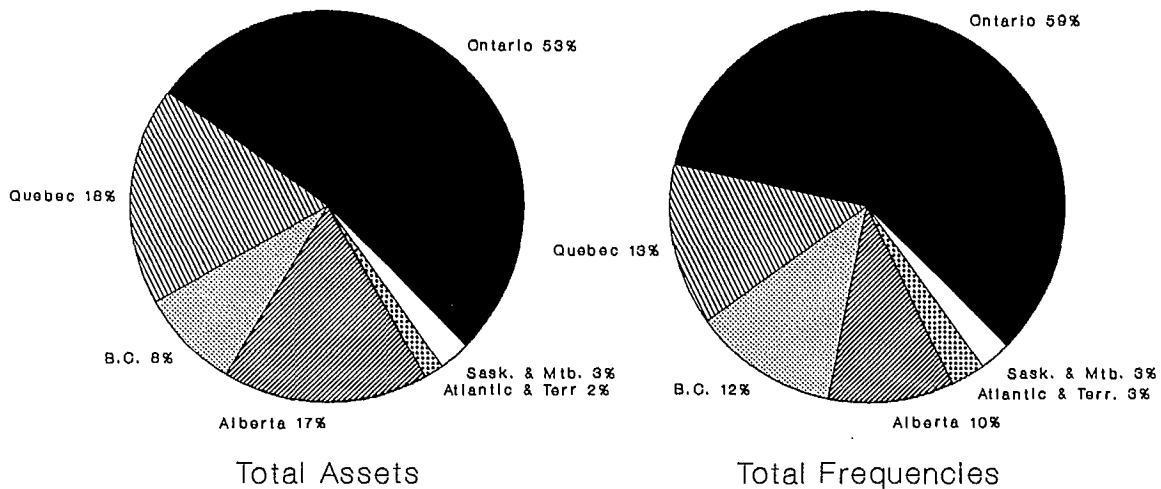

# WORLD - CANADA - AN OVERVIEW

## COMPARISON BETWEEN PROVINCES

Ontario dominates with 53% of the asset value and 59% of the frequency of all foreign investment. Quebec, Alberta and British Columbia are also significant with 18%, 17% and 8% respectively, of the total asset value of investment transactions. Relatively large investments in the petroleum and natural gas industry account for 64% of the asset value of investment in Alberta. The asset value of investment to all the other provinces and territories in Canada accounts for less than 5% of the total.

After Ontario, Quebec, and British Columbia are the most frequent destinations with 13%, 12%, and 10% respectively of the total investment transactions. Only 5% of the total transactions are targeted to all the other provinces and territories.



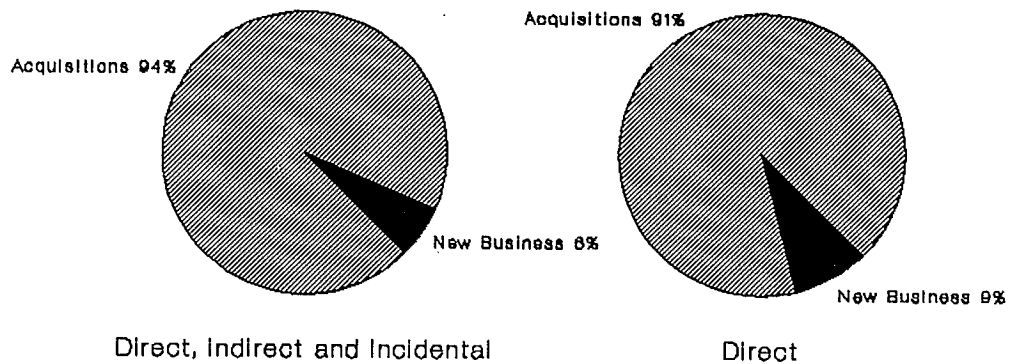

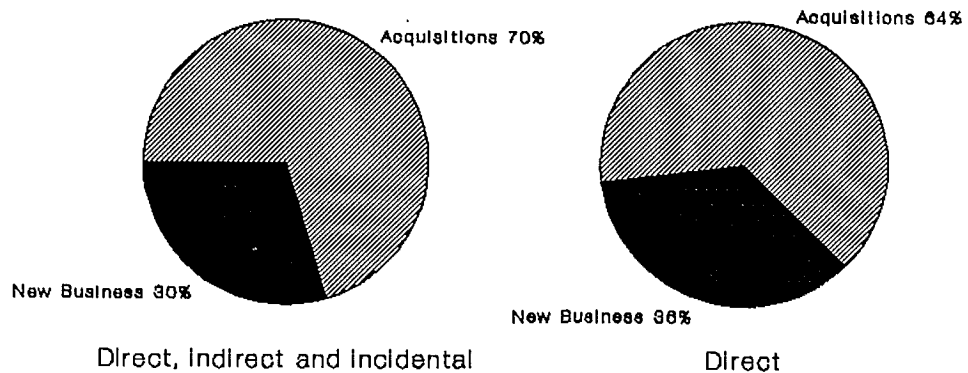

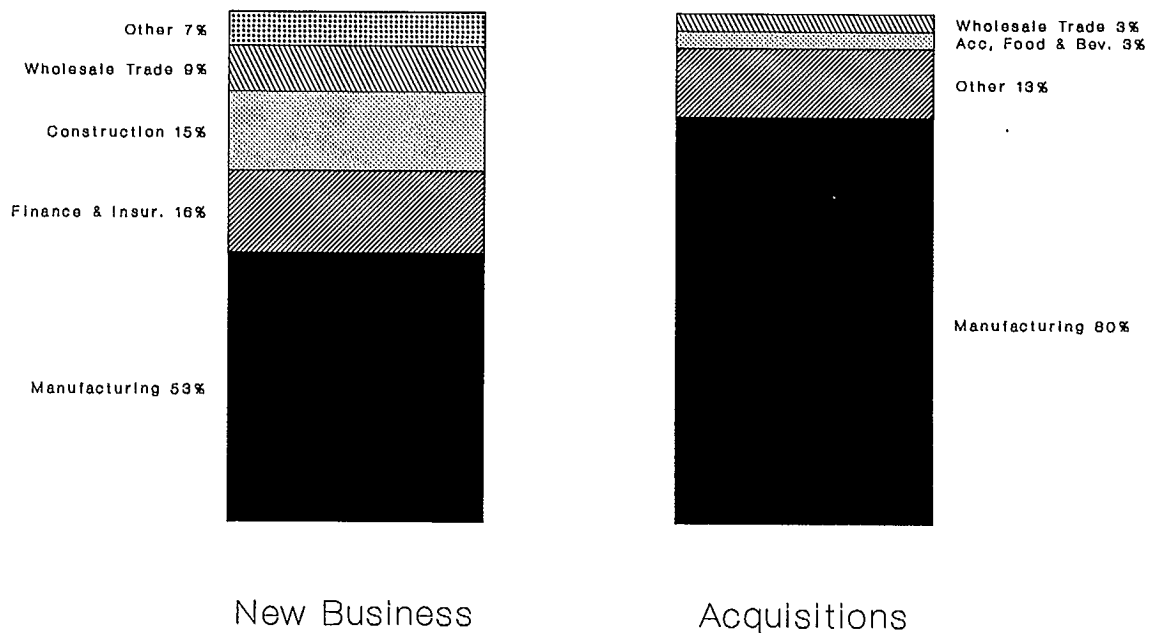

## INDUSTRY SECTORS

Manufacturing is the most popular industry with 46% of the asset value and 33% of the frequency of investment. Petroleum and natural gas industries attract a high 16% of the total asset value, and a lower 5% of the frequency of investment. Mining (7%), wholesale trade (7%), finance and insurance (5%) also attract significant portions of the asset value of investment.

23% of the total frequency of investment is made in wholesale trade. A relatively large portion, 42%, of the transactions in this industry involved new businesses. Business services (10%), real estate and insurance agents (5%), and other services (5%) also attracted large portions of investment transactions.

# WORLD - CANADA 1985-1990 COMPARISON OF PROVINCES



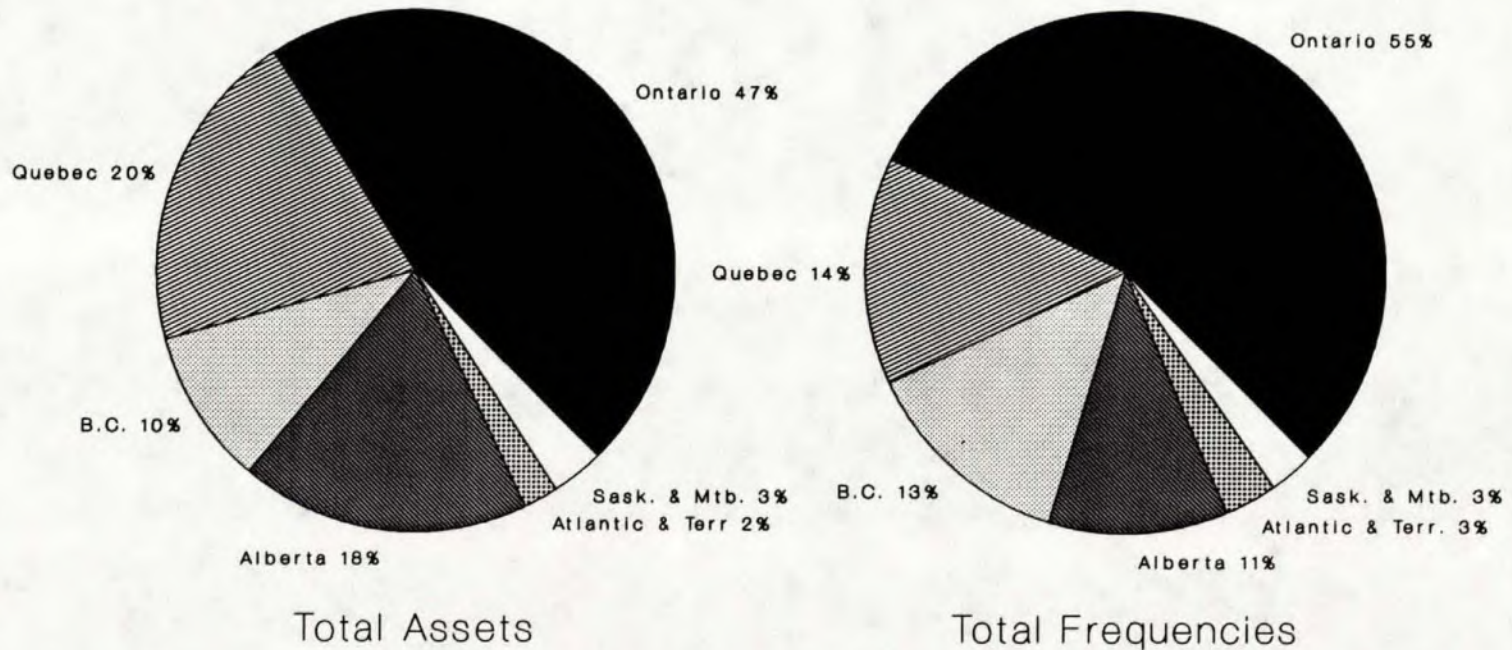

# **WORLD - ATLANTIC PROVINCES - AN OVERVIEW**

## **OVERVIEW**

A very small portion of foreign investment, 1% of the total asset value and less than 3% of the total number of transactions, is made in the Atlantic provinces.

## **COMPARISON BETWEEN PROVINCES**

Nova Scotia is the primary destination of the Atlantic provinces with 48% of the asset value and 53% of the frequency of total investment. Prince Edward Island (21%), Newfoundland (17%), and New Brunswick (14%) follow in terms of the asset value of investment. One new business in the P.E.I. construction industry accounts for 91% of the asset value of investment made there. According to the frequency of investment, Newfoundland (28%), New Brunswick (14%), and P.E.I. (4%) follow Nova Scotia.

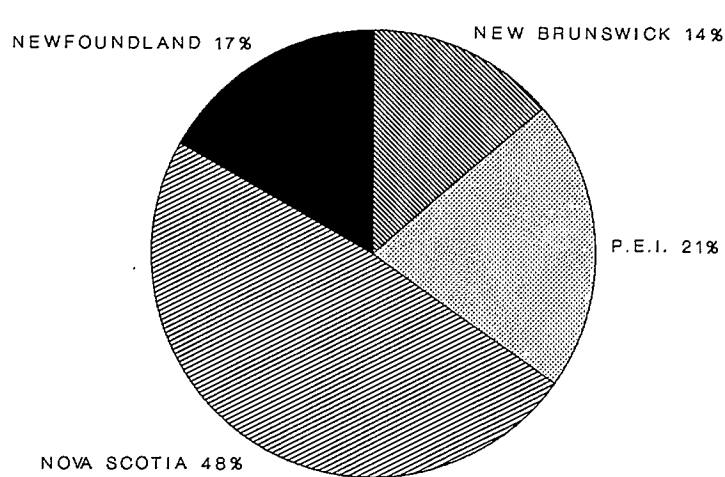
## **TYPES OF INVESTMENT**

94% of the asset value and 97% of the frequency of investment is direct. New business accounts for 52% of the asset value and 28% of the frequency of direct investment.

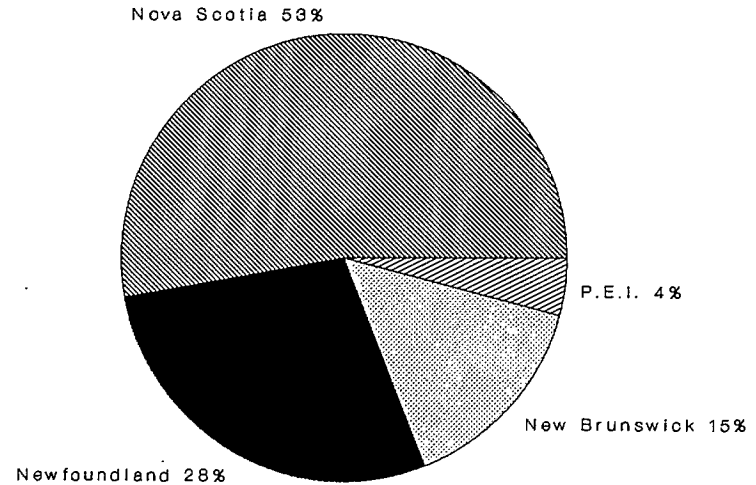
## **INDUSTRY SECTORS**

Mining (21%), construction (21%), petroleum and natural gas (18%), and manufacturing (16%) drew the greatest asset value of investment. Manufacturing (24%) and wholesale trade (22%) were the most frequent sectors targeted by foreign investors.

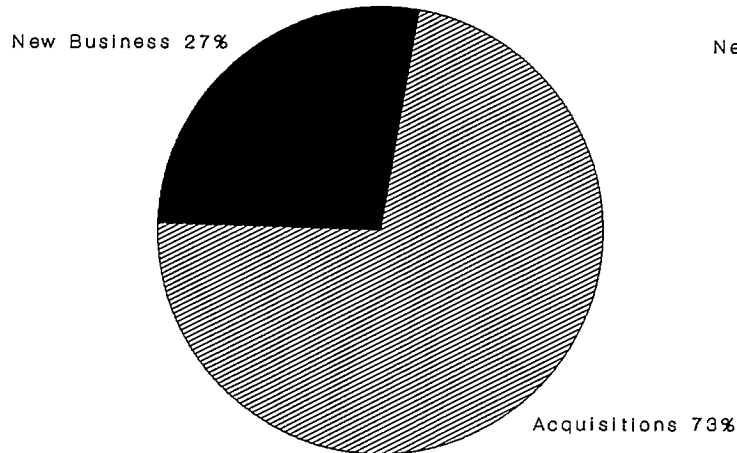

Quebec is the second most popular destination of all foreign investment with 18% of the asset value and 13% of the frequency of the total.

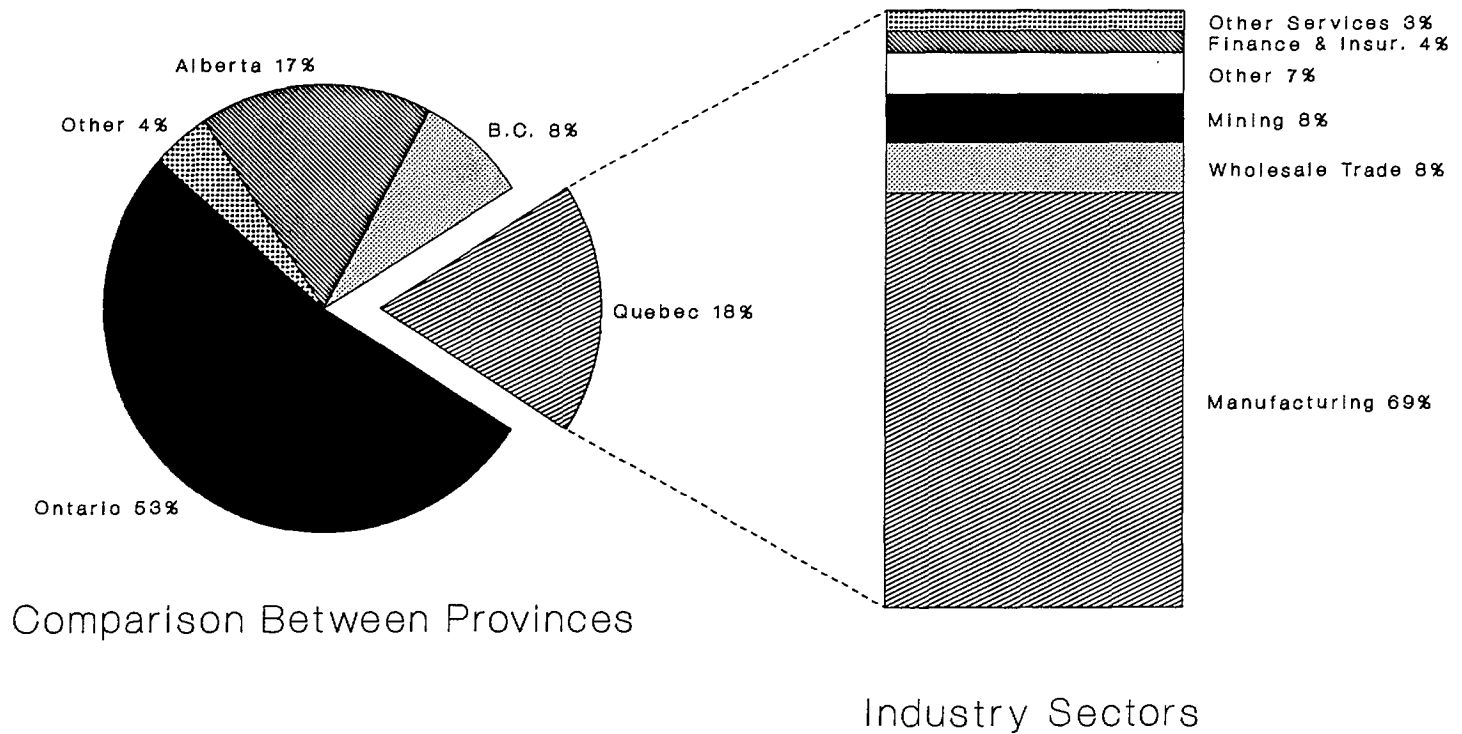
## **TYPES OF INVESTMENT**

79% of the asset value and 88% of the frequency of investment is direct. New business accounts for 16% of the asset value and 32% of the frequency of direct investment.

## **INDUSTRY SECTORS**

Manufacturing is the preferred sector with 69% of the total asset value and 35% of the total frequency of investment transactions. Mining (8%) and wholesale trade (8%) also attract significant portions of the asset value of investment. After manufacturing, wholesale trade (28%) and business services (11%) are the most frequent targets of investors. These sectors are characterized by high number of low asset value transactions involving new businesses.

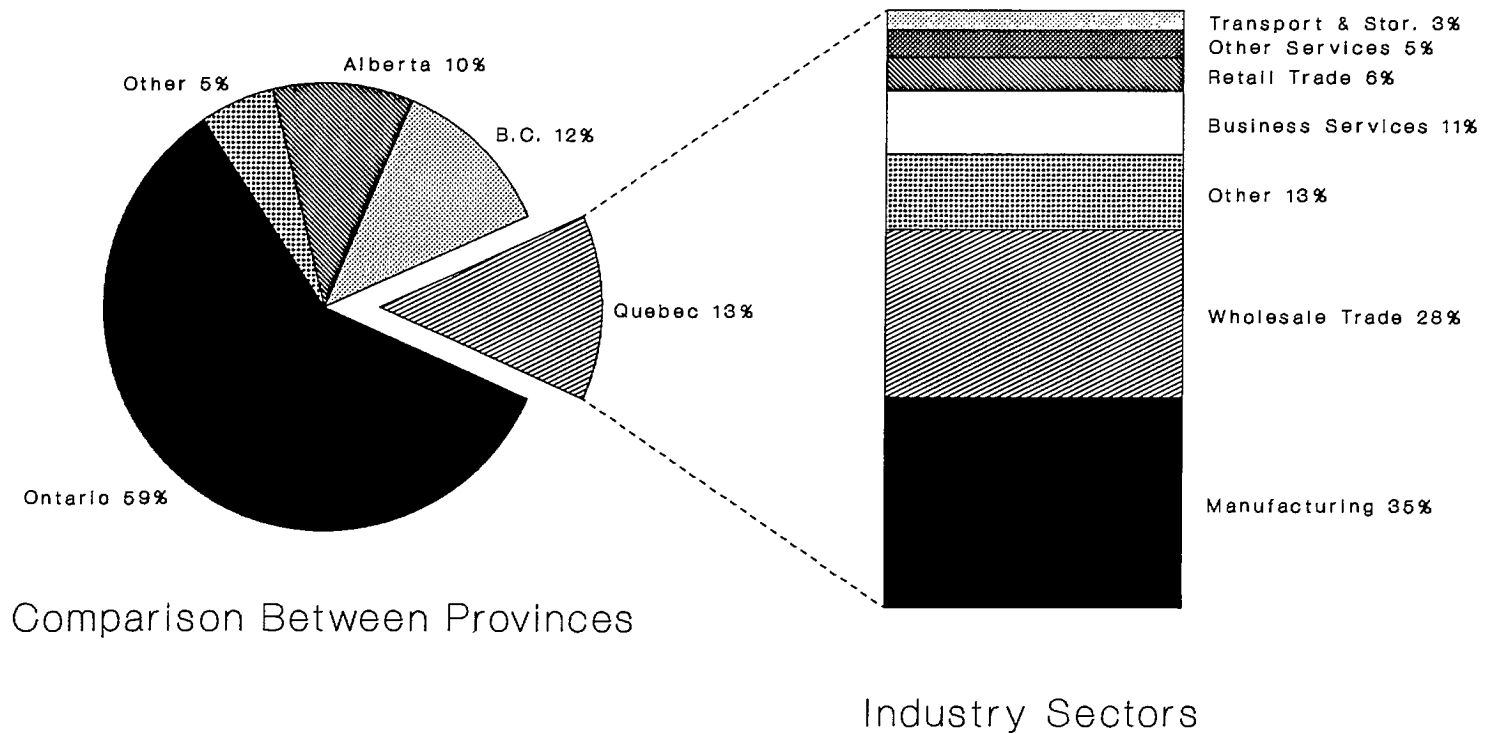
# WORLD - QUEBEC 1985-1990 OVERVIEW TOTAL ASSETS

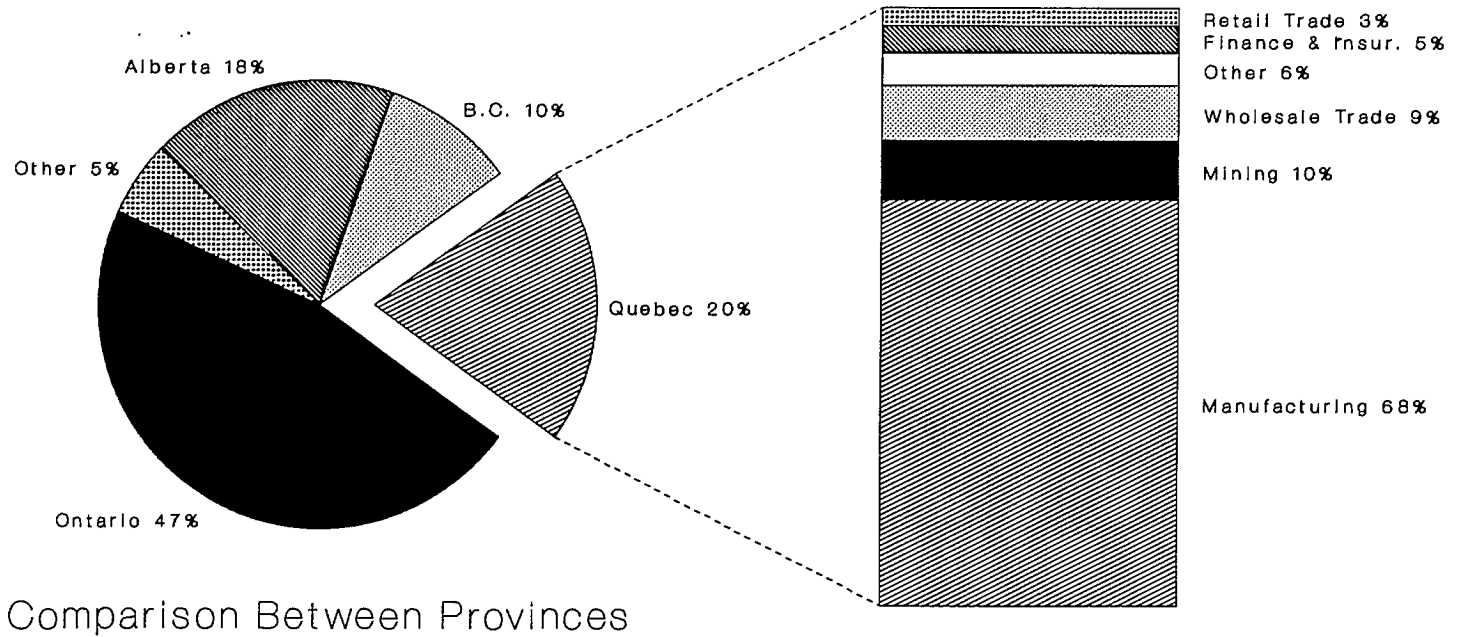


# WORLD - QUEBEC 1985-1990 OVERVIEW TOTAL FREQUENCIES

# **WORLD - ONTARIO - AN OVERVIEW**

## **OVERVIEW**

Ontario is the most popular destination of investment by all foreign investors with 53% of the asset value and 59% of the frequency of the total.

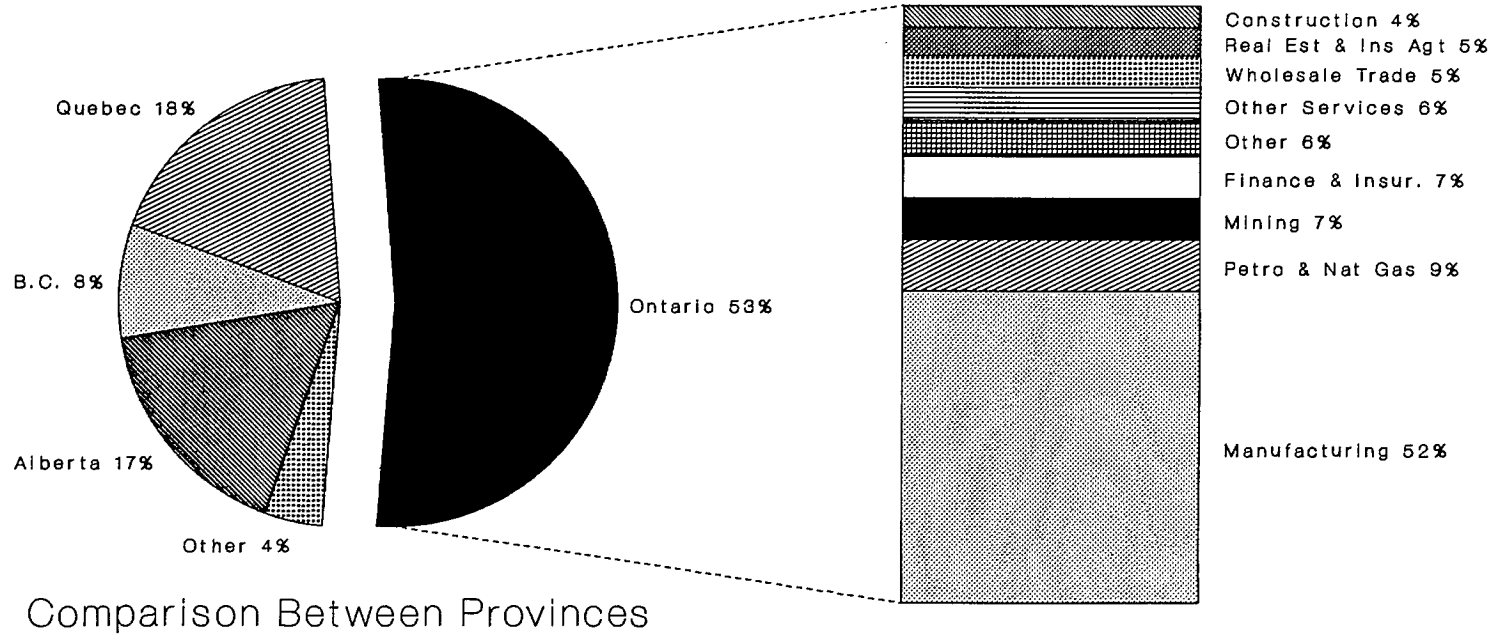
## **TYPES OF INVESTMENT**

64% of the asset value and 78% of the frequency of investment is direct. New business accounts for only 5% of the asset value of direct investment. However, 39% of the total number of direct transactions are new businesses. Large asset values involved in acquisitions, of manufacturing, petroleum and natural gas, and mining operations overshadow the asset value of investment in new business.

## **INDUSTRY SECTORS**

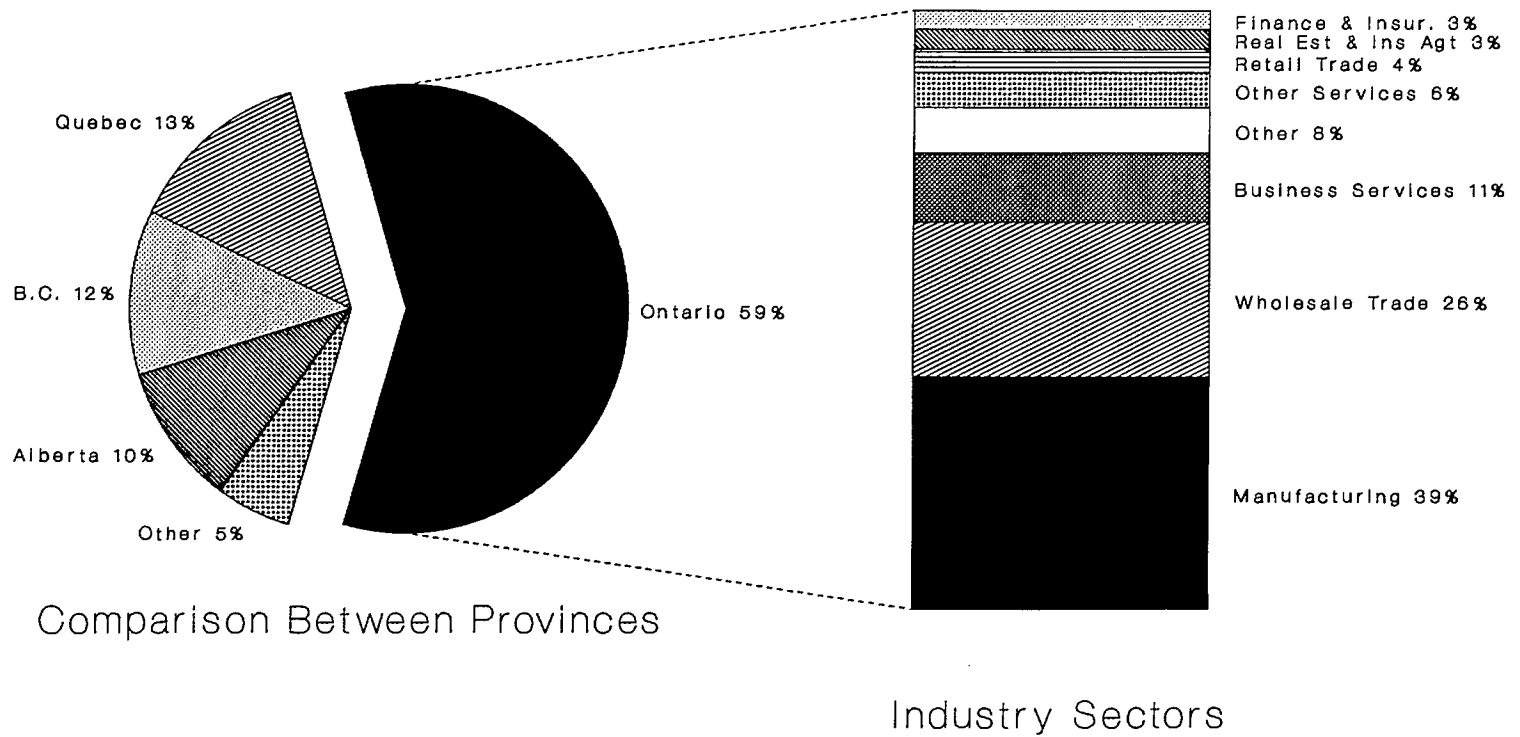
Manufacturing is the preferred sector with 52% of the total asset value and 38% of the total frequency of investment transactions. Petroleum and natural gas (9%), mining (7%), and finance and insurance (7%) attract significant portions of the asset value of investment. However, these sectors draw very low frequencies of transactions. After manufacturing, wholesale trade (26%) and business services (11%) are the most frequent targets of investors. Both these sectors are also popular choices for new businesses.

# WORLD - ONTARIO 1985-1990 OVERVIEW TOTAL ASSETS



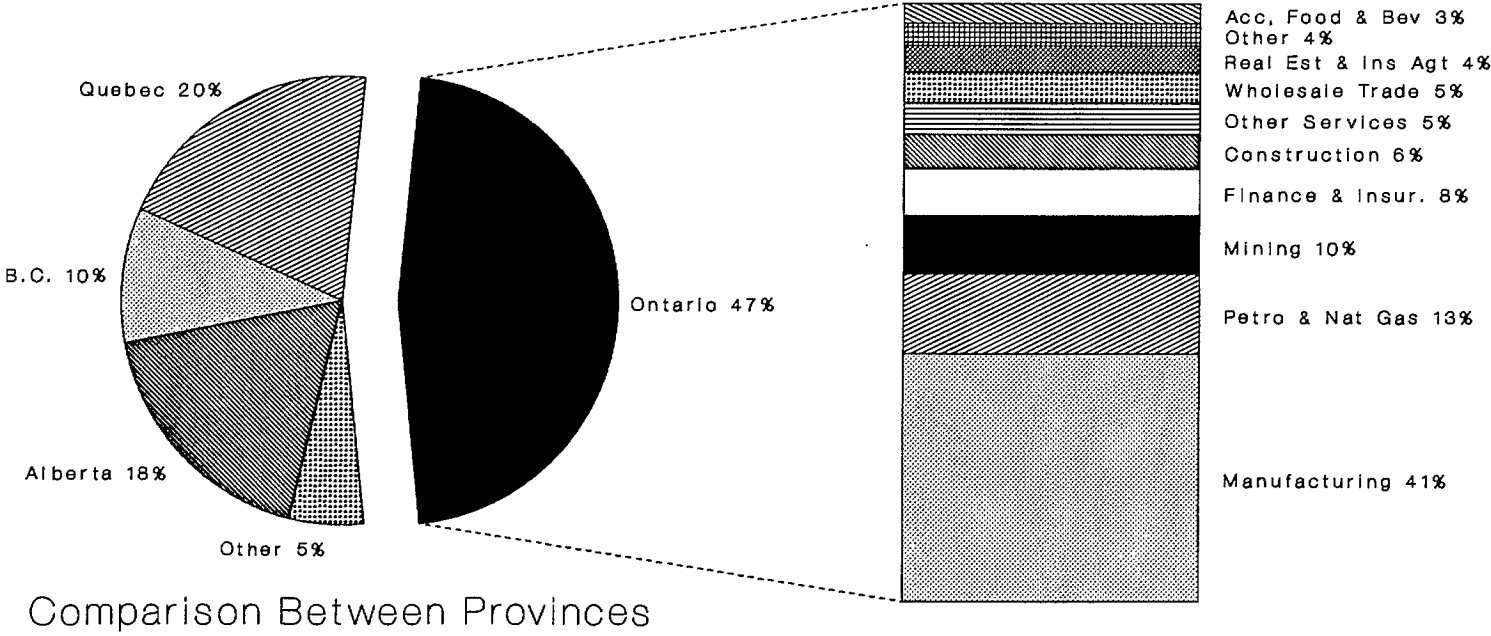

# **WORLD - PRAIRIE PROVINCES - AN OVERVIEW**

## **OVERVIEW**

20% of the asset value and 13% of the frequency of foreign investment to Canada is made in the Prairie provinces. The divergence in asset values and frequencies is due to the popularity of mining, and petroleum and natural gas industries, which are characterized by high asset values and low frequencies of investment.

## **COMPARISON BETWEEN PROVINCES**

Alberta is by far the preferred destination with 87% of the total asset value and 80% of the frequency of investment. Manitoba, much less reliant on capital intensive industries, receives a small portion of the asset value (5%) and a larger portion of the frequency (13%) of foreign investment to the Prairies. Saskatchewan secures 8% of the asset value and 7% of the frequency of investment.

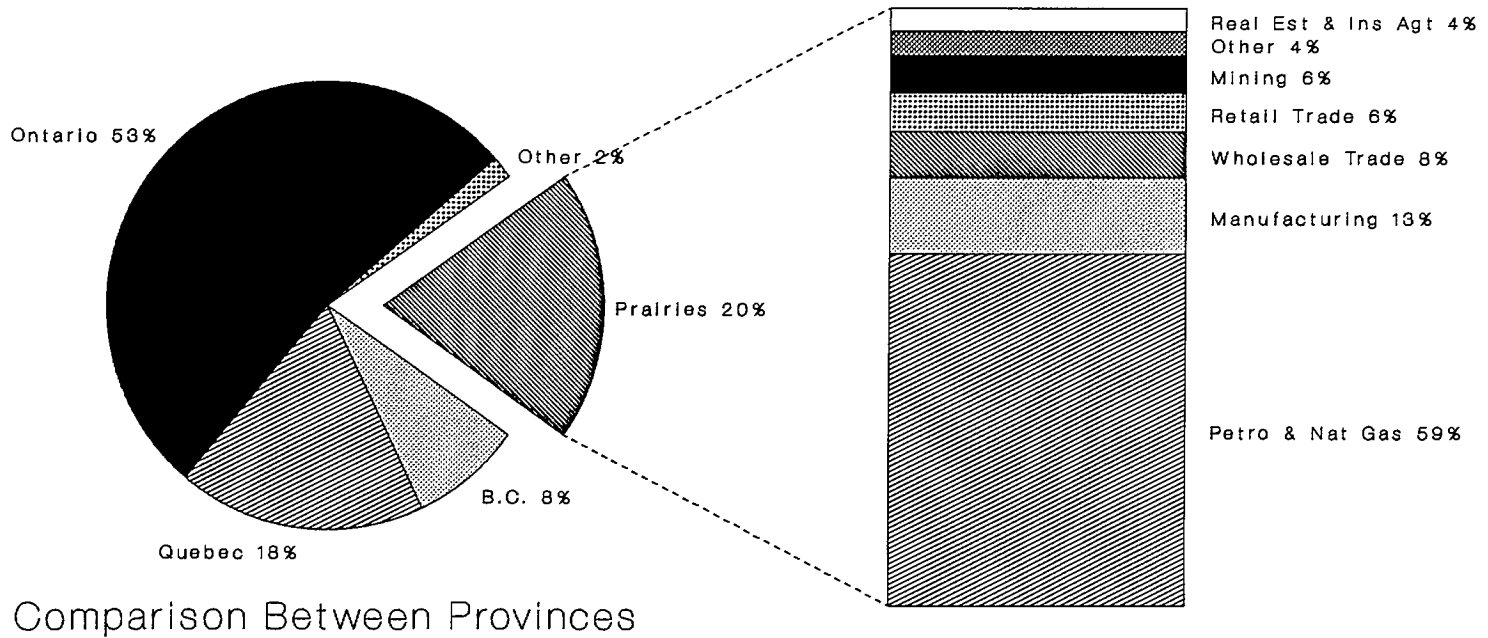
## **TYPES OF INVESTMENT**

78% of the asset value and 90% of the frequency of investment is direct. New business accounts for 6% of the asset value and 27% of the frequency of direct investment.

## **INDUSTRY SECTORS**

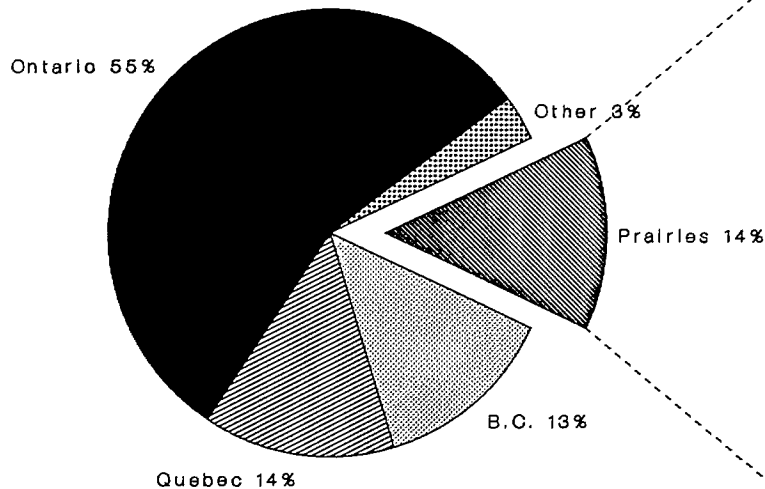
Petroleum and natural gas industries are the primary targets of foreign investment with, 60% of the asset value, and 29% of the total frequency of investment. Manufacturing (13%), wholesale trade (8%), retail trade (6%), and mining (6%) also draw significant portions of the asset value of investment. The most frequently preferred sectors, after petroleum and natural gas, are manufacturing (21%), wholesale trade (17%), and business services (9%).

# WORLD - PRAIRIES 1985-1990 OVERVIEW TOTAL ASSETS

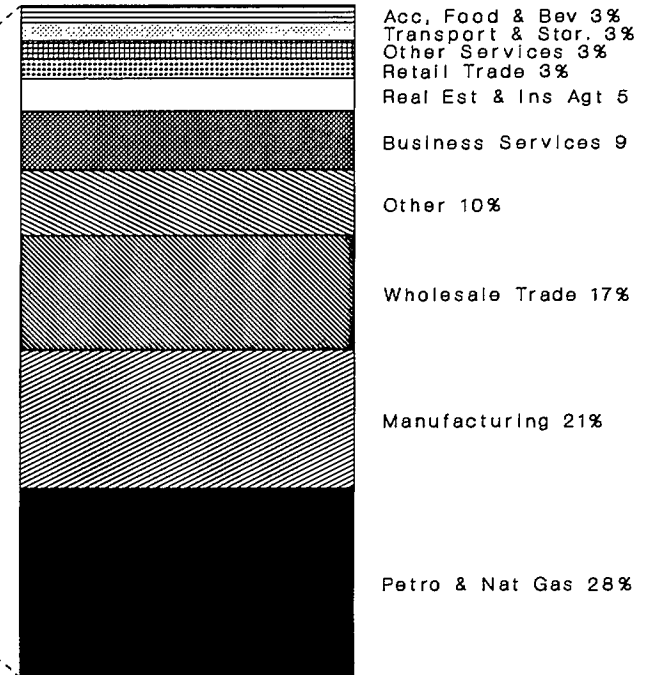

# WORLD - PRAIRIES 1985-1990 OVERVIEW TOTAL FREQUENCIES



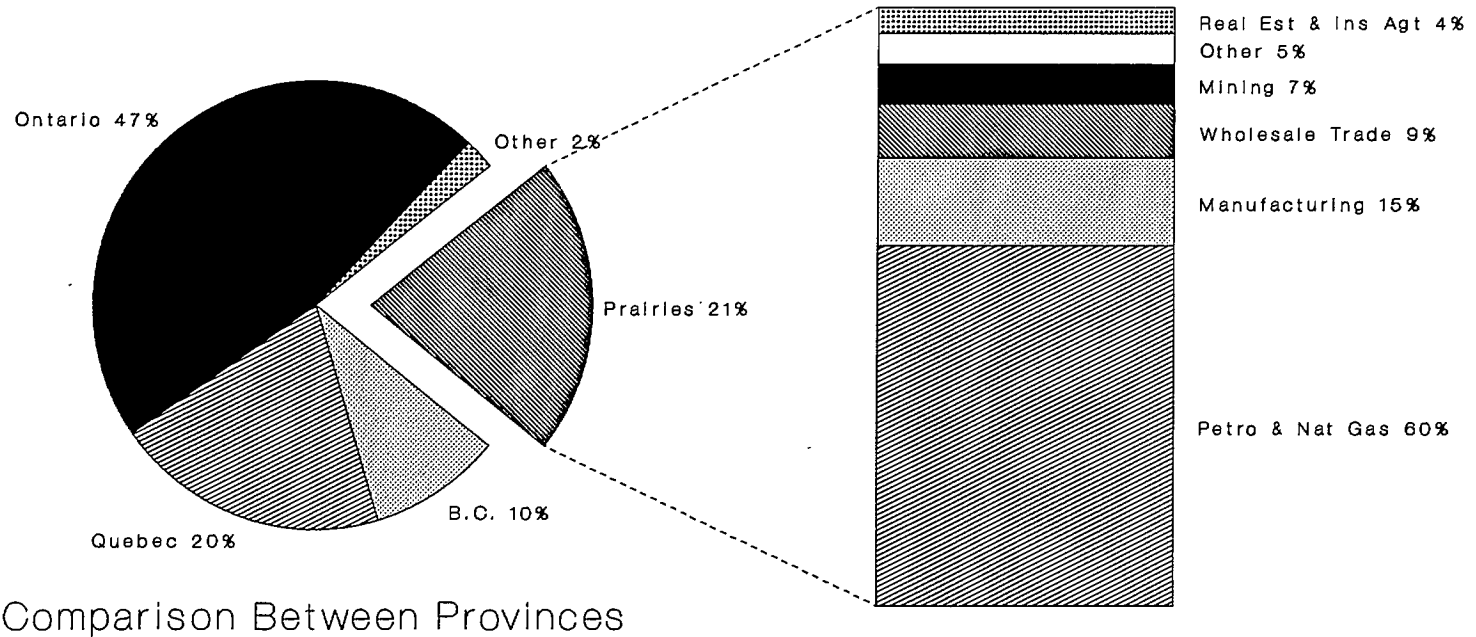
