
INTRODUCTION

This report is one of a continuing series designed to increase business awareness of the potential existing in the Canadian marketplace for domestic production and to stimulate Canadian business to explore further potential market opportunities in Canada. It is important to emphasize that this report does not attempt any assessment as to the feasibility of manufacturing or competing in a particular market and should be treated as an indicator or starting point for the manufacturer or entrepreneur.

A - IMPORT TRENDS

Fluctuating imports for industrial bottle filling machines during the period 1981 to 1984 resulted in an overall rate of growth amounting to three per cent per annum in terms of quantity and 20 per cent in terms of dollar value.

During 1984 imports totalled 106 industrial bottle filling machines (down 10 per cent from 1983), valued at \$6.2 million (up 49 per cent). Average unit prices vary greatly from year to year; in 1984 the average was \$58 425. The United States continues to lead as the chief source of these imports with at least 91 per cent of the total value and 90 per cent of the total quantity every year since 1982. There was a decrease from 1983 of United States imports in terms of quantity but in terms of value there was a significant 40 per cent increase. This increase is attributed to the economic recovery, the high rate of the U. S. dollar, and the availability of sophisticated equipment. Growth rate and per cent changes relating to countries other than the United States are erratic.

The 10 major importers accounted for 78 per cent of the total imports for 1984. Of these, nine were identified as manufacturers, and one as a wholesaler. Eight of the firms are located in Ontario and one each in Quebec and the Western Provinces.

There were approximately 52 importers of industrial bottle filling machines during 1984. The major 30 importers accounted for 94 per cent or \$5.8 million of the total imports. Twenty-one of these major importers were identified as manufacturers, their total imports representing 82 per cent or \$5.1 million of the total value. Eighty-three per cent of the value of imports were to firms in Ontario.

E - CANADIAN PRODUCTION

There are at least five Canadian manufacturers of industrial bottle filling machines. Three firms are located in Ontario and two in Quebec. Statistics Canada does not provide separate data on shipments of this product.

F - EXPORTS

Canadian manufacturers do export, but Statistics Canada does not publish separate data for exports of these machines. They are included in a category described as "Bottle Washing/Filling Machinery."

H - MARKET SUMMARY

During 1983, Canadian manufacturers shipped \$45.1 million of machinery and equipment for all kinds of packaging. Exports accounted for \$36.6 million of this. Shipments in 1985 are expected to rise to more than \$77 million (including \$69 million of exports).

Canadian manufacturing capabilities for industrial bottle filling machines are geared primarily to meet the need for in-line filling machines for the food, pharmaceutical and chemical industries in the maximum speed range of 350 bottles per minute.

The beverage breweries, distillers and soft drink industries, requiring much higher speed machines (which are not made currently in Canada) are forced to look to foreign imports of high speed rotary filling machines, available from the United States, Germany, Italy, etc.

The ever-increasing demand for complete high-speed bottling lines of machinery and equipment throughout the world presents a challenge and indeed could be a significant business opportunity for Canadian manufacturers.

Many Canadian manufacturers have the expertise, capability and technology to undertake the development of such machines and related equipment. Those who do not have all the necessary resources but who do have the capability to take on additional product lines are advised to seek a joint venture or licensing agreement with a major foreigh company to build their machines in Canada for the total North American market. Canadian manufacturers interested in manufacturing these types of machines might also consider bottle capping and labelling machines.
