SECTION I

SCOPE OF ANALYSIS

This report is based on a detailed examination of National Revenue customs invoices covering imports of silverskin onions in drums of preservative brine (vinegar) during the period January to December 1984. Only those shipments originating from The Netherlands and Israel were processed.

The following Canadian International Trade Classification (C.I.T.C.) Commodity Codes were examined:

94-99(89) Vegetables, preserved, not canned, not elsewhere specified

99-25(20) Pickles

Product Description:

Silverskin onions - a small white onion with loose silvery skin; used mainly in the gourmet and pickling trade.

SECTION II

CANADIAN PRODUCTION

Although silverskin onions are presently produced in Canada, Statistics Canada does not publish separate data on production or shipments.

SECTION III

ANALYSIS OF IMPORTS

Imports of silverskin onions in drums of preservative brine (vinegar) during the period January to December 1984 amounted to 2,008 drums for a value of \$397,864.

Silverskin onions imported in drums weighing 135 kilograms (net drained weight) accounted for 79 per cent of the total value, with the remaining 21 per cent being imported in drums of 160 or 180 kilograms.

The Netherlands was the major country of origin, accounting for \$333,409 or 84 per cent of the total value. Israel accounted for the remaining \$64,455.

Of the total imported quantity of 611,750 lbs., 77 per cent or 471,200 lbs. entered Canada via ports located in the province of Quebec.

There were 8 importers of silverskin onions in drums of preservative brine (vinegar). The majority of these are manufacturers or processors of food products, the remaining are grocery wholesalers. The importers are located in Quebec and Ontario with each province having the same number.

All shipments included in this analysis are apparently, in Statistics Canada's terminology, "arms-length transactions"; i.e., shipments between non-affiliated firms.

Full details of the analysis are provided in the following tables.

NOTE: Dollar values shown are based on selling price F.O.B. plant, in Canadian dollars. This selling price represents the value paid by the importer, excluding all freight, packing and insurance costs when specified. All trade discounts when applicable are also deducted from the selling price.
