#### IMPORT ANALYSIS

### FRACTIONAL AC MOTORS 1/30 HP AND UNDER

#### I. INTRODUCTION AND SCOPE

This Import Analysis is one of a series prepared in order to assist businesses and other organizations in their market research of specific products. The detailed import information provided in these reports supports studies by organizations seeking to expand existing production lines, change individual product characteristics or engage in new manufacturing investment in Canada. The coverage of an import analysis is developed in close consultation with the client, and is tailored to meet those specific requirements. It is important to emphasize that this report does not attempt any assessment as to the feasibility of competing in a particular market.

This analysis of imports of fractional AC Motors 1/30 HP and under is based on a detailed examination of Revenue Canada Customs import documents for the month of June 1986. Products assigned to Canadian International Trade Classification (C.I.T.C.) import commodity code 503-66-20 Motors, Electric AC 1/3 HP and under were analysed.

The fractional motors included in this analysis are typically used in fans, appliances, timers, etc.

#### II. ANALYSIS OF IMPORTS

Imports of fractional AC motors 1/30 HP and under, as reported on documents for the month of June 1986, amounted to \$1.2 million.

Seventy thousand motors (38 per cent) had a unit price of under \$5.00, and another hundred thousand (55 per cent) were in the \$5.20 to \$10.00 range. These two groups accounted for 83 per cent of the total value. In the main unit price range, those in the range of 5.91 to 6.00 dollars were the most significant with a quantity of 39 000 units valued at \$233 132. Appendix A provides further details on motors by unit price range.

Due to the lack of information on the documents analysed, imports worth  $$773\,000$  (or 67 per cent of the total value analysed) were identified only as  $1/30\,\text{HP}$  and under, but could not be broken down further as to size. The  $1/65\,\text{and}\,1/60\,\text{HP}$  motors were the most prominent identified sizes, with 36 482 units valued at  $$204\,426$ .


As shown on the next page and further detailed in Appendix B, the majority of motors of individual power units also tended to be in the 1 to 10 dollars price range.


#### COUNTRY OF ORIGIN

The United States was the dominant source of imports of fractional AC motors 1/30 HP and under, during the month of June, 1986, accounting for 92 per cent of the total import value. Other countries exporting to Canada include the following in order of value: Federal Republic of Germany, the United Kingdom, Singapore and Japan. A detailed list of major foreign exporters to Canada, in descending order of value, is shown in Appendix D.

Ontario was the major province of consignee, accounting for 95 per cent of the total import value. Québec accounted for 4 per cent. Imports to consignees in other provinces, (Manitoba, Saskatchewan and British Columbia) totalled 1 per cent.

There were at least 44 known consignees of fractional AC motors 1/30 HP and under during the month of June 1986. Five had imports of at least \$100 000 each during that period. The top 12 consignees accounted for more than \$1 million or 88 per cent of the total import value. All of these 12 consignees were located in Ontario. Appendix C lists all consignees.

#### III. CANADIAN PRODUCTION

According to industry sources, fractional AC motors 1/30 and under as described in this report are made in Canada. However, for reasons of confidentiality, data on production or shipments by Canadian manufacturers are not available.
