IMPORT ANALYSIS

JAMS AND MARMALADES

I. INTRODUCTION AND SCOPE

This Import Analysis is one of a series prepared in order to assist businesses and other organizations in their market research of specific products. The detailed import information provided in these reports supports studies by organizations seeking to expand existing production lines, change individual product characteristics or engage in new manufacturing investment in Canada. The coverage of an import analysis is developed in close consultation with the client, and is tailored to meet those specific requirements. It is important to emphasize that this report does not attempt any assessment as to the feasibility of competing in a particular market.

This analysis of imports of jams and marmalades is based on a detailed examination of Revenue Canada Customs import documents for the period July to December 1987. Imports classified to the following Ganadian International Trade Classification (C.I.T.C.) import commodity codes were analysed:

078-92-20 Jams, Canned, Except Infant Foods 078-94-10 Marmalades, Canned, Except Infant Foods

Not studied were commodity codes described as jellies or canned fruit preserves(1). In addition, bulk shipments are contained in other import commodity codes.

II. SAMPLING TECHNIQUE

Due to the large volume of shipments classified to import commodity codes 078-92-20 and 078-94-10, it was necessary to use a sample of import invoices. Invoices are listed by lines, and the lines were selected according to the following rules:



In each stratum, invoices were drawn at random according to the sampling ratio. All results in this report are based on multiplying the information in each invoice by the inverse sampling ratio (1, 2, 3, 9 respectively).

For the accuracy of the results obtained because of the sampling technique utilized in this report, refer to Appendix H.

(1) A noted exception is the United Kingdom which in some instances treated as preserves what others would consider to be jams. While not included in the main body of this analysis, the Market Information and Analysis Division examined preserves originating from the United Kingdom. The results are presented as an addendum to this report. (See page 40).






Between 1983 and 1987 the value of <u>jam</u> imports increased from \$3.3 million in 1983 to \$9.1 million in 1987, an average annual growth rate of 29 per cent. The value of <u>marmalade</u> imports increased from \$1.6 million in 1983 to \$2.2 million in 1987 (an average annual growth rate of 8.5 per cent), despite a decrease of 11 per cent from 1985 to 1986.

IV. ANALYSIS OF IMPORTS - JULY TO DECEMBER 1987

Imports as shown in this report during the period July to December 1987 were valued at \$4.5 million, with jams accounting for \$3.7 million and marmalades \$820 000.

Of the total jam imports of \$3.7 million, strawberry jams accounted for \$1.1 million or 30 per cent. Raspberry jams ranked second with a value of \$767 000 or 21 per cent. Other principal flavours, in descending order of value, were apricot, cherry and black currant accounting for \$853 000 of the total value of imports. Gift packs accounted for only 3 per cent of the total. (For further details refer to Appendix A.)

Of the total <u>marmalade</u> imports (\$820 000), orange flavoured marmalades were valued at \$202 000 or 25 per cent of total marmalade imports. The remaining identified portion of marmalades consisted of ginger, golden shred and lime flavours. Ginger was the single major item accounting for \$177 000 or 22 per cent. Forty-four per cent of total marmalade imports were not identified as to flavour. (For further details refer to Appendix A.)

<u>Jams</u> imported into Canada in 375 milliliter jar sizes accounted for \$699 000 or 19 per cent of the total value. The next most popular jar sizes were 750 milliliter and 250 milliliter. These were valued at \$544 000 (15 per cent) and \$440 000 (12 per cent) respectively. The dominant jar size for <u>marmalade</u> imports was 250 milliliters; jars of this size were valued at \$427 000 and accounted for 52 per cent of the total value of marmalade imports.

The price of a jar of jam ranged from under $10 \not\epsilon$ to over \$2.80. (See Appendix C.) There was little relation between the size of jar and its price. For example, the overall average prices for the popular 250,375, and 750 ml sizes were $79 \not\epsilon$, $57 \not\epsilon$, and $77 \not\epsilon$ respectively. However, in all three sizes there was a very wide variety of prices. The price ranges per jar were as follows:

Half the 250 ml jars of jams cost under 70¢, half over. For both the 250 and 375 ml sizes, one quarter cost less than 40¢. With respect to major flavours, no real differences occured in price ranges according to flavour. For <u>marmalades</u>, unit prices for 250 milliliter jars ranged from a low of 69¢ to a high of \$1.47 and averaged 81¢ per jar.

About 75 per cent of total jams and marmalades were imported at a 10 per cent tariff rate and the other 25 per cent, primarily from Yugoslavia, at 15 per cent. (See Appendix G.)


With respect to the country of origin, average prices for <u>jams</u> ranged from a low of 95¢ per 1000 milliliters from Yugoslavia (the major country of origin) to \$6.82. For <u>marmalades</u>, the average price from the dominant country, United Kingdom, was \$3.70.

Yugoslavia was the major country of origin for imports of jams accounting for \$907 000 or 25 per cent of the total value, primarily of strawberry and raspberry flavours. The United Kingdom was the next largest country of origin (\$664 000 or 18 per cent) with strawberry and black currant flavours predominating. Denmark followed closely at \$558 000 or 15 per cent, primarily raspberry. The United Kingdom was the dominant country of origin for <u>marmalades</u>. Shipments from that country were valued at \$661 000 or 81 per cent of the total. (For further details refer to Appendix B.)

COUNTRY OF ORIGIN - JAMS





Ontario was the major province of consignee for the imports of <u>jams</u>, with \$1.8 million or 50 per cent of the total dollar value. British Columbia followed with \$1.1 million or 30 per cent.



OTHER PROVINCES WERE BRITISH COLUMBIA AND NOVA SCOTIA

Ontario was also the major province of consignee for the imports of <u>marmalades</u>. It accounted for \$476 000 or 58 per cent of the value of imports.

There were 69 known consignees/importers of jams and marmalades during the period July to December 1987. The principal 25 consignees/importers accounted for \$3.8 million or 85 per cent of the total dollar value of imports. All consignees/importers are listed in alphabetical order in Appendix D.

V. CANADIAN PRODUCTION

Statistics Canada reports that in 1985, Canadian shipments of jams and marmalades were valued at \$62.7 million and \$10.9 million respectively. These are the latest figures available.

VI. MARKET SUMMARY

The Canadian jam industry accounted for 2 per cent (1983) of the fruit and vegetable sector and over the 5 year period, 1979-1983 significant declines in sales were indicated. Declining domestic sales are attributable to imports as well as declining per capita consumption of sugar-containing products. This trend has been reinforced by consumer demand for nutritious, non fattening foods.

The gourmet sector, however, appears to be a potential growth area and one that is not affected by consumers' concerns for sugar-reduced products. In fact, demographic trends (aging population, increased disposable income) lend themselves to future growth in the demand for high quality products that can provide textures and tastes different from traditional jams and marmalades. These traditional products have been the mainstay of the industry and have primarily been marketed through chain grocery stores or packaged into single serving portions for the food service industry.

Gourmet jams are usually distinct from traditional products as the contents contain more fruit, provide different variations of traditional fruit and may be honey-based. Some marmalade products are made with unrefined sugar, which would appeal to health-conscious individuals, while other marmalades may include different sizes of peel cuts for different textured effects, along with addition of ginger, other fruits or alcohol. They are normally retailed at a premium price and marketed through specialty food shops.

There are no available figures on the production of gourmet jams and marmalades in Canada. However, it is known that there is a small cottage industry and some medium size processors that are servicing regional markets. Consistency and quality of product remain the key factors to competing in the gourmet sector.
