# Introduction

In 1986, the Department of Communications set up the Sound Recording Development Program (SRDP). Well known to various segments of the music industry, the SRDP provides direct assistance to the production and marketing of Canadian musical products. It is nevertheless only one of many tools created by the Government of Canada to offer Canadian firms the best possible conditions for development.

There are many other programs available through federal departments and agencies with international, economic or social mandates that would encourage the growth of the Canadian sound recording industry. To make these programs better known, the Department of Communications has prepared this brochure. It provides an overview of the programs, their objectives, the kinds of assistance available, and other related details. We hope that this information will enable members of the sound recording industry to find the type of support best suited to them.

### Nature of assistance

- development of innovative communications technologies and their use in the activities of professional cultural organizations
- construction or renovation of buildings for cultural use or purchase of equipment for projects directly related to the objectives of the organization
- festivals and special cultural events of national scope
- projects that strengthen the management of professional cultural organizations

# a) Touring Grants

The mandate of the Touring Office is to promote among the widest possible number of Canadians the distribution and enjoyment of performing arts works through grants and services to performing artists and arts organizations, and Canadian presenters and distributors engaged in touring performing arts productions in Canada.

# b) Concerts Canada

The Concerts Canada program is designed to assist artists' management and to encourage artists' managers to develop careers of Canadian artists in the field of classical music.

# **External Affairs and International Trade Canada**

## 1) Arts Promotion Program

The Arts Promotion Program is an important element of the International Cultural Relations Program which aims to extend and complement national political, economic and cultural objectives.

The program provides financial assistance to eligible artists, authors, companies and groups that propose international tours, exhibits, visits or exchanges consonant with departmental priorities.

#### Nature of assistance

## a) Sound recording

Financial assistance is available to companies, artists and groups representing the Canadian sound recording industry. The application for assistance must include a precise description of the project and a detailed budget including potential sources of funding.

Financial assistance is available in support of the following activities:

- promotion and marketing activities related to Canadian industry participation at major international trade fairs (i.e. MIDEM and the New Music Seminar in New York)
- attendance of potential foreign buyers at Canadian trade symposiums directly related to the search for foreign markets for Canadian sound recording products
- foreign touring of Canadian artists where foreign launch of their recordings is being promoted

# b) Music field

Financial assistance is available to Canadian companies, groups and artists in the music field wishing to tour abroad. To be eligible, professional artists, companies or groups must have some national or international touring experience, have acquired the administrative skills needed for the successful implementation of a major undertaking and be nationally recognized for their artistic excellence. Priority is given to those touring projects that:

- respond to a demonstrated interest abroad, for example, an offer by a well-established local sponsor who can guarantee adequate revenues based on fair commercial arrangements
- last a minimum of two weeks and help to develop a specific market
- present Canadian works of the highest quality
- are organized by a Canadian agent or professional tour co-ordinator

The program may exceptionally grant financial assistance in support of those projects that:

- are aimed at market exploration by impresarios or agents
- do not involve a tour as such but allow Canadian artists to participate in artistic events of an international nature
- involve invitations to well-known foreign individuals to attend major artistic events of an international nature

# 2) Program for Export Market Development (PEMD)

The program supports a variety of activities to help current or potential Canadian private-sector exporters increase their marketing activities in foreign markets and develop their sales of Canadian goods and services. The program accomplishes this by sharing the costs of export marketing activities with Canadian businesses, thus reducing the risks involved in penetrating a foreign market.

#### Nature of assistance

PEMD offers financial assistance to two main categories of activities.

## a) Industry-initiated

- participation in recognized trade fairs outside Canada
- visits outside Canada to identify markets
- visits by foreign buyers and sales agents to Canada
- project bidding or proposal preparation at the precontractual stage
- establishment of permanent sales offices abroad
- innovative marketing initiatives

## b) Government-initiated

- trade missions fairs abroad
- visits by foreign business persons to Canada

# 3) Export Development Corporation (EDC)

The EDC provides a wide range of financing, insurance and guarantee services to Canadian exporters.

#### Nature of assistance

The EDC assures short- and medium-term export financing for goods and services (including the rights to patents, trademarks and copyrights).

The EDC provides support programs intended to protect overseas investments and to protect against overdue payments of foreign buyers.

- performance bonds
- foreign investment insurance

## 4) New Exporters to Border States (NEBS)

The NEBS program is a crash course in the essentials of exporting to the United States. Its objective is to encourage small and medium-size Canadian companies that are not currently exporters to consider the markets just across the border.

#### Nature of assistance

Each NEBS mission can last from one to two days and includes the following components:

- travel to the U.S. border and/or to the nearest Canadian consulate or another city in the territory of the consulate
- briefing by U.S. Customs officers
- talk by U.S. manufacturers' representative, sales agent or buyer
- briefing on the local market by consulate trade officers
- one-on-one interviews with potential agents or distributors

Transportation and program-related costs are covered by External Affairs and International Trade Canada and the provinces. Participants pay only hotel accommodation and personal expenses.

# 5) New Exporters to U.S. South (NEXUS)

This program is aimed at companies that have traded traditionally just over the U.S. border and its purpose is to lead them into expanding their activities in the southern states

#### Nature of assistance

The mission will concentrate on developing a program to gain distribution and sales exposure for the companies. It can be built around a particular event such as regional or trade fairs. It can also consider a seminar or workshop format complete with invited speakers to elaborate on the market opportunities available or to describe emerging trends and market characteristics.

Each NEXUS mission can last three to four days and usually includes a group of 10 to 20 companies from the same sector. As with the NEBS program, participants are responsible for accommodation and personal expenses.

## 6) Canadian Trade Commissioner Service

There are over 800 trade commissioners in 112 cities abroad and 11 cities in Canada. The primary responsibility of the Trade Commission is to help Canadian companies start or expand export sales in international markets.

## Nature of assistance

Trade commissioners abroad can help you:

- identify market opportunities for your products or services
- promote your company to local customers
- recommend appropriate technical experts to help negotiate deals
- intercede to help solve your problems with duties, taxes or foreign exchange
- advise and assist you with foreign joint ventures and licensing
- organize travel abroad by giving you practical advice

# 8) Technology Inflow Program (TIP)

TIP promotes the acquisition of the foreign technological innovation needed to develop new or improved Canadian products, processes or services.

### Nature of assistance

## a) TIP services abroad

Specially assigned staff in several of Canada's diplomatic posts abroad will:

- respond to specific requests from Canadians to identify foreign technology sources and investigate opportunities for collaboration
- arrange for the prospective partners to be brought together to discuss the technical, commercial and legal aspects of specific technology transfers
- provide other support as appropriate to the Canadian recipients

## b) TIP Fund

The TIP Fund may provide financial support for some activities (expenses are normally shared between TIP and the participating organizations) such as:

 exploratory visits to acquire in-depth knowledge of foreign innovations and/or initiate and implement the transfer of technology to Canada

- working visits to foreign organizations by Canadian scientists and engineers to obtain hands-on experience in the development and application of a technology required in Canada
- working visits to Canada by foreign experts where the Canadian organization will obtain significant benefit from the visitors' expertise
- awareness missions to explore new technologies of interest to Canada


## Small Business Loans Act (SBLA)

The purpose of the SBLA is to assist new and existing small business enterprises to obtain intermediate term loans to help finance specified fixed asset needs. The loans are made directly by chartered banks and other approved lenders with the SBLA providing for loss-sharing arrangements between the lenders and the federal government.

#### Nature of assistance

Loans of up to \$100,000 are available for the purpose of financing:

- the purchase of land necessary for the operation of a business enterprise
- the construction, purchase, renovation, improvement, modernization and extension of premises
- the purchase, installation, renovation, improvement or modernization of fixed or movable equipment





# **Employment and Immigration Canada**

## Job Development Program (JDP)

The Job Development Program aims to develop the labour market potential of long-term unemployed Canadians through a combination of work experience and skills training.

## Nature of assistance

## a) General projects

Subsidizes employers operating projects that provide a minimum of three long-term unemployed individuals or those receiving social assistance with a training and work experience program related to specific jobs.

## b) Individually subsidized jobs

Subsidizes employers who hire unemployed individuals or those receiving social assistance, including the employment disadvantaged (an employment disadvantaged person is one who has a social or cultural barrier to employment), to fill newly created positions or to fill current job vacancies with the intention of providing such individuals with a combination of training and work experience for a specific job.

# c) Training

Subsidizes the purchase of training places from public or private institutions.

# Indian and Northern Affairs Canada

## **Cultural Grants Program**

Grants are made to Inuit individuals and organizations in order to develop and promote Inuit culture within modern Canadian society. The program encourages applicants to seek additional financing for their projects from other appropriate sources.

## Nature of assistance

The amount of any single grant may not exceed \$5,000. These grants are made available on a "one time" basis and are not intended to provide direct on-going support to projects or activities of a regular nature.

# Western Economic Diversification Canada

Western Economic Diversification Canada is intended to assist projects undertaken by either individuals or organizations in any sector that will contribute to the diversification of the economy of western Canada. For example, projects eligible for assistance can include: new product, new market, and new technology development; productivity improvement; or importation; from either the manufacturing or services sectors.

### Nature of assistance

Assistance comes in the form of grants, loans and loan guarantees. The program provides financial assistance for research and development, import replacement, and for launching, modernizing or expanding a business. The following projects are also eligible:

- purchase of land
- labour
- marketing
- feasibility studies
