1.0 INTRODUCTION AND METHODOLOGY

This report presents the findings of a national survey of firearm ownership in Canada, conducted by the Angus Reid Group on behalf of the federal Department of Justice. The results of this study provide baseline information to the Department on the incidence of firearm ownership in Canada.

This national survey was conducted between February 4th and 19th, 1991 between the hours of 5:00 and 10:00 p.m. A total of 10,103 households were contacted in this survey. In each household, an adult member was questioned on whether or not their household owns any type of firearm. If a firearm was owned by the respondent or any other member of the household, the Angus Reid Group interviewer then administered the remainder of the questionnaire.

The questionnaire for this survey was developed in close consultation with representatives from the Department of Justice. The final draft questionnaire was subject to pretesting and revision in order to ensure that the question wording was clear and accurate, and that the interviews flowed smoothly. A copy of the final questionnaire employed in this study is appended to this report.

Telephone numbers for the sample were randomly generated using the Angus Reid Group's in-house computerized sample selection procedure. This program generates telephone numbers randomly by Census Division, such that the sample is selected proportionate to population distributions consistent with Census data.

All data reported in the research findings have been weighted to reflect the actual proportions of households in Canada by province and territory. The results, therefore, are taken to be representative of the Canadian population as a whole, both nationally and regionally.

In the survey, a total of 2341 households were interviewed where there was at least one firearm owned by the household. With respect to the profile of firearms owned and other measures in this survey, estimates of proportions based on a random sample of this size are accurate to within ± 2.0 percentage points at the 95 percent confidence level.

The portrait of firearm owners is based upon the 1271 respondents in this survey who personally owned a firearm. The survey results concerning firearm owners are taken to be accurate to within \pm 2.75 percentage points at the 95 percent confidence level.

The prevalence of firearm ownership is estimated to be 23 percent of Canadian households. Moreover, since this estimate of firearm ownership prevalence is based upon 10,103 households, this estimate is expected to be accurate to within ± 1 percentage point at the 95 percent confidence level.

2.0 FIREARM OWNERSHIP IN CANADA

Firearms are present in approximately one out of every four households in Canada. The survey results indicate that of the roughly 9.6 million households (1990 figures) in this country, around 2.2 million own at least one type of firearm - therefore, it is estimated that nearly one-quarter (23%) of all Canadian households own a firearm. (TABLE 1)

The prevalence of households with firearms varies widely across the country. The estimated prevalence of firearms households is by far the highest in Yukon and the North West Territories (67%), followed distantly by Alberta (39%) in second place. In sharp comparison, it is estimated that the proportion of households owning at least one firearm is lowest in Ontario (15%).

The approximately 2.2 million Canadian households with a firearm own an estimated total of 5.9 million firearms. Therefore, the average number of firearms estimated to be owned by each of these households is 2.67.

Once again, there are significant regional differences in the average number of firearms per household. Consistent with the high prevalence of firearms households in Yukon/NWT, the mean estimated number of firearms owned by each household is also the highest in this part of the country (3.44). Firearms households in Manitoba/Saskatchewan also appear to own

a greater number of firearms on average (3.04) compared to similar households elsewhere in Canada, particularly in Quebec (an estimated average of 2.40 firearms per household) and Atlantic Canada (2.44).

In terms of the proportional distribution of the number of firearms owned by Canadian households with firearms (as opposed to an average figure), a majority - an estimated 60 percent - have one or two firearms. Based on the sample of respondents, one-third (35%)

of these households own only one firearm while one-quarter (25%) have two firearms within the household. Significantly, nearly one in five (17%) households own five or more firearms. (TABLE 2)





Among the three main firearm ownership segments - households which own a rifle, those which have a shotgun, and those which possess a handgun - the survey results show that multiple firearm ownership is most common among households which own a handgun. While an estimated 17 percent (or approximately 1 in 5) of all firearm-owning households in Canada own five or more firearms, this is characteristic of almost one-half (46%) of households which own a handgun. In contrast, it is estimated that only around two in ten of those households which own a rifle (22%) and those possessing a shotgun (21%) have at least five firearms. (Note: The "type of firearm-owning household" owned categories are not mutually exclusive; that is, households in the "Rifle" segment, for example, own a rifle but they may also own other types of firearms.)

Canadians participating in this survey were asked whether they themselves own or hold any guns in their possession. A majority (54%) of all survey respondents replied affirmatively. Regionally, personal ownership of a gun was highest among those polled in the Yukon/NWT (65%) and in Manitoba-Saskatchewan (63%) and lowest among respondents living in Quebec (49%). With respect to other demographic descriptors, personal gun ownership was highest among males (82% versus only 18% of women), the middle-aged (60%), those interviewed from households where total annual income is in excess of \$60,000 (66%) and individuals who have less than a complete high school education (59%). 3.0 OWNERSHIP OF FIREARMS BY TYPE

3.1 Types of Firearms Owned

Rifles and shotguns greatly outnumber other types of firearms owned by Canadians. It is estimated that fully seven in ten (71%) households which own at least one firearm, or approximately 1.5 million Canadian households, have a rifle within their possession. Not far behind are shotguns - an estimated two-thirds (64%) of households with firearms own this type of firearm, or roughly 1.4 million households. Considerably less common are handguns (owned by an estimated 12% of firearm-owing households). Other types of firearms are owned by 5 percent of Canadian households with firearms (of this figure, the voluntary response of "air gun" accounts for 4%). (TABLE 4)

Firearm ownership by type exhibits some marked variations along regional lines. With regard to rifles, the survey results indicate that this type of firearm is owned by nearly all firearm households in Yukon/NWT (95%) and a large majority of those from other regions except Quebec, where this figure drops to 55 percent. On the other hand, Quebec households with firearms are the most likely to own a shotgun (77%); shotgun ownership is least pronounced in the two western-most provinces - British Columbia (51%) and Alberta (58%). According to the research data, handguns are most readily found among firearmowning households in British Columbia (16%) and Ontario (15%).

Additional cross-tabulation analysis of the types of firearms owned reveals that, of the three most prevalent types of firearms, households in which there is a handgun are more likely than those which own a rifle and those which possess a shotgun, to also own another type of firearm. More specifically, among Canadian households which own a handgun, the survey results suggest that approximately three in four (73%) also possess a rifle and around two-thirds (63%) also own a shotgun. Among shotgun-owning households, meanwhile, two-thirds (65%) also own a rifle but only one in ten have a handgun. Rifle-owning households are even less likely to have other types of firearms - six in ten (59%) also own a shotgun and one in ten a handgun. (TABLE 5)

Ownership of other types of firearms is also fairly common among the smaller sectors of firearm households. Among households which own an air gun (term volunteered by respondents), half also have in their possession a rifle, four in ten (43%) own a shotgun and one in ten possess a handgun. (These results are included in the "Other" firearms owned category.)

3.2 Incidence of Semi-Automatic Firearms

Of the three most popular types of firearms owned by Canadian households, those most likely to be semi-automatic are handguns, followed by rifles and shotguns. The results of this survey show that slightly more than one-third (36%) of households which own a handgun have at least one which is semi-automatic. This compares to one-quarter (24%) of rifle-owning households which have at least one semi-automatic rifle and to even fewer (17%) households with shotguns. (TABLE 6)

Household ownership of semi-automatic handguns varies across different population descriptors. Regionally, the proportion of handgun households with at least one semi-automatic handgun is in the 30 to 40 percent range in all parts of Canada except Yukon/NWT, where it climbs to the 50 percent mark. Handgun-owning households which have used any of their firearms on at least one occasion over the past year are almost twice as likely as those which have not, to own a semi-automatic handgun (42% versus 23%). (TABLES 6 & 7) (See Section 5.0 for an explanation of how a household's main reason for owning a selected type of firearm was determined in the survey.)

Household ownership of semi-automatic rifles is also variable across population subgroupings. Across geographic lines, the proportion of rifle-owning households with at least one rifle of the semi-automatic variety is roughly one out of every four in most regions but rises to one-third in both Manitoba/Saskatchewan and Yukon/NWT. Similar to that observed for handgun-owning households, the incidence of semi-automatic rifle ownership is higher among rifle owning households which have used a firearm in the past 12 months than among those which have not (28% compared to 19%).

Differences tend to be less pronounced across population segments concerning the incidence of semi-automatic shotgun ownership. Based on the results emerging from the surveyed sample of Canadians, the proportion of households with shotguns which own at least one semi-automatic firearm of this type ranges from only one in ten in Manitoba/Saskatchewan to double this number in Ontario (21%) and Quebec (20%). Whether or not these households have used a firearm during the past year appears to have no marked association with the incidence of semi-automatic shotguns.

4.0 PROFILE OF FIREARM OWNERS

4.1 Demographic Profile

This section of the report presents a socio-demographic profile of firearm owners in Canada. As respondents to this survey were not necessarily required to personally own a firearm (that is, they were allowed to answer questions on behalf of their entire household), the following profile is based solely on survey participants who indicated that they themselves are the owner of a firearm, thus painting a portrait of firearm owners in this country. These estimates are then compared to the Canadian population at large based on estimates obtained from the Census and from recent National Angus Reid Polls.

O Sex - The survey results show that firearm owners in Canada are predominantly male (86%) as opposed to the gender split that exists among the Canadian population as a whole. (TABLE 8)

- Age Firearm owners are more likely to be middle-aged compared to Canadians as a whole. Based on this survey, a large plurality (46%) of Canadians who personally own a firearm are between 35 and 54 years of age, whereas this age group comprises about one-third of the national population. The younger (18 to 34) and older (55+) age groupings represent a larger portion of the Canadian population overall compared to firearm owners.
- Definition of firearms tend to have less formal education than the population overall. This research indicated that, whereas a majority (55%) of firearm owners have not received formal schooling beyond the high school level, more than half (53%) of Canadians have at least some post-secondary education.
- o Income There are no significant socio-economic differences between firearm owners and the population of the country in general, except perhaps for somewhat of an under-representation of firearm owners in the lowest income category (less than \$20,000), as suggested by this survey.
- o Employment Status Full-time employment is more characteristic of Canadians who personally own a firearm than members of the overall population. While fully two-thirds (66%) of firearm owners in the survey said they are working at full-time jobs,

this applies to just under half (47%) of Canadians as a whole, who are twice as likely to be employed on a part-time basis (12%).

Occupation - Consistent with their lower levels of education compared to Canadians overall, firearm owners are not as likely to be employed in white collar occupations. Based on the sample of surveyed respondents, roughly one-third (31%) of employed Canadians who personally own a firearm work in an owner or professional capacity, as opposed to one-half of Canadians as a whole - this gap is particularly evident with regard to professional occupations (18% of firearm owners versus 34% of Canadians overall). Meanwhile, polled firearm owners were considerably more likely to be blue collar workers (33% versus 14% of the general population) and, to a lesser extent, involved in farming (8% compared to 3%).

4.2 Incidence of Firearm Safety Instruction

The results emerging from this survey show that among all Canadian households which own a firearm, one-half (49%) have a member who has received instruction in the care and safe handling of firearms within the past five years. Across regional lines, the incidence of firearm safety instruction ranges from a low of 43 percent in British Columbia, to a narrow majority (53%) of Ontario households which own a firearm, up to 60 percent in

Yukon/NWT, the part of the country which has the highest prevalence of firearm ownership as well as the highest estimated average number of firearms per household. (TABLE 9)

There are also wide variations in firearm safety instruction with respect to other population descriptors. The incidence of having received training in the care and safe handling of firearms is significantly greater among households which own a handgun (67%) than among those which possess a rifle or a shotgun (levels comparable to the national picture).

With respect to households' main reason for owning a firearm, the incidence rate is only 38 percent among those households whose primary reason is collecting but rises to the majority mark or higher among all other household types, notably those whose predominant reason is employment (75%). While most (60%) firearm-owning households which have used their firearm within the past year have at least one member who has received safety instruction, the same can be said of only a minority (37%) of those households which have not used their firearm in this period of time. Finally, the survey results suggest that there tends to be a positive association between the incidence of firearm safety instruction and the number of firearms owned by households (from 43% among those with only one firearm, up to around 60% of households with five or more firearms).

Volunteered by respondents as their household's main reason for owning this type of firearm; it was not read to respondents as were target shooting, hunting, collecting ** and employment.

5.0 REASONS FOR FIREARM OWNERSHIP

5.1 Rifles

Survey respondents who indicated that they or some other member of their household owns a rifle, shotgun, handgun, or some other type of firearm (term volunteered), were subsequently asked what their household's main reason is for owning each type of firearm. These respondents were asked whether their household's main reason for ownership is target shooting, hunting, collecting or employment, or some other reason volunteered by the respondents; only one main reason was accepted for each type of firearm owned by the respondent's household.

Hunting is the predominant reason why Canadians own rifles. Fully two-thirds (68%) of surveyed Canadian households which own a rifle do so for hunting purposes. This reason is trailed distantly by target shooting and collecting (14% each). A negligible portion of rifle-owning households own this type of firearm for reasons of employment or self-protection (term volunteered).

A large majority of the rifle-owning households interviewed in all parts of the country own this type of firearm for hunting purposes. Nevertheless, this figure does show regional variation, from six in ten households in British Columbia and Alberta to fully three-quarters in Quebec, the Atlantic provinces and Yukon/NWT. As a main reason for rifle ownership, target shooting is the most common among rifle-owning households in Yukon/NWT (21%) and Alberta (19%). Compared to other regions, owning a rifle for collecting purposes is most likely to be indicated by households in British Columbia (22%), followed by those in Alberta and Ontario (17% each). (TABLE 10)

Further analysis shows that rifle-owning households interviewed which also have a handgun reported somewhat different reasons for owning a rifle than those households which do not also own a handgun. In particular, these households are somewhat less likely to own their rifle for hunting (only 59% reported this reason), and somewhat more likely to cite target shooting (16%) or collecting (20%) as the main reason. Similarly, rifle-owning households which also own a shotgun are somewhat more likely to report hunting (76%) as the main reason for having a rifle, and somewhat less likely to cite either target shooting (10%) or collecting (11%). 5.2 Shotguns

Hunting is an even more pervasive reason for owning a shotgun than a rifle. More than three-quarters (78%) of surveyed Canadian households which own a shotgun said their primary reason for ownership is hunting. Other reasons account for only a small minority of households which own a shotgun, the main ones being collecting (11%) and target shooting (8%). As was observed for rifles, virtually no shotgun-owning households cite employment or self-protection (volunteered by respondents) as their primary reason for ownership of a shotgun.

Throughout the country, hunting is by far the main reason why households own shotguns. Regional patterns which were noted for rifle ownership are, similarly, observed with respect to shotguns: namely, shotgun-owning households in British Columbia and Alberta are the least inclined to own a shotgun for hunting purposes (63% and 70% respectively, which is still very large) while those in Quebec (88%), Atlantic Canada (81%) and Yukon/NWT (86%) are the most likely to do so. British Columbians are again the most likely to own a shotgun for collecting (20%), and target shooting is mentioned more often by Alberta households (13%).

Shotgun-owning households which also own a handgun are somewhat more likely to report collecting (16%) or target shooting (13%) as the main reason for owning their shotgun and somewhat less likely to cite hunting (67%).

5.3 Handguns

Handguns, meanwhile, largely tend to be owned for target shooting and collecting purposes. A plurality of interviewed households which own a handgun cite target shooting (41%) as their main reason for ownership, followed by collecting (32%). A significant number (15%) also do so for employment purposes. Self-protection (volunteered by respondents) and hunting are each pinpointed as foremost reasons by only one in twenty (5%) households which own a handgun.

Reasons for handgun ownership are not uniform across the country. Target shooting is the primary reason for owning a handgun among half of all such households in British Columbia, Alberta and the Atlantic provinces. In Manitoba-Saskatchewan and Ontario, handgun-owning households are roughly divided between target shooting and collecting, with an even split between these two reasons in Yukon/NWT. Reasons for owning a handgun are divided further still among Quebec households with handguns: one-quarter own this firearm mainly for target shooting, one in five (20%) for collecting, and three in ten (30%) for employment purposes (considerably higher than households elsewhere in Canada); households from this province are also the most likely to own handguns for the respondent-volunteered reason of self-protection (14%).

6.0 FIREARM USAGE

6.1 Use of Firearms Over the Past Year

The data collected in this survey suggest that Canadian households which own a firearm are evenly divided between those which have used any of their firearms over the past year and those which have not. One-half of all firearm households in this country have used at least one of their firearms over the course of the last 12 months. A generally comparable figure can be found in most parts of Canada. The two exceptions are British Columbia households (only 38%) and, positioned at the other end of the continuum, households in Yukon/NWT (65%). (TABLE 12)

APPENDIX I

SURVEY METHODOLOGY

Survey Content and Comparisons with Other Sources

The questionnaire for this survey was developed in close consultation with representatives from the Department of Justice. The final draft questionnaire was subject to pretesting and revision in order to ensure that the question wording was clear and accurate, and that the interviews flowed smoothly. A copy of the final questionnaire employed in this study is appended to this report.

The focus of this study was on household ownership of firearms in Canada, the main reason for owning different types of firearms, and household usage of firearms during the last 12 months. The results also provide estimates of the total stock of firearms held in private households at this time.

A survey conducted by Statistics Canada in August, 1976 estimated that a total of 5,168,000 firearms were held by private households in Canada. Estimates from the present survey suggest that this number has now grown by about fifteen percent to 5,926,000 firearms. Estimates of the number of households which own firearms are not available from the Statistics Canada study, so that other data from the two studies are not directly comparable.

Sampling Method and Precision of Estimates

The survey population for this study is all Canadian households with a working telephone on the premises. Since the telephone numbers called in this study were generated at random, all such households had a chance of being selected, whether or not their telephone number was listed or unlisted in telephone company directories. Telephone numbers for the sample were randomly generated using the Angus Reid Group's in-house computerized sample selection procedure. This program generates telephone numbers randomly by Census Division, such that the sample is selected proportionate to population distributions consistent with Census data.

All data reported in the research findings have been weighted to reflect the actual proportions of households in Canada by province and territory. The results, therefore, are taken to be representative of the Canadian population as a whole, both nationally and regionally.

In the survey, a total of 2341 households were interviewed where there was at least one firearm owned by the household. With respect to the profile of firearms owned and other measures in this survey, estimates of proportions based on a random sample of this size are accurate to within ± 2.0 percentage points at the 95 percent confidence level.

The portrait of firearm owners is based upon the 1271 respondents in this survey who personally owned a firearm. The survey results concerning firearm owners are taken to be accurate to within \pm 2.75 percentage points at the 95 percent confidence level.

The prevalence of firearm ownership is estimated to be 23 percent of Canadian households. Moreover, since this estimate of firearm ownership prevalence is based upon 10,103 households, this estimate is expected to be accurate to within ± 1 percentage point at the 95 percent confidence level.

With respect to all other estimates of proportions (ie. "percentages") reported in this study, a more precise estimate of statistical precision may be obtained by consulting appropriate tables of statistical significance. In general, these latter estimates of precision often indicate that the results are more precise, since the above generalisations assume a "worst case" estimate.

The accuracy of survey estimates in general may be affected by various sources of "non-sampling error", the effects of which are typically inestimable. Such sources include the differences which may have resulted from reporting errors and from non-response, for example. Similarly, the present study may be subject to inaccuracies due to non-sampling error. However, there is no evidence in the present study to suggest that the estimates produced by this survey are subject to any more inaccuracies nor any less inaccuracies than any other similar telephone survey of the Canadian population.
