ANNUAL REPORT ACCESS TO INFORMATION ACT APRIL 1, 2023 TO MARCH 31, 2024

1. INTRODUCTION

The Access to Information Act grants Canadian citizens and permanent residents the right to access information contained in records under the control of federal institutions governed by the Act. This right is subject to exceptions specified within the Act. Additionally, decisions made by federal institutions on the disclosure of government information are subject to independent review by the Access to Information Commissioner of Canada and by the Federal Court.

The Canadian Museum of Nature's (CMN) *Access to Information Act* Annual Report has been prepared and will be tabled in Parliament according to section 94 of the *Access to Information Act*.

The Canadian Museum of Nature (CMN), a Schedule III Crown Corporation, was established in 1990 by the *Museums Act* and reports to Parliament through the Minister of Canadian Heritage. The Board of Trustees is responsible for setting the strategic direction of the Corporation. The President and Chief Executive Officer is responsible for the day-to-day operations of the Corporation.

The mandate of the Canadian Museum of Nature, as embodied in the *Museums Act* (1990), is:

"To increase, throughout Canada and internationally, interest in, knowledge of and appreciation and respect for the natural world by establishing, maintaining and developing for research and posterity, a collection of natural history objects, with special but not exclusive reference to Canada, and by demonstrating the natural world, the knowledge derived from it and the understanding it represents."

The Canadian Museum of Nature does not have any non-operational ("paper") subsidiaries.

The Canadian Museum of Nature's major programs and activities include:

Public Education:

The Museum develops and maintains exhibitions, programs, events, the nature.ca website, electronic and print publications, and activities to foster community engagement, learning, and an understanding of and respect for nature.

Collections Management:

The Museum develops, preserves, and makes accessible collections of natural history specimens, objects, and information to meet the growing needs of the public and private sectors for research, education and informed decision-making about the natural world.

Research:

The Museum studies the past and helps Canadians prepare for the future by conducting systematics and applied research, and by developing and maintaining networks and linkages with Canadian and international science communities.

Internal Services:

The Museum develops and implements policies, processes and an accountability structure to oversee the fulfillment of its mandate, including governance, strategic direction, corporate services, monitoring of corporate performance, reporting to Parliament and revenue-generating activities.

Accommodation:

The Museum provides secure and functional facilities that meet all safety and building-code requirements. These facilities include the Victoria Memorial Museum Building, a national historic site and the birthplace of Canada's national museums, where most of our exhibitions and programs are offered, as well as the Natural Heritage Campus, which houses our research, collections and administrative operations.

2. ORGANIZATIONAL STRUCTURE

The President of the Canadian Museum of Nature, as designated head (President) of the Museum under the *Access to Information Act*, personally exercises the powers entrusted to the position by the *Act*. The President has delegated power for specific sections of the *Act* to the Vice President, Corporate Services and to the Access to Information and Privacy Co-ordinator.

The Museum occasionally employs a contractor to support the Vice President, Corporate Services and the Access to Information and Privacy Co-ordinator in handling incoming requests.

During the reporting period, the Canadian Museum of Nature did not have any service agreements under section 96 of the *Access to Information Act*.

For Proactive Publication Requirements, the Chief Financial Officer is responsible for publishing Travel and Hospitality expenses, while the Corporate Secretary Reports is responsible for publishing reports tabled in Parliament.

3. DELEGATION ORDER

The Canadian Museum of Nature's Access to Information Delegation Order is attached as Appendix A.

4. PERFORMANCE 2023-24

The Museum generally receives a small number of access to Information requests. Given the Museum's mandate to educate Canadians and disseminate knowledge, a considerable amount of information is provided to the public, be it through public displays, printed material, inquiry lines, the Museum's Web site or other media. Statistics on the distribution of this material are provided in the Museum's Corporate Plan and the Annual Summary of Scientific Publications.

During the 2023-24 reporting period, the Museum received two (2) formal access to information requests, and one (1) outstanding request was carried over from the previous year. Additionally, the Museum received two (2) requests for consultation from another Government of Canada Institution.

Access to Information Requests:

- Percentage of requests responded to within legislated timelines: 66.7%
- Number of requests, broken down by completion times:
 - Within 1-15 days: 1
 - Within 31-60 days: 1
 - Within 61-120 days: 1
- Requests for which "no records exist": 1, or 33.33%
- Requests for which records were "disclosed in part": 2, or 66.67%

In 2023-24 the Museum invoked extensions for 1, or 33.33% of all completed requests. The extension was necessary to accommodate consultations that could not reasonably be completed within the original time limit.

Consultation Requests:

 - Within 1-15 days: 1
 - Within 31-60 days: 1
- Percentage for which records were "fully disclosed": 100%

To note: The 2022-23 statistical report incorrectly indicated that two (2) access to information requests were completed within that period. In fact, one was completed; the second should have been noted as outstanding and carried over to the 2023-24 reporting period.

5. TRAINING AND AWARENESS

The Canadian Museum of Nature's *Records and Information Management Policy* defines the roles and the responsibilities of Museum employees regarding records management and the implementation of the *Access to Information Act*. This policy is available to all employees. The Access to Information and Privacy Coordinator provided periodic one-on-one and advice and guidance as required, to CMN staff and Senior Management on Access to Information and Records and Information Management.

Due to operational constraints, the Canadian Museum of Nature did not conduct awareness sessions in 2023-24. To ensure staff have the necessary information to effectively carry out their duties with respect to Access to Information, the Museum will be conducting an assessment of required training for all staff.

6. POLICIES, GUIDELINES, PRODECURES AND INITIATIVES

No changes were made to the Canadian Museum of Nature's Access to Information related policies, guidelines, prodecures or initatives.

The Canadian Museum of Nature will be undertaking a review of its internal policies and practices, to identify efficiencies and facilitate the processing of requests and making more information readily available to the public. Work is expected to be completed by the end of fiscal 2025-26.

7. PROACTIVE PUBLICATION UNDER PART II - ACCESS TO INFORMATION ACT

The Canadian Museum of Nature publishes its travel and hospitality expenses incurred by senior officers within 30 days after the end of the month in which the expenses occurred on the Government of Canada's Proactive Disclousure website.

The Museum also publishes its reports tabled in Parliament on the <u>Nature.ca</u> website, under the <u>Plans</u> and <u>Reports</u> and <u>Transparency</u> and <u>Accountability</u> sections.

Percentage of proactive publication requirements published within the legislated timelines: 0%

Part if the issue was that the Museum transition to publishing its travel and hospitality expenses on the Government of Canada's Open Government website. Delays were caused due to new templates, timelines and the implementation of new processes and procedures.

To improve this, the Museum will review its internal practices to identify efficiencies and ensure that it meets its proactive disclosure obligations in a timely manner.

The proactive publication of the Canadian Museum of Nature, under Part 2 of the ATIA, is attached in Appendix B.

8. SUMMARY OF KEY ISSUES AND ACTIONS TAKEN ON COMPLAINTS

As of March 31, 2024, the Canadian Museum of Nature had no complaints against it under the *Access to Information Act*.

9. MONITORING COMPLIANCE

During the reporting period, regular updates were provided to the VP, Corporate Services regarding incoming requests and the status of those requiring extensions. This included a regular review of materials with the VP, Corporate Services and the status of expected completion.
