



## Anik C2 to ride with Challenger

On June 18, 1983, Telesat Canada's Anik C2 was launched aboard NASA's Space Shuttle "Challenger". Canada's seventh commercial communications satellite, C2 will be an in-orbit back-up for its predecessor, Anik C3, launched in November 1982. Anik C3 provides Canadian pay-TV, educational TV and long-distance telecommunications services.

The Anik C series of satellites are the most powerful domestic communications satellites available to North Americans,

and bring innovative, flexible, cost-efficient new broadcasting, business and other telecommunications services to customers. They can provide very reliable transmission of voice, video and data communications and, because of their high power, allow the use of much smaller earth stations.

Anik C's 16 transponders receive audio signals transmitted from earth at 14 billion cycles per second (14 GHz), amplify them, and transmit them back to earth in the 12 GHz range. Each transponder can

carry the equivalent of 1,344 one-way voice channels, or two color TV channels. The satellite's antenna covers most of Canada with four spot beams.

Telesat's first Anik C2 customer will be GTE Satellite Corp. of Stamford, Connecticut, which will lease five channels to provide pay-TV service.

The Anik satellites underwent pre-launch testing at DOC's David Florida Laboratory.

June 8, NASA's Space Shuttle prototype, Enterprise, rode into Ottawa aboard its Boeing 747, and for several days everyone became Star Trekkers, as all marvelled at this space explorer.

Huge crowds gathered to see the Enterprise and to visit DOC's exhibit, "Canada:

20 Years in Space", which was displayed in the National Research Council hangar at Uplands airport. NASA official James Beggs and Canadian Science Minister Donald Johnston discussed the participation of Canada's first astronaut, probably in 1985.

DOC employees who have a burning desire to be an astronaut or to walk in space should be warned that July 15 is the deadline for applications. So hurry! Grab your space suit and apply to DOC's Far-Out Branch, Galaxy Level, Journal Tower North. See you in space.

## France-Canada film co-operation agreement

At the end of May, Communications Minister Francis Fox and French Ambassador Jean Béliard signed a film co-operation agreement to strengthen cultural and economic links between France and Canada.

The signing was followed by a formal reception in Montreal, attended by guests from the film and television production industries, cablecasters, producers and artists. The Agreement concerning

cinematographic relations between the Canadian and French governments involves film and film productions. It extends a 1974 agreement dealing primarily with feature films to include other types of production such as short films and documentaries.

This agreement is the first in a series of three film and audio-visual agreements initialled in Paris on April 22 by Alain Gourd, SADM.

## Canada's WCY program effective

Halfway into World Communications Year, a number of events in Canada's WCY program have attracted much attention and have been very successful.

In mid-May, Communications Minister Francis Fox announced 12 major Canadian winners in the Youth Photo and Drawing Contest, a worldwide competition held in conjunction with World Communications Year 1983. In total, 180 contestants won Canadian regional prizes donated by government and the private sector.

The three national first-prize winners will receive a cash award plus a trip to Geneva in October, to participate in the world competition during Telecom 83. They are: Jacques Patry, 12, of Sherbrooke, Quebec; Susan Meyer, 14, of Holyrood, Ontario; and Richard Gamelin, 17, of Espanola, Ontario.

Montreal was the site, from June 6 to 17, of an important international seminar entitled "Communications: New Tech-

nologies, New Challenges for Development," organized by the Institut international de la communication. Sponsored by the federal Departments of Communications, External Affairs, CIDA, the Quebec Department of Communications, and Teleglobe Canada, the seminar was intended for senior officials of 40 underdeveloped countries, plus Canadian officials from federal and provincial governments.

The seminar dealt with new technologies in telecommunications, microcomputers and telematics, and their interrelationship in the communications infrastructure. The program included lectures by Canadian specialists, demonstrations of new technologies, workshops and tours of technical centres in Ottawa, Montreal and Quebec City.

Ottawa was the scene, May 30 – June 3, of the University Research Symposium, which focussed on research in telecommunications performed by Canadian universities for the Department of Communications.

On May 25 and 26, the University of Ottawa held a successful conference under the title of "Communications, Technology and International Development: Issues/Perspectives, An International Symposium."

In mid-May the Arts, Science and Technology Exhibit opened in British Columbia, and will be on display in the province for five months. The 3,600-square-foot spectacular exhibit is a cooperative project of DOC, the provincial government, the Arts, Science & Technology Centre, the NEED Program, educational institutions, the communications industry and community organizations. The exhibit contains four modules: (1) Program production, featuring computer graphics, using Telidon; (2) Satellites, with 10 models circling the earth, and a Spacephone using Anik B; (3) Mobile radio systems; (4) Telecommunications, featuring the tracing of a phone call through the system, and a walk-through fibre-optic cable.

## The Regulatory Reporter now an independent service

On May 12, the Minister of Communications met with representatives from the Canadian Law Information Council to receive its annual report and to extend his congratulations on the success of its publication, **The Regulatory Reporter**. Launched in 1980 with financial assistance from DOC, its goal is to improve public access to information in the telecommunications field. The Reporter is now an independent subscriber-supported service, after a three-year period of government and industry support. It provides monthly summaries of decisions of regulatory agencies and judicial and political appellate bodies; proceedings before agencies, judicial or political bodies; amendments to legislation or new legislation; and commentary on current trends and developments.
