1. Introduction

The *Species at Risk Act* (SARA or the Act) enacted in 2002, is part of Canada’s strategy to protect wildlife species from becoming extinct, and to help in their recovery. The Act, among other things, establishes a process for conducting scientific assessments of the status of individual wildlife species, and a mechanism for listing those assessed as Extirpated, Endangered, Threatened and Special Concern species. SARA requires the protection of individuals, residences and critical habitats of the wildlife species listed on Schedule 1 as Extirpated, Endangered or Threatened. The Act also requires the preparation of recovery documents for all listed wildlife species.

Every year, the Minister of the Environment¹ must prepare a report², on the administration of the Act during the preceding calendar year, and table it in Parliament. This SARA Annual Report summarizes activities carried out in 2024³.

The Minister is responsible for the overall administration of SARA, except insofar as the Act gives responsibility to another “competent” minister. Environment and Climate Change Canada (ECCC), Parks Canada (PC), and Fisheries and Oceans Canada (DFO) often referred to as the “competent” departments, share responsibility for the implementation of SARA.

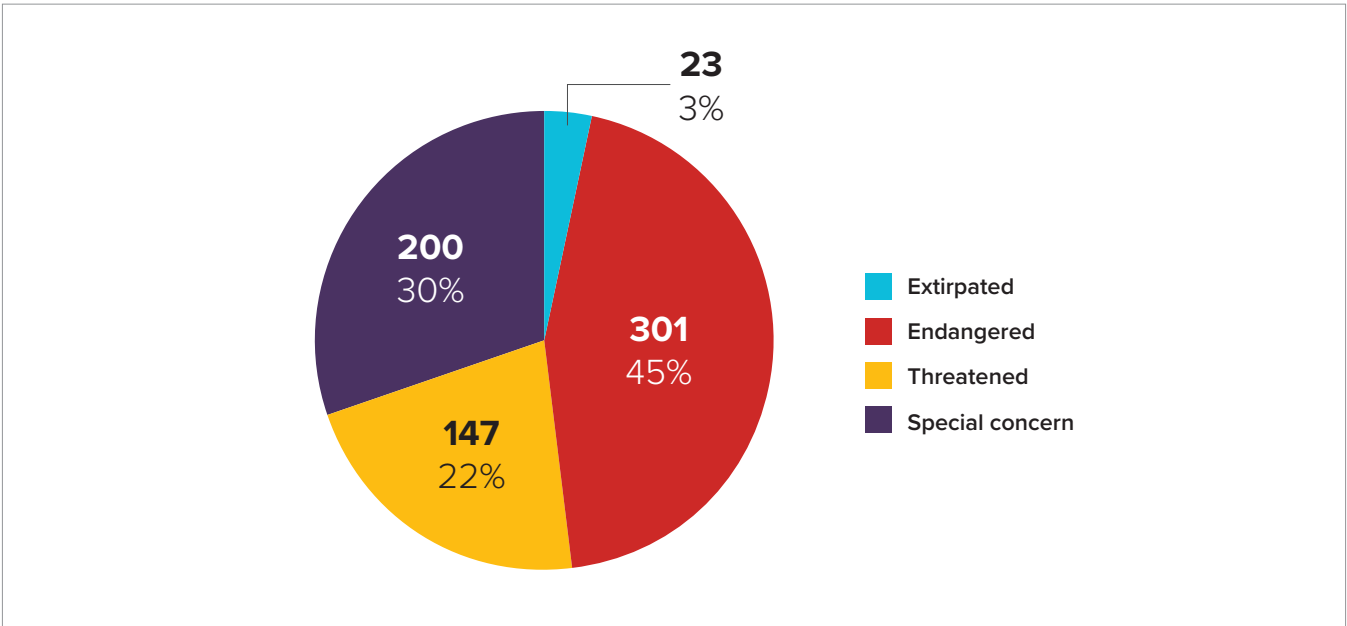
Highlights

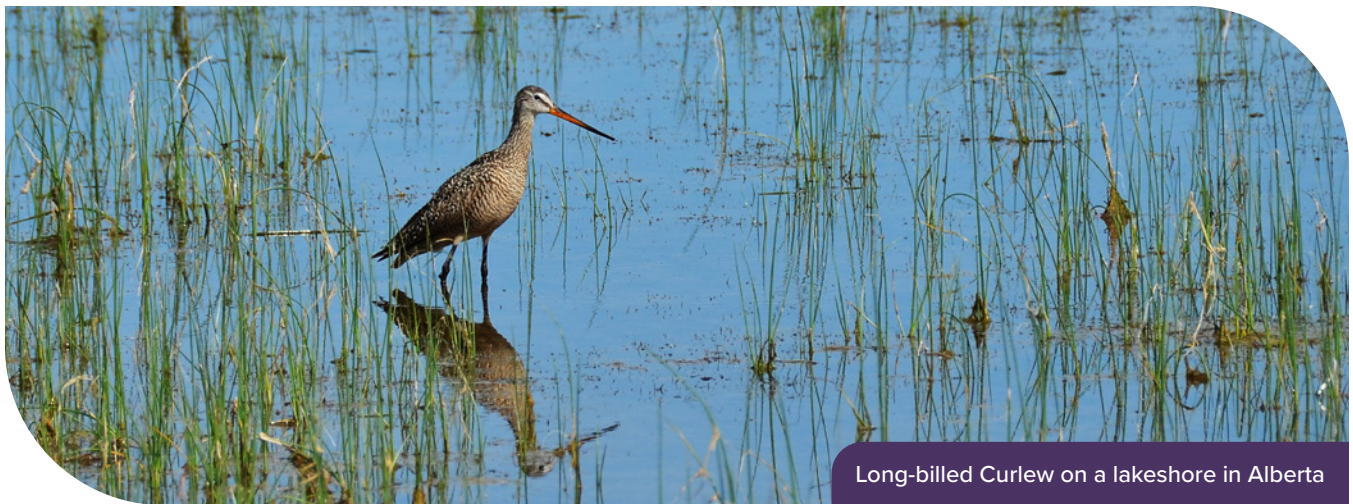
- In 2024, the [Wild Species](#) program launched a [new search tool](#) that allows users to track, in its database, the status of over 50,000 wild species in Canada, including species at risk, and see how they have changed over time. The program produces a report and database every five years on the status and distribution of all wild species in Canada as required under section 128 of SARA.
- In May 2024, ECCC published the [Report on the Progress of the Recovery Strategy Implementation \(Period 2017–2022\) and the Action Plan Implementation \(Period 2018–2023\) for Caribou \(*Rangifer tarandus*\), Boreal Population, in Canada](#). Overall, the report shows that some progress has been made in key areas of the implementation of the federal Recovery Strategy and Action Plan for Boreal Caribou, but more work needs to be done to achieve recovery goals.
- In October 2024, the Government of Canada posted the final [Policy on Assessing Imminent Threats under Sections 29 and 80 of the Species at Risk Act—terrestrial species](#), as well as the [Operational guide: requesting an imminent threat assessment for terrestrial species under the Species at Risk Act](#) on the Species at Risk Public Registry in October 2024. These documents improve the transparency of the imminent threat assessment process.
- In October 2024, a new [State of Canada's Birds web platform](#) was launched through a partnership between ECCC and Birds Canada. It combines the best available monitoring information on the populations of all regularly occurring species of birds in Canada, including details for all 79 bird species listed under SARA.
- PC provided legal protection for three species in three Parks Canada-administered areas by publishing a critical habitat description for Redside Dace; and, jointly with DFO, a critical habitat description for Spotted Gar and a critical habitat order for White Sturgeon, Nechako River Population. PC also published reports on the progress of recovery document implementation for Pink Sand-verbena and Bolander's Quillwort.
- DFO renewed a five-year conservation agreement with Transport Canada, the Vancouver Fraser Port Authority, and six marine transportation industry associations to mitigate the impacts of acoustic and physical disturbance from large commercial vessels on endangered Southern Resident Killer Whales.
- ECCC, DFO, and PC continued to deliver on commitments aligned with recommendations made by the Commissioner of Environment and Sustainable Development (CESD) to address gaps in SARA implementation.

1.1. Status of SARA-listed Species

As of December 31, 2024, Schedule 1 of SARA had a total of 671 species listed at-risk. Of these, ECCC is responsible for 520, PC 11, and DFO 140. Where multiple federal authorities exist for either a terrestrial or aquatic species in or on federal lands administered by PC, PC collaborates with ECCC and DFO, respectively.

2. Assessment of Species at Risk

There are about 80,000 species in Canada. In order to protect them, we first have to know where they are, identify them, gather knowledge about their state, and understand what is key to their survival. We also need to understand the challenges and threats they face.

2.1. Wild Species Report

Under section 128 of the SARA, the Minister must prepare a general report on the status of all wildlife species in Canada every five years. The [2020 Wild Species report](#) included information on over 50,000 species. These reports help the [Committee on the Status of Endangered Wildlife in Canada](#) (COSEWIC) determine which species warrant more in-depth assessment. ECCC is currently leading efforts, in collaboration with NatureServe Canada and provincial and territorial counterparts, to prepare the 2025 report, which will include data on over 65,000 species.

A [new search tool](#) released on wildspecies.ca in 2024 allows users to search the database for each species, including species at risk, to determine its status nationally and by province and territory, and to see how its status has changed over time. The site also features photos of many of these species from the citizen science platform, iNaturalist.

2.2. COSEWIC Assessments

COSEWIC is an independent advisory panel to the Minister that meets twice a year to assess the status of wildlife species. Their mandate is to assess the status of wildlife species in Canada that it considers to be at risk and identify existing and potential threats to the species. COSEWIC uses the best available information on the biological status of a species, including scientific knowledge, community knowledge and Indigenous traditional knowledge. COSEWIC provides species' assessments and supporting evidence annually to the Minister.

The Act requires COSEWIC to review the classification of each species at risk at least once every 10 years, or at any time if it has reason to believe that the status of the species has changed significantly or when sufficient data becomes available to determine whether there was a change in status.

Species Reassessed by COSEWIC

Most wildlife species remain in the same category when they are reassessed. In December 2023 and May 2024, 28 wildlife species were reassessed, of which 17 had no change in their status. Of the 11 species that had a change in status, six were classified to a higher-risk category and five were classified to a lower-risk category.

3. Listing of Species at Risk

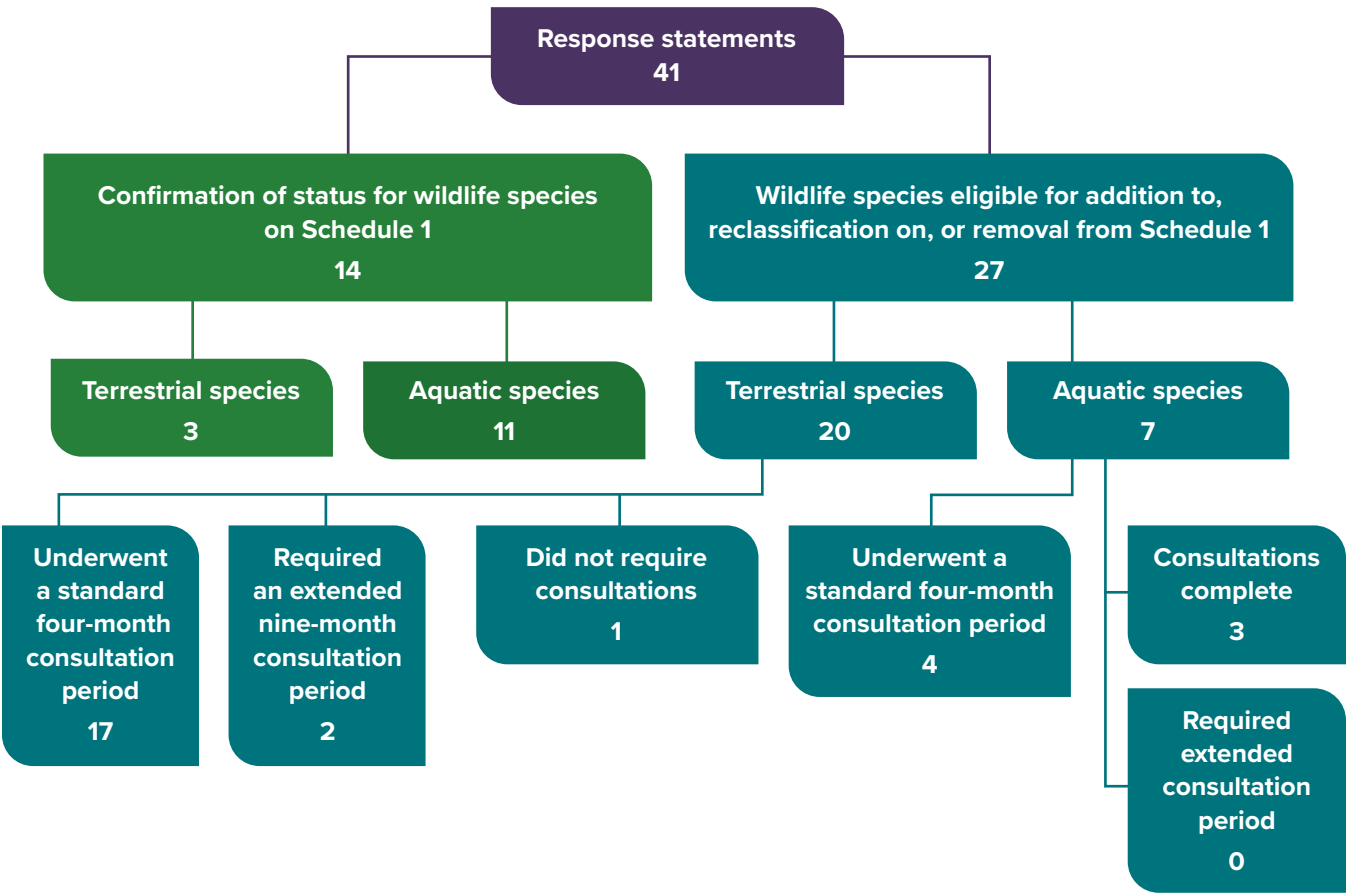
3.1. Minister’s Response to COSEWIC’s Assessments

Only when a species is assessed by COSEWIC as at risk (Extirpated, Endangered, Threatened, or Special Concern) does it become eligible to be included on Schedule 1 of SARA. COSEWIC sends its assessment and supporting evidence (that is, rationale and status reports) for species classified as at risk, to the Minister. The COSEWIC assessment and the reasons for it are also posted on the SAR Public Registry.

In October 2024, COSEWIC submitted 41 wildlife species assessments. The Minister has 90 days to issue a response statement indicating how they intend to respond to each COSEWIC assessment, and to provide timelines for action, to the extent possible. The Minister’s response statements indicate the type of consultation that will be undertaken for the species. Certain species may require extended consultation.

The Minister's consultation process engages Indigenous peoples, stakeholders and the public to examine the potential social, economic, and ecological impacts of adding, not adding, removing, or changing the status of a species on Schedule 1 of SARA.

Public Consultations

The Minister forwards COSEWIC assessments and consultation results to the Governor in Council (GIC). The GIC, on the recommendation of the Minister, decides whether or not to add, remove, or reclassify a species, or refer the matter back for further information or consideration. If the GIC does not take a course of action within nine months of receiving the assessment, the Act requires the Minister to amend the List in accordance with COSEWIC's assessment.

In 2024, one order that acknowledges the receipt by the GIC of species at risk assessments was published in the *Canada Gazette*, Part II.

3.2. Amendments to Schedule 1 in 2024

In 2024, two listing orders amending Schedule 1 and one order that acknowledges the receipt by the GIC of species at risk assessments, were published in the *Canada Gazette*, Part II.

[Order Amending Schedule 1 to the *Species at Risk Act*: SOR/2024-135 for Eastern Wolf \(June 17, 2024\)](#)

This Order reclassified the Eastern Wolf from a status of Special Concern to Threatened to ensure that the species is afforded a level of protection commensurate with risks to the species' survival.

Order Amending Schedule 1 to the *Species at Risk Act*: SOR/2024-123 for the Chestnut-collared Longspur and Nine Other Wildlife Species (June 10, 2024)

This Order amends Schedule 1 to SARA by adding nine new species to the List. One species already listed is reclassified from a Threatened to an Endangered status (the Chestnut-collared Longspur).

4. Planning and Activities for Species at Risk Recovery and Conservation

4.1. Planning Documents

Once listed, measures to [protect and recover the at-risk wildlife species](#) are required. Under SARA, the competent ministers must prepare recovery strategies and action plans for the species listed as Extirpated, Endangered or Threatened, and management plans for those listed as Special Concern. Implementation reports are required under SARA to provide information on the progress made toward achieving objectives set out in a species’ recovery strategy or management plan or the progress made toward implementing the measures proposed in an action plan.

Recovery Strategies

Preparation of recovery strategies for species listed as Extirpated, Endangered, or Threatened have the following steps:

1. Identify threats to the species and its habitat
2. Set population and distribution objectives for the species
3. Identify critical habitat to the extent possible

Competent departments continue to work on producing documents within the timelines provided for in the Act and are working to publish overdue recovery strategies and their implementation reports. ECCC has 28 species with an overdue recovery strategy and 226 overdue implementation reports on active recovery strategies. PC has no species with an overdue recovery strategy, nor any overdue implementation reports on recovery strategies. DFO has 4 species with an overdue recovery strategy and 12 species with overdue implementation reports on recovery strategies.

Action Plans

An action plan identifies the conservation measures required to address the threats to the species and meet the population and distribution objectives outlined in the recovery strategy. An action plan may include identification of the species' critical habitat, to the extent possible, based on the best available information, and consistent with the recovery strategy.

Competent departments continue to work on producing documents on time and are working to publish overdue action plans and their implementation reports. ECCC has 217 species with an overdue action plan and 21 overdue implementation reports on active action plans. PC has no species with an overdue action plan or associated implementation reports. DFO has 17 species with an overdue action plan and 13 overdue implementation reports on action plans.

The Minister of the Environment released the [*Report on the Progress of the Recovery Strategy Implementation \(Period 2017–2022\) and the report on Action Plan Implementation \(Period 2018–2023\) for Caribou \(*Rangifer tarandus*\), Boreal Population, in Canada*](#) on May 10, 2024. The Report highlights federal, provincial, and territorial progress over the last five years in implementing the federal Recovery Strategy and Action Plan for the Boreal Caribou. It includes assessments of population and habitat conditions, and summarizes key recovery measures taken nationally, as well as in each province and territory. Overall, the report shows that some progress has been made in key areas, but much remains to be done to achieve the goals set out in the Boreal Caribou National Recovery Strategy.

Management Plans

A management plan differs from a recovery strategy and an action plan, in that it identifies conservation measures needed to prevent a species of Special Concern from becoming Threatened or Endangered, but it does not identify critical habitat. Where appropriate, these management plans may be prepared for multiple species on an ecosystem or landscape level.

Competent departments continue to work on producing documents within the timelines outlined in the Act and are working to publish overdue management plans and their implementation reports. ECCC has 21 species with an overdue management plan and 64 overdue implementation reports on active management plans. PC has no species with an overdue management plan or associated implementation reports. DFO has seven species with an overdue management plan and 15 species with an overdue implementation reports on the management plan.

Critical Habitat

Critical habitat is identified in the recovery strategy or in an action plan for the species, as necessary to support the population and distribution objectives laid out in those planning documents.

In 2024, ECCC published the [Progress report on steps taken for protection of critical habitat for species at risk in Canada \(October 2023 to March 2024\)](#) and the [Progress report on steps taken for protection of critical habitat for species at risk in Canada \(April 2024 to September 2024\)](#).

In addition, ECCC published the second update to the [Critical Habitat for Species at Risk National Dataset](#), which displays the geographic areas within which critical habitat for terrestrial species at risk occurs in Canada. The dataset was published as open data on the Open Science and Data Portal, enabling public access to interactive maps for critical habitat for 284 species at risk. The interpretation of this geospatial information is available in recovery documents found on the Species at Risk Public Registry.

DFO’s [aquatic species at risk map](#) is available online to assist in project planning to protect critical habitat and other locations where species at risk are present.

4.2. Recovery Activities



Action plans and management plans propose various actions that can contribute to recovering, restoring, and enhancing ecosystems and species at risk across Canada. Many of these actions are taken or funded by ECCC, PC, and DFO.

In 2024–2025, PC implemented recovery measures on lands and waters it administers, including research, restoration, and public outreach and education activities; and is on track to complete 85% of recovery measures identified in current multi-species action plans. PC supported the delivery of over 18 initiatives in partnership with non-governmental organizations, academic institutions, private citizens and Indigenous communities, including the following:

- Recovery of Peary Caribou at Qausuittuq National Park by:
 - embracing *Inuit Qaujimajatuqangit*, the experiential knowledge of Inuit, and advancing Indigenous stewardship
 - continuing cleanup of fuel barrels and other non-hazardous debris from multiple sites to restore habitat for Peary Caribou
 - examining Peary Caribou connections to the environment as a whole, through the land, water, other wildlife, and with people
 - sharing progress of the work on social media and in [Parks Canada's Report on Conservation from 2018 to 2023](#)
- Recovery of species at risk at Point Pelee National Park by:
 - removing invasive Blue (Hybrid) Cattails (*Typha x glauca*) from wetland habitat that supports over 19 species at risk, including Least Bittern and multiple species of fish and turtles at risk
 - creating over 1,413 m² of open water habitat, and 339 m of edge habitat to support species at risk
 - working with academic partners to study the response of native species to various restoration techniques
 - sharing knowledge and lessons learned with First Nations partners and a regional Community of Practice



In Focus: Habitat Restoration for the Wood Turtle

The Mauricie National Park has been protecting the Wood Turtle for nearly 30 years. Since 2019, the park team has focused on preventing road mortality, the main threat to the species' survival. In 2021, the park helped create the Tortue Action Mauricie group, which it coordinates with two other local organizations. This collaboration helps to better coordinate turtle protection measures on a regional scale, including those aimed at reducing road mortality.

In line with this initiative, a permanent detour fence was installed at the park in 2024 to direct turtles away from a stretch of road where several turtles had been observed. Since its initial installation as a pilot project in 2020, there have been no sightings of this reptile on this stretch of road. In 2025, the park team will install a variable message sign and speed bumps to reduce vehicle speeds in sensitive areas.

These efforts are in addition to annual monitoring of the Wood Turtle population, carried out since 1996 at one of the species' largest known egg-laying sites. The team also protects nests and hatchlings from predation, another major threat to the species' survival. Thanks to all these actions, between 2022 and 2024, the number of nests observed reached its highest level in 20 years.

Habitat Stewardship Program

The Government of Canada's [Habitat Stewardship Program for Species at Risk](#) (HSP) was established in 2000. This application-based funding program is administered by ECCC (for terrestrial species) and DFO (for aquatic species) and is implemented on a regional basis. Projects funded by HSP are submitted by Canadians and contribute directly to the recovery objectives and population goals of species at risk and prevent others from becoming a conservation concern. The most complete information currently available for the HSP covers the 2023–2024 fiscal year.

The HSP for Terrestrial Species at Risk

In 2023–2024, ECCC invested over \$5.5 million in 100 HSP projects led by 93 different recipients who brought in over \$11.1 million in cash and in-kind support. Forty-eight new projects were launched, and 6 of the other 52 ongoing multi-year projects with existing funding commitments from previous years received additional funding to expand their scope. In addition, the maximum duration for HSP funding agreements was extended from three to five years. In total, over \$13.8 million in ECCC funding was committed in 2023–2024 for projects running through 2027–2028.

The 2023–2024 projects targeted a total of 162 terrestrial species at risk. On-the-ground results included over 51.3 thousand hectares of habitat secured and 8 thousand hectares of habitat newly protected through landowner or landholder agreements, while habitat protection agreements covering another 95 thousand hectares were renewed. Species at risk habitat was also improved by over 21.6 thousand hectares and along over 16 kilometres of shoreline.

The HSP for Aquatic Species at Risk

DFO's Habitat Stewardship Program for Aquatic Species at Risk invested approximately \$4 million in new and previously approved multi-year projects to support stewardship activities undertaken by external partners in Canada's freshwater and marine aquatic ecosystems.

Since its inception, DFO's Habitat Stewardship Program has successfully supported over 240 projects involving over 790 partners from Indigenous communities, provinces and territories, environmental organizations, industry, and academia that have directly contributed to the recovery of over 120 aquatic species at risk. In 2024, DFO's HSP approved and administered 25 new projects along with other multi-year projects approved in previous years.

HSP projects in 2024 supported stewardship efforts across Canada, resulting in outreach events, surveys, inventories, and habitat improvements, such as the removal of barriers and habitat restoration. Other important activities included support for the reduction of vessel strike risk and noise impacts to at-risk whale species, among many others important endeavours in support of aquatic species at risk.

HSP Project: Ontario Streams, Redside Dace Habitat Rehabilitation Initiative

The Redside Dace (*Clinostomus elongatus*) is a federally and provincially endangered minnow native to Ontario that is sensitive to changes in water quality. Pollution and litter in streams have led to decreased water quality across the Greater Toronto Area. Ontario Streams, a proponent in the Ontario and Prairie Region who received funding in 2023–2024, aims to improve degraded Redside Dace habitats through riparian plantings and in-stream rehabilitation over the course of this three-year project. Ontario Streams' project will implement restoration techniques to reduce sediment input into streams and improve fish habitat by installing habitat enhancement structures, increasing native riparian plant cover, and removing pollutants during garbage collection. These goals will be achieved by leading volunteer stewardship events for riparian planting, garbage cleanups in riparian areas, and assisting Ontario Streams' staff in installing in-stream habitat enhancement structures. With the support of the Habitat Stewardship Program, Ontario Streams can continue to lead impactful action to keep water clean, clear, and cool for Redside Dace.

Indigenous Partnerships for Species at Risk / Aboriginal Fund for Species at Risk

In fall 2024, ECCC renamed the Aboriginal Fund for Species at Risk (AFSAR) program to the Indigenous Partnerships for Species at Risk (IPSAR) program; however, DFO continues to use the original name. All aspects of the funding program remain the same. Established in 2004, the application-based program is delivered by ECCC (for terrestrial species) and DFO (for aquatic species). The program focuses on strengthening capacity in Indigenous communities to lead the stewardship of species at risk and culturally significant species in support of broader SARA implementation.

IPSAR (Terrestrial Projects)

IPSAR terrestrial projects support Indigenous peoples' capacity to lead on the recovery of species at risk and culturally significant species, such as caribou, Black Ash, and turtles by enabling a broad range of conservation actions that leverage Indigenous knowledge, engage communities, and facilitate the exercise of rights and responsibilities tied to stewardship. During the 2023–2024 fiscal year, the IPSAR terrestrial stream:

- provided \$2.49 million to 27 new and 31 previously approved multi-year Indigenous-led projects (58 in total)
- leveraged additional funds exceeding \$3.2 million (cash and in-kind)
- involved 58 Indigenous governments, communities, and organizations as recipients

Aboriginal Fund for Species at Risk (AFSAR) (Aquatic Projects)

During the 2023–2024 fiscal year, the AFSAR aquatic stream:

- provided over \$3 million towards 21 new projects and 26 previously approved multi-year projects (47 total)
- leveraged additional funds exceeding \$1 million (cash and in-kind)
- involved 41 Indigenous organizations and communities as recipients

AFSAR Project: Monitoring and Stewardship of Species at Risk With Mi'kmaw Communities of Mainland Nova Scotia

The Confederacy of Mainland Mi'kmaq (CMM) conducted a project that focused on the inner Bay of Fundy (iBoF) Atlantic Salmon, Brook Floater and American Eel. Project objectives were accomplished by surveying the target SAR populations, collecting data and samples, developing new recovery activities, and expanding outreach and education activities. The key project outcomes were integration of Mi'kmaw knowledge into conservation and recovery activities, and continued support for existing SAR recovery and management programs through data and sample collection. CMM was an integral part in improving information sharing between collaborators to support ongoing SAR stock assessment and conservation programs. The freshwater mussel and salmon outreach workshops increased community stewardship and implementation of SARA while promoting recovery strategies for target species and reinforcing the active role Mi'kmaw communities have in protecting SAR for future generations.

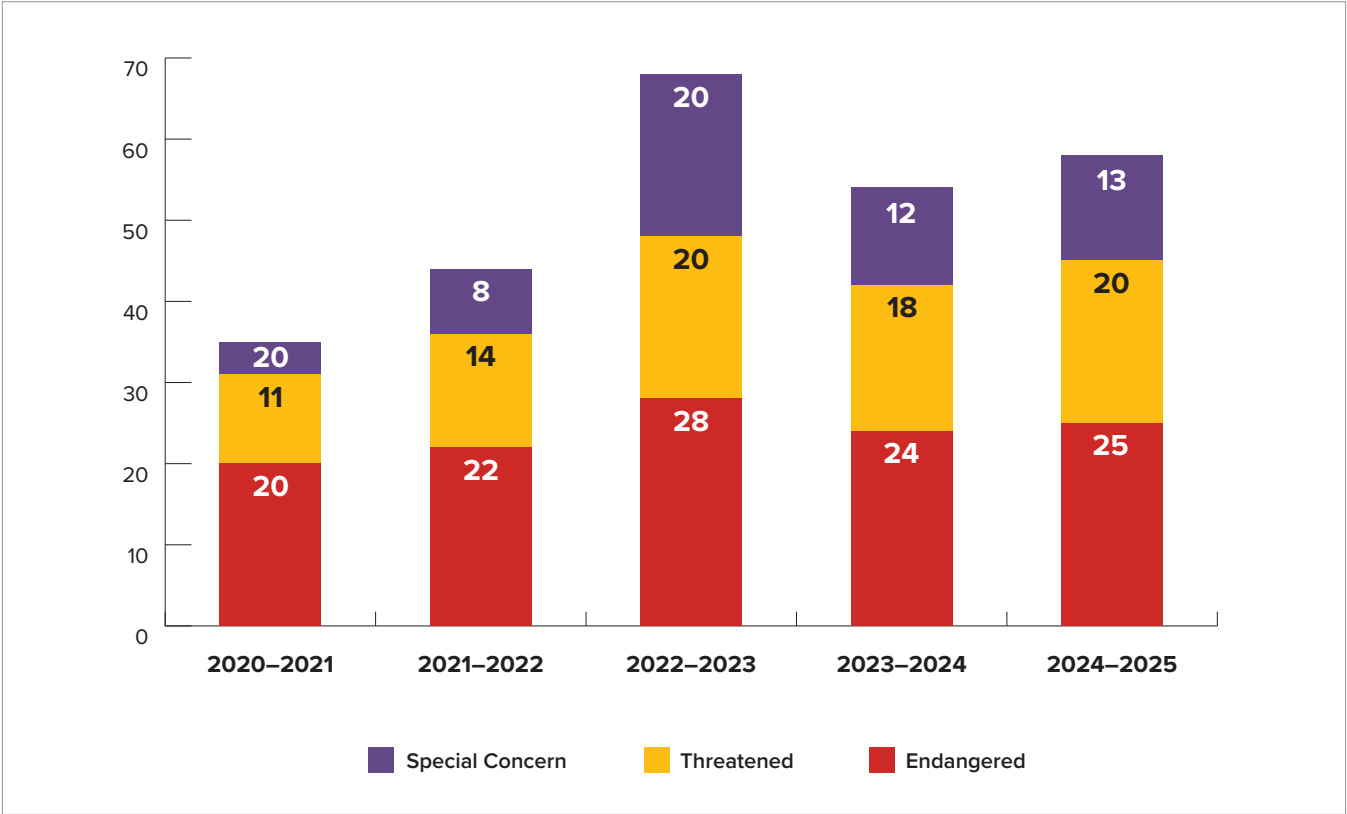
Critical Habitat Interdepartmental Program

Established in 2020, the [Critical Habitat Interdepartmental Program](#) (CHIP) is a directed funding program administered by ECCC. The CHIP encourages federal government departments, agencies, and Crown corporations (other than ECCC, PC, and DFO) to lead projects aimed at the recovery of species at risk through the conservation and restoration of their habitat on federally-administered or -owned lands. The CHIP operates at a fiscal year level, from April 1 to March 31, due to the financial nature of the funding program.

During the 2024–2025 fiscal year, the CHIP:

- provided \$355,078 towards eight projects (seven multi-year, one new)
- leveraged additional funds of \$390,414 (cash and in-kind)
- involved six federal departments and one Crown corporation and their numerous partners (e.g. Indigenous communities, environmental organizations, academics, provincial government, and private landowners)
- supported recovery and conservation efforts for 58 SARA-listed species

Overall, funded projects delivered on objectives that include critical habitat restoration through the removal of invasive species, the maintenance of a SAR field seed bank, SAR population surveys to support [Other Effective area-based Conservation Measures \(OECM\)](#), and monitoring and reintroduction of native species.

Recovery Actions for Garry Oak Ecosystems on Canadian Forces Base Esquimalt Properties, British Columbia

The Garry Oak woodlands and meadows of southwestern British Columbia represent one of Canada's most endangered ecosystems. Remaining fragments continue to be degraded by the proliferation of shrubs and trees into areas that were formerly open woodlands and meadows. To mitigate the impacts of this threat on SARA-listed plants, the Department of National Defence has been leading a long-term ecosystem management project to restore Garry Oak habitat by removing invasive shrubs and encroaching native trees. The current project is part of a broader stewardship effort that has been ongoing for over 10 years and builds on a previous nine-year project funded through the Interdepartmental Recovery Fund. The CHIP has been funding this current project since 2020.

Targeted species: Dense Spike-primrose, Rigid Apple Moss, Foothill Sedge, Macoun's Meadowfoam, Purple Sanicle, Kellogg's Rush, and Banded Chord Moss.

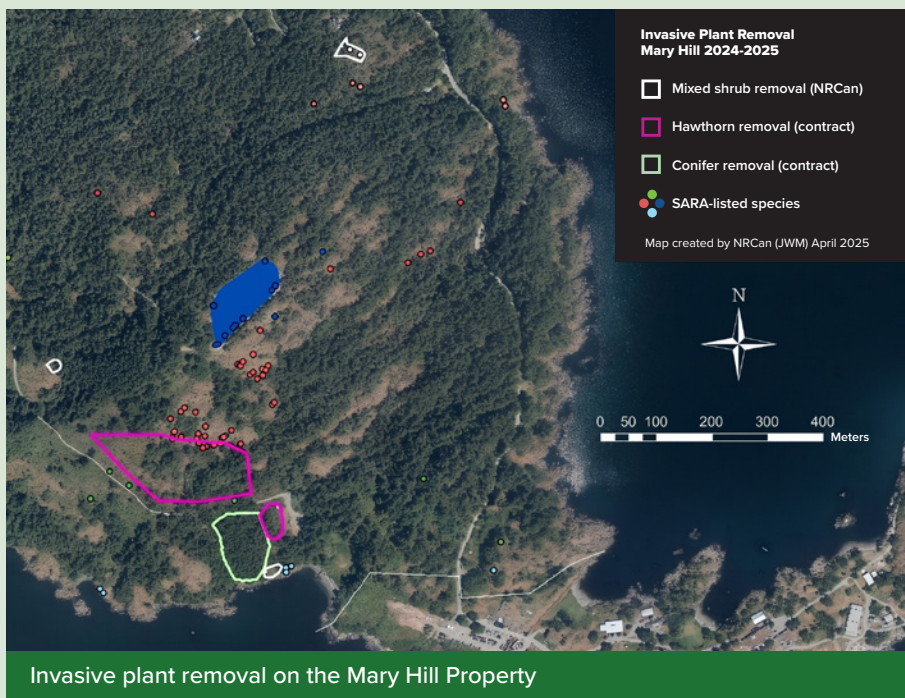
Accomplishments in 2024-2025

- The highest-priority invasive shrubs (Gorse and Common Hawthorn) have been reduced to 5% cover at two of the three sites;
- Conifer thinning complete over 95% of all three properties;
- All occupied habitat and critical habitat of SARA-listed plants clear of invasive shrubs at all three project properties;
- Endangered Deltoid Balsamroot discovered at Albert Head;
- More than 5 kg of seed of 26 native species was collected for direct seeding in areas disturbed by treatment activities or left bare after shading by invasive shrubs.

Canada Nature Fund for Aquatic Species at Risk

The Canada Nature Fund for Aquatic Species at Risk (CNFASAR) supports the recovery and protection of aquatic species at risk. Since its inception in 2018, CNFASAR has supported 94 projects, with an additional 57 ongoing.

To date the Government has invested over \$120 million in funding to address priority places and threats to aquatic species risk. This funding has supported projects that benefit over 150 populations of aquatic species at risk associated with nine priority places, and two marine threats (fishing interactions [includes entanglement and bycatch of aquatic species at risk] or physical and acoustic disturbance [includes vessel collisions and marine noise]).

CNFASAR Projects

Okanagan River Mainstream and Off-Channel Habitat Restoration in Okanagan Falls, BC

In 2024, under a three-year agreement, the Okanagan Nation Alliance completed work to restore two sites of the Okanagan Mainstream River. This restoration work will benefit aquatic species at risk such as the Rocky Mountain Ridged Mussel and COSEWIC-assessed species like Chinook Salmon. Restoration work included the construction of two riffles with boulders, the removal of a dam structure and revegetation of the riverside.

Scaling Real-Time Marine Mammal Observation With Integrated AI and Drone Technology for Marine Megafauna Species at Risk

The goal of this three-year project is to augment the capabilities of [Marine Mammal Observers](#) (MMO's) through the use of innovative drone technology and artificial intelligence (AI). In 2024, the department collaborated with [Edgewise Environmental](#) to gather expertise and integrate their advice in the training of MMOs, using the first version of their AI system called “Möbius”. [Whale Seeker](#) and Edgewise conducted beta tests of the AI system and have compiled feedback for their updated version of “Möbius”. This new version will be tested in the field and refined in 2025. The objective of this project is to place Canada in the forefront of real-time marine mammal detection.

Turning the Tide for Atlantic Whitefish and Inner Bay of Fundy Atlantic Salmon in Nova Scotia, Dalhousie University

In 2024, Dalhousie University continued their CNFASAR project (2023–2026) using acoustic telemetry tracking tools to observe two SARA-listed endangered species in Nova Scotia: Atlantic Whitefish in the Petite Rivière watershed and iBoF Atlantic Salmon in their marine habitat. Project activities include implanting acoustic transmitters in Atlantic Whitefish being maintained for conservation purposes in the Dalhousie University Aquatron, and Atlantic Salmon from the DFO Coldbrook Biodiversity Facility. As part of the work in 2024, tagged Atlantic Whitefish were released into their native watershed and tracked. The movement data is contributing to the understanding of habitat use and will help inform the selection of translocation sites in non-native watersheds, which is a key recovery measure for the species. IBoF Salmon kelts were also acoustically tagged, released and tracked in 2024, to leverage the unique and extensive system of acoustic telemetry arrays currently present in the Bay of Fundy. The salmon tracking work is helping to fill key knowledge gaps related to marine threats and movements in that environment. As part of the project, a series of videos highlighting project activities were produced and shared in 2024 to garner further interest and support for their conservation.

Reducing Threats to Aquatic Species at Risk In Waters of the South Coast of Newfoundland

Quebec-Labrador Foundation (QLF) is conducting a four-year (2023–2026) project in waters of the South Coast of Newfoundland and Labrador with a goal to reduce mortality to aquatic species at risk resulting from fishing interactions and to contribute to the recovery of species at risk, including the North Atlantic Right Whale and South Newfoundland Atlantic Salmon. This builds upon the success of a previous CNFASAR project, where the project team conducts “dockside dialogues” with harvesters to encourage compliance with recovery measures and voluntary stewardship actions, such as reporting incidents of entanglement or strandings, live release of Wolffish, and reduction and diversion of plastic marine debris. Through collaborative work with towns, harvesters, and harbour authorities, procedures for the collection and removal of fishing-related waste—such as bait box liners—are being implemented. QLF also works in partnership with local towns and stewardship groups to encourage reporting of salmon poaching, adoption of best practices for recreational fishing, and reduction of river pollution and waste through the posting of salmon stewardship signage. Education and outreach are essential components to the success of the project, delivering information, motivating positive actions, and encouraging sustained stewardship of South Coast marine waters and in-stream habitats for aquatic species at risk. The project has earned praise from fish harvesters and each year a rising number of harvesters adopt the practice of returning plastic waste. To date, 123,062 bait box liners have been prevented from entering the ocean.

Enhanced Nature Legacy

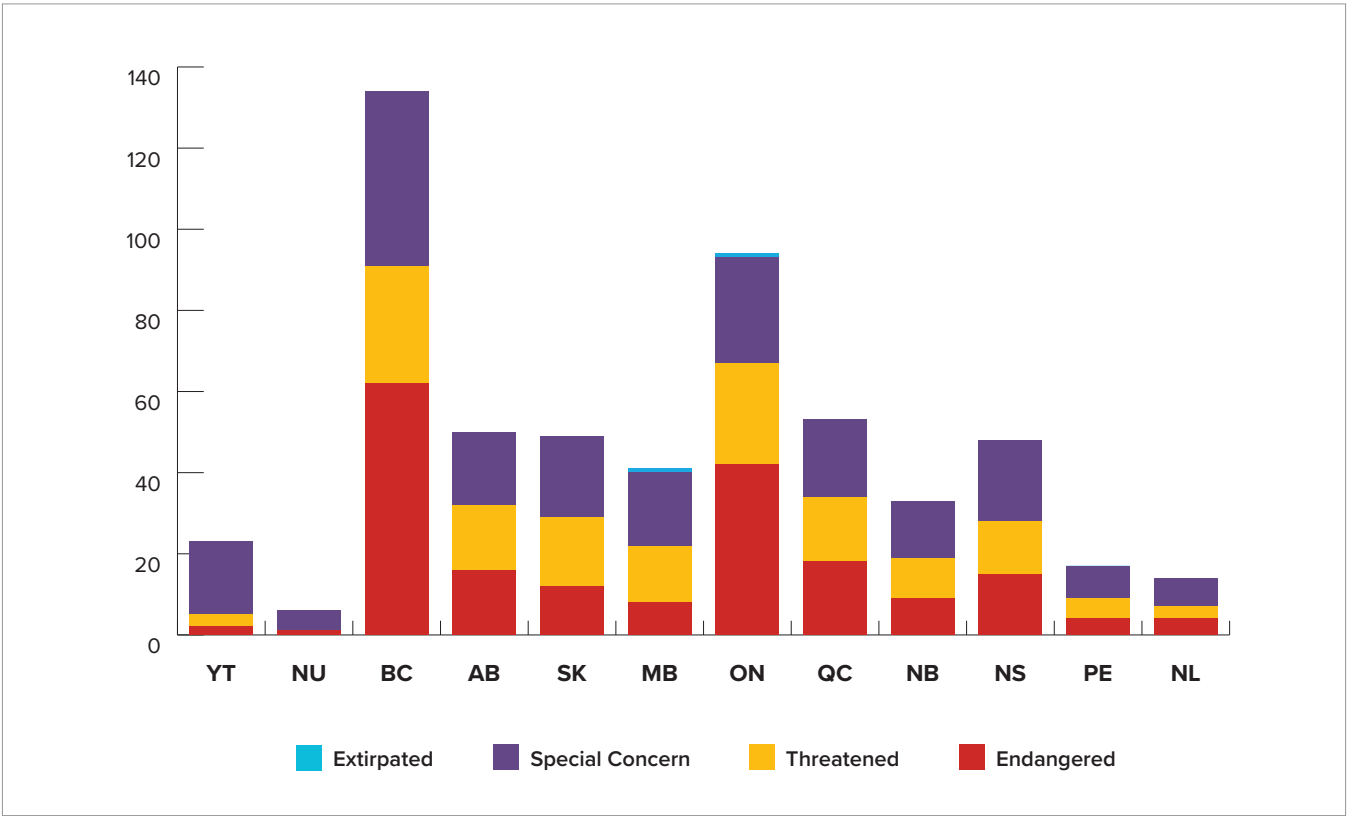
Through the Enhanced Nature Legacy (ENL) initiative, the Government of Canada has advanced conservation efforts that directly contribute to the protection and recovery of species at risk.

A core focus of this work is the implementation of the *Pan-Canadian Approach to Transforming Species at Risk Conservation in Canada* ([Pan-Canadian Approach](#)), which advances SARA recovery efforts by investing in actions in areas where they can have the greatest impact through targeted work in Priority Places, for Priority Species, and across Priority Sectors where cumulative threats can be addressed.

Priority Places

Priority Places and Community Nominated Priority Places (CNPP) have significant biodiversity, high concentrations of species at risk, and opportunities to advance conservation efforts. In 2024–2025, the federal government invested \$37.8 million in 159 projects in [Priority Places](#) and CNPP, with additional funding leveraged through matching funds from partners. The projects are being carried out in 12 Priority Places identified collaboratively by federal, provincial and territorial governments and in 17 CNPPs that were identified through open calls for applications. CNPPs must have multiple species at risk residing within them.

Examples of projects supporting the Priority Places objectives in 2024–2025 include:

- Conducting habitat management activities by installing infrastructure (e.g., fencing and signage) to mitigate road mortality of species at risk amphibians and reptiles and undertaking a coordinated approach to outreach and communications between partners and the general public in the Long Point Walsingham Forest Priority Place in Ontario
- The securement and permanent protection of private land containing habitat, and in particular critical habitat, for multiple species at risk within the Kespukwitk/Southwest Nova Scotia Priority Place. The project also supports targeted outreach and education for private landowners with habitat for species at risk on their properties
- Native prairie habitat enhancement and securement through beneficial management practices implementation, continued delivery of species at risk habitat securement and continued species at risk baseline and monitoring surveys to guide range management plan development and beneficial management practices implementation in the Southwest Manitoba Priority Place

PC is responsible for protecting and managing the ecosystems found in national parks. National parks overlap with six Priority Places allowing for collaboration with partners to maximize landscape-scale conservation benefits for multiple species at risk. PC is also a key partner in at least five CNPP initiatives across the country.

Priority Species

In 2024–2025, the [Priority Species](#) initiative invested \$54 million in 35 projects across Canada, expected to leverage an additional \$42.2 million. These investments support on-the-ground conservation actions for the six Priority Species at risk identified through the Pan-Canadian Approach: Barren-ground Caribou (including the Dolphin and Union population), Peary Caribou, Boreal Caribou, Southern Mountain Caribou, Wood Bison and Greater Sage-grouse. Delivered by 24 unique funding recipients, these projects made significant contributions to the recovery of these at-risk species, notably:

- Collection of population size and trend data that show as of 2024, there are more Southern Mountain Caribou subpopulations that are stable or increasing in size than are decreasing.
- Implementation or development of 23 range plans for Boreal Caribou ranges.
- Completion or implementation of 90% of actions for Wood Bison recovery in Canada.
- Support to successful collaboration, leadership and knowledge sharing, such as the Ronald Lake Buffalo Herd Cooperative Management Board
- Engagement of 37 Indigenous communities through activities such as sponsored workshops and community meetings, and the provision of direct funding to support recovery activities.
- Dismantlement or reforestation of at least 40 kilometers of roads and other linear features, restoration of over 50 ha of crucial habitat for Priority Species, and securement of a minimum of 2,000 ha of land for conservation.

All six of the Priority Species occur across PC-administered places. PC continues to advance work that supports the recovery of these species:

- **Wood Bison**—Promising testing of a recombinant vaccine (bovine tuberculosis and brucellosis) may yield a safe and effective oral vaccine for protecting Wood Bison against exotic bovine diseases. These results inform bison management to improve genetic diversity and recovery of the species.
- **Southern Mountain Caribou**—Construction of the Caribou Conservation Breeding Centre is now complete, and Jasper National Park anticipates welcoming its first caribou in 2025. An Indigenous Advisory Committee has been established, and several Indigenous Partners are supporting caribou through ceremonies and collecting lichen for the captive caribou.
- **Greater Sage-grouse**—Eight km of fence has been marked in critical habitat for Greater Sage-grouse to increase visibility of fence wires and reduce risk of mortality due to collisions of the species with fence lines.
- **Boreal Caribou**—Active investigation and work are underway to improve habitat quality and connectivity for Boreal Caribou in Pukaskwa National Park. Collaboration with partners (Government of Ontario, Indigenous nations) to support the recovery of Boreal Caribou in the Lake Superior Coast Range continues.

Priority Sectors

The Priority Sectors initiative aims to advance the protection and recovery of species at risk by enhancing beneficial practices and addressing threats by mitigating, minimizing, or avoiding harmful practices. ECCC is collaborating with partners and stakeholders across the agriculture, forest and urban development sectors to develop Strategic Conservation Frameworks for species at risk in those sectors.

In 2024, significant progress was made in advancing work with all three sectors, including:

- Forest Sector Framework is progressing, with indicators of forest health being developed to support monitoring of the effects of forest operations on species at risk and their habitat.
- Urban Development Sector Framework is well underway, and a tool has been launched nationally to support municipalities in incorporating species at risk considerations in natural asset evaluation and management.

Indigenous Partnerships Initiative

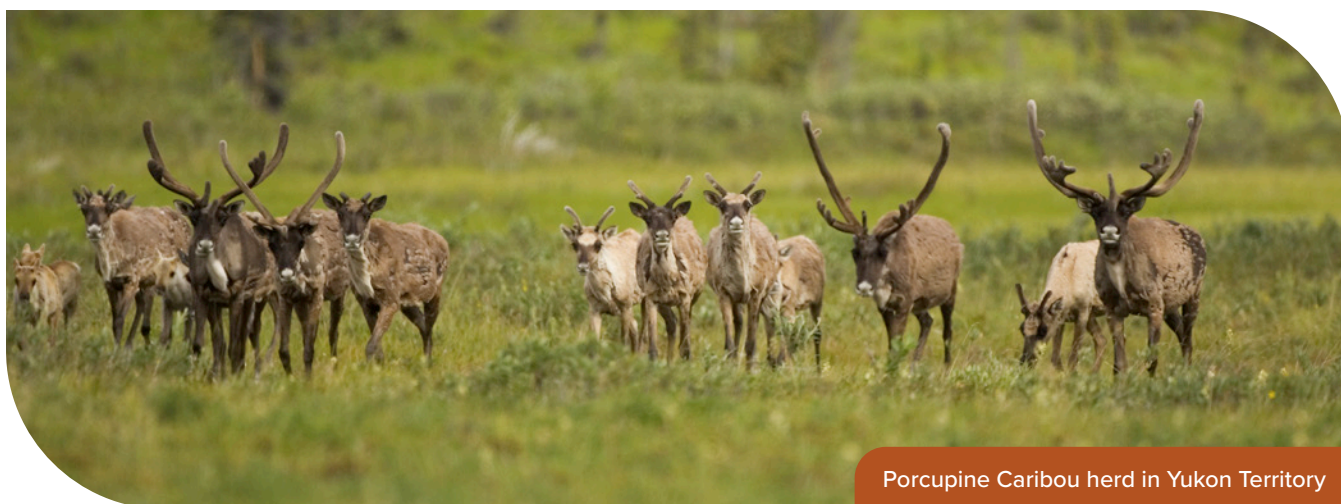
The Indigenous Partnerships Initiative (IPI) amplifies the leadership of First Nation, Inuit and Métis partners in the conservation of species at risk and culturally significant species in a manner that reflects Indigenous peoples' unique priorities, rights and knowledge in the implementation of the Pan-Canadian Approach and SARA.

In 2023–2024 fiscal year, IPI provided \$21.5 million to 32 new and 83 previously approved multi-year projects (115 total). The initiative leveraged additional funds that exceeded \$6 million (cash and in-kind) and supported 103 Indigenous governments, communities, and organizations. Projects implemented recovery actions for priority species such as Boreal Caribou and Southern Mountain Caribou, supported conservation action for priority threats such as wildlife health (e.g., chronic wasting disease), and leveraged Indigenous knowledge to direct stewardship strategies. The IPI has also been instrumental in establishing a mechanism to more effectively meet the many consultation obligations under SARA.

Framework for Aquatic Species at Risk Conservation

DFO developed the Framework for Aquatic Species at Risk Conservation to identify opportunities where use of multi-species approaches may improve the conservation and recovery of aquatic species at risk listed under SARA and provide considerations for applying these approaches.

In 2024, DFO incorporated the feedback from external engagement conducted in 2023 and aims to publish the Framework in August 2025. The Framework will serve as a policy guide for applying collaborative, evidence-based and multi-species approaches to conserve and recover aquatic species at risk at DFO.

5. Agreements and Collaboration

Conservation Agreements

Implementation of conservation measures continued in 2024 under nine previously signed SARA section 11 conservation agreements for Boreal Caribou and Southern Mountain Caribou in the Northwest Territories, the Yukon Territory, British Columbia, Alberta, Saskatchewan, Manitoba, and Ontario. These agreements include measures, such as habitat protection, habitat restoration, population management, monitoring, and commitments to develop and implement range plans or similar landscape-level plans.

The section 11 agreement with the Northwest Territories was amended in March 2024, to extend its term to September 15, 2026. This additional time allows the governments of Canada and the Northwest Territories to conclude the work originally set out in the agreement.

Investments from the Priority Species initiative supported SARA section 11 agreements, notably by providing \$1.45 million in new commitments to the Government of the Northwest Territories for Boreal Caribou, and \$1.46 million in new commitments to the province of Alberta for Wood Bison.

In 2024, DFO renewed a five-year Conservation Agreement with Transport Canada, the Vancouver Fraser Port Authority, and six marine transportation industry associations to mitigate the impacts of acoustic and physical disturbance from large commercial vessels on endangered Southern Resident Killer Whales (SRKW). The Agreement promotes and coordinates voluntary, seasonal slowdowns and altered transit paths by ships for the benefit of SRKW, as well as collaborative research, innovation, education, and outreach relating to shipping impacts on at-risk whales.

In 2024, DFO's Pacific region signed a Memorandum of Understanding with the Government of British Columbia under the 2005 *Canada-BC Agreement on Species at Risk* to support the recovery of freshwater species at risk in British Columbia.

DFO continues to work with the Cree Nation Government (CNG) under the Conservation Agreement signed in April 2022, pursuant to section 11 of SARA for the conservation of Lake Sturgeon (southern Hudson Bay - James Bay populations), a species of Special Concern under SARA. The agreement and ongoing efforts recognize the essential role and leadership of the Cree nation for the successful conservation of this species. Since the signing of the agreement, a working group composed of members of DFO and the CNG has been working on its implementation.

In 2024, the *Cree-led threat management plan for the conservation of Lake Sturgeon/ Nameu (ᓇᓴᓴᓴ)/Nimaau (ᓄᓴᓴᓴ)/ Name (NAME) in the James Bay Northern Quebec Agreement Territory* was completed. It will form an integral part of the SARA management plan scheduled for final publication in 2025. In 2024, DFO and the CNG began negotiating a new conservation agreement under Section 11 of SARA to oversee implementation of the management plan in Cree territory, under the leadership of the CNG. The entire initiative is funded under the Canadian Endangered Species Fund.

On March 5, 2025, Canada, BC and the First Nations Leadership Council released the [first annual report](#) on activities under the *Tripartite Framework Agreement on Nature Conservation*, detailing progress made up to March 2024.

Nature Agreements

To meet the challenges associated with the biodiversity and climate crisis, [Nature Agreements](#) establish shared priorities and financial commitments in a collaborative manner, from the perspective that collaboration between Canada, provinces, territories, and Indigenous partners is central to protecting a wide array of natural ecosystems. These agreements continue to be a promising tool for advancing nature conservation priorities in Canada, including area-based conservation and species at risk, while building relationships between federal, provincial, territorial, and Indigenous partners.

In 2024, under the *Canada-Yukon Nature Agreement*, progress made by the Government of Yukon related to species at risk includes:

- leading ecological research and monitoring in the Aullaviat/Aunguniarvik Conservation Area, focusing on Porcupine Caribou habitat and range shifts identified by the Inuvialuit
- completing surface disturbance mapping in the Northern Tutchone and Kaska regions, including key caribou herd ranges, and acquired new satellite imagery for land-use planning in the Dawson and Nacho Nyak Dun areas
- establishing a two-year funding agreement with the Council of Yukon First Nations to support Indigenous collaboration in developing approaches for species at risk management and ecological cumulative effects assessment
- conducting monitoring and research on 16 of 26 Northern Mountain Caribou herds, as well as on other key species including Collared Pika, Wolverine, Grizzly Bear, and Little Brown Myotis

Through the [Canada-Nova Scotia Nature Agreement](#), in 2024, the Government of Nova Scotia:

- established governance bodies and working groups to support recovery planning, monitoring, and habitat identification for species at risk
- launched a cross-departmental initiative to develop guidance for species at risk and migratory birds, aligning with legal and policy frameworks. The work includes regulatory assessments with respect to effective protection and sector-specific guidance for reptiles, aerial insectivores, shorebirds, and key migratory species such as Bicknell's Thrush, Piping Plover, and Bank Swallow.

6. Governance

National Aboriginal Council on Species at Risk

As per section 8.1 of the Act, the National Aboriginal Council on Species at Risk (NACOSAR) advises the Minister on the administration of the Act and provides advice and recommendations to the Canadian Endangered Species Conservation Council (CESCC). While CESCC is not currently formally established, the participating Ministers meet regularly.

The NACOSAR had a two-day in-person meeting and met virtually several times over the year. Key discussion topics included how to best respond to community requests in general and several in particular, the role of the Council and how to ensure knowledge, and the operating conditions necessary to enable the effective work of the NACOSAR. The Minister and officials from ECCC, DFO, and PC attended parts of an in-person May 27–28, 2024 meeting. At that meeting, the NACOSAR raised the importance of additional policy and research support for the Council to enable the development of impactful and effective solutions and the Minister expressed interest in receiving a proposal. The NACOSAR also shared its view that SARA is not being used as a risk management tool as originally intended, particularly as it relates to infringements of Aboriginal and treaty rights. The NACOSAR flagged its potential role in helping ensure that the impacts on Indigenous peoples are appropriately measured and considered.

Nature Advisory Committee

At their June 2024 meeting, a multi-interest Nature Advisory Committee was asked for advice on broadening engagement on ECCC's work to develop and implement Strategic Conservation Frameworks to guide species at risk management in priority sectors in Canada, including the agriculture, forestry, and urban development sectors. Committee members advised on the importance of early and sustained engagement with partners across sectors, coordination among federal departments, and the opportunity to advance collaborative, integrative, and bottom-up approaches. Members expressed interest in remaining engaged in the further development of the Strategic Conservation Frameworks.

Indigenous Nature Tables

Three distinctions-based Indigenous Nature Tables were launched; these co-developed tables contribute to the development and provision of strategic advice and innovative solutions on shared nature priorities, including species at risk. The First Nations Nature Table discussed species at risk, including information-sharing on ECCC, DFO and PC species at risk related programming and highlighted the importance of advancing First Nations leadership through SARA. The Strawberry Moon Table on Nature emphasized the value species at risk programs have in supporting Métis nature priorities and contributing to halting biodiversity loss. The Inuit Nature Table expressed interest in having future Table conversations on species and conservation.

Species at Risk Public Registry

The online Species at Risk Public Registry fulfills the requirement under SARA for the Minister to establish a public registry to facilitate access to SARA-related documents. The Registry is an important tool for engaging and informing Canadians on species at risk issues. In addition to providing access to documents and information related to SARA, it provides a forum for Canadians to submit comments on SARA-related documents being developed by the Government of Canada.

Section 123 of SARA identifies documents that must be published on the Registry, including:

- regulations and orders made under the Act
- agreements entered into under section 10 of the Act
- COSEWIC's criteria for the classification of wildlife species
- status reports on wildlife species that COSEWIC has prepared or has received with an application
- the List of Wildlife Species at Risk
- codes of practice, national standards or guidelines established under the Act
- agreements and reports filed under section 111 or subsection 113(2) of the Act, or notices that have been filed in court and are available to the public
- all reports made under sections 126 and 128 of the Act

Other documents prepared in response to the requirements of SARA including recovery strategies, action plans, management plans, permit explanations, and reports on the progress of recovery document implementation are also required to be published on the Public Registry.

In 2024, 550 documents were published on the Public Registry, including 399 permit explanations and 48 documents for public consultation. These documents also include SARA and COSEWIC annual reports, consultation documents, COSEWIC status reports and status appraisal summaries, ministerial response statements, and recovery documents.

7. Notices, Orders and Imminent Threat Assessments

The federal government is responsible for critical habitat protection for all species at risk on federal lands.

Species at risk critical habitat in federal protected areas is protected 90 days after a description of the critical habitat is published in the *Canada Gazette*. In 2024, two critical habitat descriptions were published in the *Canada Gazette* providing protection for two species at risk in one national park, one national urban park and two national wildlife areas..

Protection Orders for Critical Habitat

Protection of critical habitat for aquatic species and all other species on federal lands other than in federal protected areas are protected either by a Ministerial protection order or, where the critical habitat is already protected, by publishing a statement in the Species at Risk Public Registry on how that critical habitat is protected.

In 2024, the Minister of Fisheries repealed and replaced a ministerial order to protect critical habitat for the aquatic species at risk, White Sturgeon, Nechako River Population in collaboration with PC.

Emergency Orders and Imminent Threat Assessments

Under section 80 of SARA, the GIC may, on the recommendation of the competent Minister, make an emergency order to provide for the protection of a listed wildlife species no matter where it occurs in Canada.

To improve the transparency of the imminent threat assessment process, in October 2024, the Government of Canada posted the final [Policy on Assessing Imminent Threats under Sections 29 and 80 of the Species at Risk Act –terrestrial species](#) as well as the [Operational guide: requesting an imminent threat assessment for terrestrial species under the Species at Risk Act](#) on the Species at Risk Public Registry.

In May 2024, the Minister of the Environment formed the opinion that the Caribou (*Rangifer tarandus*), Boreal population (i.e., Boreal Caribou) is facing imminent threats to its recovery, based on an assessment of populations in Quebec, and was therefore required under SARA to recommend the making of an emergency order. The Government of Canada directed the Minister to proceed with the development of a potential emergency order to protect portions of Boreal Caribou habitat within or adjacent to the three most at risk ranges in Quebec (Val-d’Or, Charlevoix, and Pimpuacan), and to prohibit activities that may adversely affect the species and its habitat. A public comment period on the proposed order took place between June 19 and September 15, 2024.

An updated Imminent Threat Assessment for the SRKW was undertaken by DFO and PC, in consultation with ECCC and Transport Canada. On November 29, 2024, the Minister of Fisheries, and the Minister of the Environment, as the Minister responsible for the Parks Canada Agency, announced that they had formed the opinion that SRKW continues to face imminent threats to its survival and recovery and confirmed three key threats to the population: acoustic and physical disturbance, reduced prey availability, and environmental contaminants.

Given that opinion, the Ministers were required to recommend an emergency order. After careful consideration, the Government of Canada declined to make an Emergency Order for the protection of SRKW. Instead, the Government of Canada proposed additional actions to address threats to SRKW that build on existing measures. 8. Permits under SARA

Permits are required for activities that may affect species listed on Schedule 1 of SARA as Extirpated, Endangered, or Threatened, and where the activities contravene the Act's prohibitions or protection orders, wherever these apply. The competent minister may enter into an agreement or issue a permit under section 73 of SARA for the following:

- scientific research related to the conservation of a listed species, and conducted by qualified persons
- activities that benefit a listed species or are required to enhance its chance of survival in the wild
- activities that incidentally affect a listed species

Under section 74, an agreement, permit, licence, order or other similar document authorizing a person or organization to engage in an activity affecting a species at risk authorized by the competent minister under another Act of Parliament can have the same effect as an agreement or permit under section 73 of SARA if the requirements of section 73 are met. These documents or authorizations are considered “SARA-compliant”.

ECCC issued 98 permits under section 73 to allow for activities affecting over 50 species, including reptiles, amphibians, birds, vascular plants, arthropods, molluscs, and mammals.

Of the 98 permits⁴ issued:

- 22 allow for scientific research related to the conservation of a species
- 30 allow for activities benefiting a species or required to enhance its chance of survival in the wild
- 66 allow for activities incidentally affecting a species

Twelve of these permits were issued for activities carried out in an area affected by an emergency order. ECCC also issued 314 SARA-compliant permits affecting, or with the potential to affect, Threatened and Endangered migratory bird species under the *Migratory Birds Convention Act*, 1994.

PC issued a total of 42 permits, 17 of which were SARA-compliant permits issued under the *Canada National Parks Act*.

⁴ The total number of permits per type is greater than the total number of permits issued (98) as 20 permits covered more than one purpose.

Of the 42 permits issued:

- 15 were for scientific research related to the conservation of a species
- 8 were for activities benefiting a species or required to enhance its chance of survival in the wild
- 18 were for activities incidentally affecting a species
- 1 was for activities that benefited one species and incidentally affected a different species

DFO issued a total of 230 permits under section 73 of SARA in 2024. Of these 230 permits:

- 58 were for scientific research related to the conservation of an aquatic species
- 29 were for other activities that benefit the species or enhance its chance of survival in the wild (for example, monitoring surveys or marine mammal rescue)
- 143 were for activities that incidentally affected the listed species (including accidental capture while undertaking research on other non-listed species, or fish or mussel relocation during construction activities)

DFO issued a total of 23,605 licences under the *Fisheries Act* that also acted as SARA permits under section 74. of these licences:

- 23,529 were commercial fishing licences where incidental catches of White Shark, Basking Shark and Loggerhead Sea Turtles were recognized to be a possibility. Conditions in these fishing licences require mandatory reporting of any species interactions in logbooks, and subsequent release of species back into the water in the manner that causes the least harm. These licences fit under the purpose of SARA s. 73(2)(c)
- 39 fishing licences for experimental, scientific, and educational purposes under section 52 of the *Fishery (General) Regulations*. These licences fit under the purposes of SARA s. 73(2)(a) or (c)
- 12 authorizations under section 38 of the *Marine Mammal Regulations* for disturbances caused in the conduct of beneficial work. These licences fit under the purposes of SARA s. 73(a) or (b)
- 25 authorizations under paragraph 35(2)(b) of the *Fisheries Act* that have the same effect as SARA permits. These permits fit under the purpose of SARA s. 73(2)(c).

9. Enforcement

ECCC, PC, and DFO have federal enforcement programs to protect individual SARA-listed species, their residences and their critical habitat when subject to an order, by verifying and securing compliance with SARA's requirements. They work jointly and in partnership with Indigenous, provincial, territorial, and international authorities.

ECCC

To verify compliance with SARA, in 2024 ECCC had 80 wildlife enforcement officers conducting inspections, investigations, and permit verifications across Canada.

ECCC wildlife enforcement officers carried out the following SARA-related enforcement activities in 2024:

- conducted 404 inspections
- issued 4 warnings
- opened 17 new investigations

In 2024, ECCC wildlife enforcement officers continued to employ a risk-based approach for enforcement planning and conducted compliance verification of prohibited activities for SARA-listed species, including, among others: American Badger, bats (Little Brown Myotis, Northern Myotis, Tri-coloured), bees (Gypsy Cuckoo Bumble, Western Bumble Bee), birds (Bank Swallow, Barn Owl, Burrowing Owl, Chimney Swift, Ferruginous Hawk, Lewis's Woodpecker, Greater Sage-grouse, Whooping Crane, Meadowlark), Butternut trees, Eastern Wolf, Fernald's Braya, Monarch Butterfly, snakes (various), turtles (Blanding's Turtle, Spiny Softshell, Spotted Turtle, Western Painted Turtle, Wood Turtle), Western Chorus Frog, Western Tiger Salamander.

PC

PC has approximately 85 operational park wardens dedicated to law enforcement activities in all PC-administered places. In 2024, a total of 93 law enforcement incidents were recorded that relate to the protection of species at risk in protected heritage areas. In 2024, park wardens did not issue any charges or warnings under the Act. Under other associated legislative powers, a total of 17 charges and 92 warnings were issued in 2024 in support of protecting species at risk.

PC continued efforts with DFO, Transport Canada, ECCC, and other partners, to protect the SRKW. At Gulf Islands National Park Reserve and Pacific Rim National Park Reserve, Transport Canada's Interim Order is in effect along with associated measures, as well as DFO Seasonal Based Closures related to the SRKW recovery measures. Park wardens dedicated 522 hours in proactive patrols for the protection of SRKW and 78 hours in response to incidents. There were 64 reactive occurrences recorded throughout 2024 that resulted in 8 charges and 27 warnings as it relates to the protection of the SRKW.



DFO

DFO's enforcement actions for species at risk are carried out by fishery officers who have been trained and designated as enforcement officers under SARA. They incorporate SARA enforcement activities alongside their duties under the *Fisheries Act* and other federal statutes and regulations. In 2024, DFO's fishery officers:

- dedicated over 23,398 hours to patrols, inspections, investigations, court cases, public relations and other duties related to enforcing the prohibitions of SARA
- initiated approximately 175 investigations, devoting over 2,424 hours specifically to investigative work related to species at risk
- recorded a total of 175 SARA-related violations, resulting in a range of enforcement actions including education, warnings and charges

9.1. Prosecutions

ECCC

In 2024, ECCC's wildlife enforcement officers initiated 5 prosecutions and concluded 4 prosecutions under SARA totaling \$110,000 in penalties.

Two Quebec residents fined a total of \$10,000 for violating the *Species at Risk Act* — May 9, 2024 —
Longueuil, Quebec

A Quebec company was fined \$12,500 for destroying nests of Bank Swallows, a Threatened species —
July 4, 2024 — Sainte-Anne-des-Monts, Quebec

On July 4, 2024, Les Entreprises Énia Lafontaine was ordered to pay a fine of \$12,500. The company pleaded guilty to one count of violating SARA. The company used heavy machinery to excavate, and damaged or destroyed Bank Swallow nests in a sandpit.

Landscaping company 9242-6451 Québec inc. and its owner were ordered to pay a total fine of \$12,500 for violating the *Species at Risk Act* — November 15, 2024 —
Longueuil, Quebec

The National Capital Commission was ordered to pay a total of \$75,000 for having violated the *Species at Risk Act* — December 13, 2024 —
Gatineau, Quebec

On December 12, 2024, the National Capital Commission (NCC) pleaded guilty to violating SARA. The charge stems from actions that contravened a condition of a permit issued under the Act to develop a bicycle path in the Western Chorus Frog's habitat in Leamy Lake Park, Gatineau. The contravention concerned the deposit of rock dust in the Western Chorus Frog's habitat during the work that was carried out, which resulted in damage to critical habitat of the Western Chorus Frog. The NCC was ordered to pay a fine of \$50,000 to the Receiver General for Canada and \$25,000 to the Government of Canada's Environmental Damages Fund. The NCC was also ordered to carry out remedial work to repair the damage caused to the Western Chorus Frog's critical habitat.



DFO

In 2024, Pacific region fishery officers laid two charges under SARA, resulting in one conviction.

To support the recovery of SARA-listed species in Pacific Region, fishery officers continue to work closely with the Public Prosecution Service of Canada on several investigations involving SARA-listed marine mammals. In August 2021, witnesses observed a wildlife documentary crew operating a low-flying drone hovering roughly a meter above Northern Resident Killer Whales near Robson Bight, British Columbia and reported it to DFO. Northern Resident Killer Whales are listed as Threatened under SARA. DFO Fishery Officers from the Whale Protection Unit in Pacific Region conducted an investigation that resulted in the prosecution of the film company for disturbing marine mammals prohibited under the *Marine Mammal Regulations*. Charges under SARA were not pursued in this case. The trial concluded in 2024 with River Roads Films and the two drone operators found guilty of disobeying the federal regulation that protects killer whales and other marine mammals. River Road Films was fined \$25,000 and the two drone operators received a total of \$7,500 in fines for their involvement.

10. Monitoring and Reporting

10.1. Monitoring

Monitoring of wildlife species provides the scientific foundation for all aspects of the species at risk program, from assessment and recovery planning, to implementing and evaluating the effectiveness of conservation actions. Monitoring also provides information on trends for both the distribution and population size of species, which are key indicators in the COSEWIC assessment process.

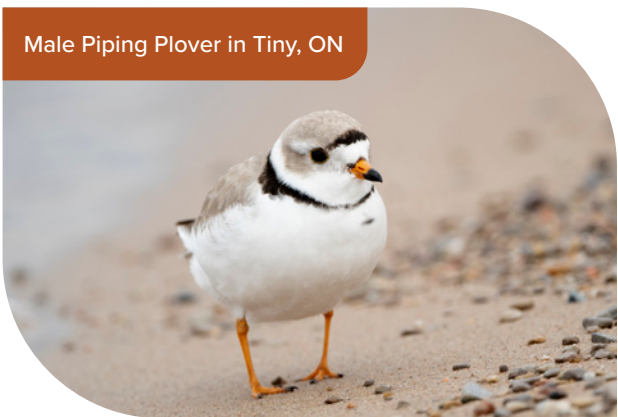


Figure 6. Population change since 1970 for 10 avian groups of conservation concern

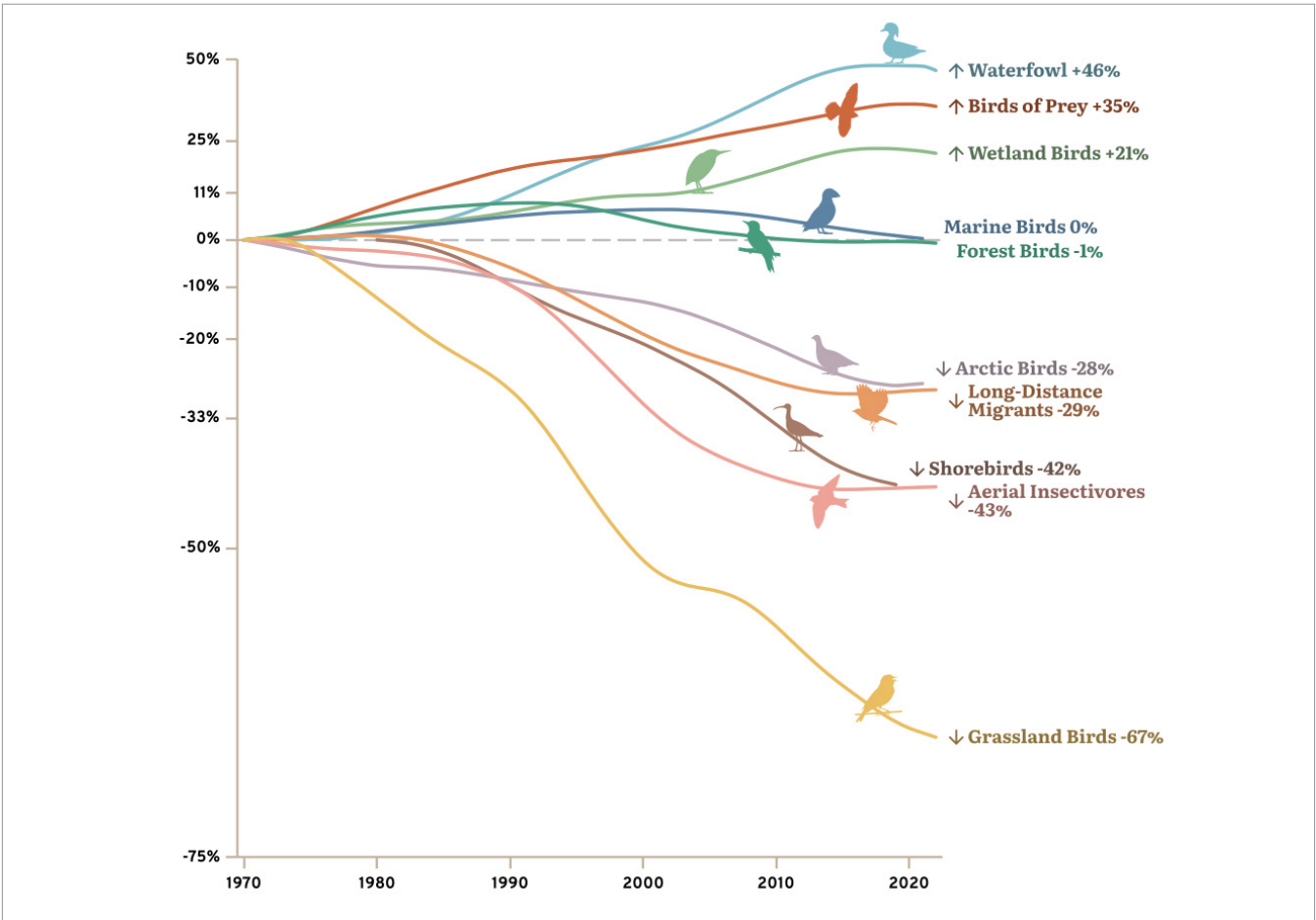

ECCC

ECCC manages and coordinates, together with key partners, national scale monitoring programs for all species of migratory birds in Canada, as well as regional programs for other selected wildlife species at risk. Some of these concentrate on describing critical habitat, such as quantifying occupancy, abundance, productivity, foraging, and/or breeding evidence at important sites and/or habitats. The programs include the [North American Breeding Bird Survey](#), provincial and regional [Breeding Bird Atlases](#), and Arctic shorebird breeding surveys. Data from many of these programs are made publicly available through the [NatureCounts](#) data platform hosted by Birds Canada.

In Focus: Acoustic Monitoring of Species at Risk

ECCC is leading a collaborative project to monitor grassland bird species at risk in the [Prairie Pastures Conservation Area](#) (PPCA, also known as Govenlock, Nashlyn, and Battle Creek pastures) in southwestern Saskatchewan using Autonomous Recording Units (ARUs). The PPCA is a large, contiguous tract of native prairie grassland home to numerous species at risk, including Chestnut-collared Longspurs, Sprague's Pipits, Burrowing Owls, and Greater Sage-grouse. ARUs have been deployed throughout the PPCA to record birdsong since 2017. Recordings are then transcribed by human listeners to estimate species diversity and abundance. By monitoring changes in abundance over time, ECCC is determining the stability of species at risk populations in this important conservation area. Monitoring also helps ensure that sustainable cattle grazing supports habitat conservation for migratory birds. The PPCA has also used ARUs to monitor Greater Sage-grouse lek sites since 2016. Regional staff have shown that acoustic methods, which include a collaboratively developed workflow for processing ARU data, provide a cost-effective way to detect occupancy at historical lek sites within protected areas.

New in 2024, data from these monitoring programs have been synthesized into the [State of Canada's Birds](#) web platform. This new web platform is delivered in partnership by ECCC and Birds Canada, brings together the best available information on how Canada's birds are doing.

The web platform also provides detailed species accounts for all 463 regularly occurring bird species in Canada, giving population status, trends, goals, and information on distribution and occurrence. This information is a key component of the COSEWIC assessment process, and a way to track the effects of recovery actions for populations of listed species.

In Focus: Automated Nest Monitoring of Whooping Cranes

Since 2019, ECCC has worked collaboratively with PC, the United States Fish and Wildlife Service, and the Wilder Institute to study nest success of endangered Whooping Cranes (*Grus americana*) in Wood Buffalo National Park and adjacent areas of the Northwest Territories. The goal of the work is to determine rates and causes of nest failure to inform population models and management actions to recover one of Canada's rarest birds. Monitoring consists of deploying cameras, video cameras, ARUs, and water level loggers at nest sites during the first week of incubation. Nest fates are determined by reviewing images and videos collected by remote cameras. However, because avian predators, like Common Raven, are not commonly

detected in images, ARUs are used to determine occupancy rates of ravens as a proxy for avian predation risk. Recordings are also used to characterize avian communities in these remote areas, including the presence of other species at risk. To date, nest failure has been due to parental inexperience, avian and terrestrial predators, and storms.

PC

PC monitors various ecosystems indicators and species at risk in the places it administers. In 2024, PC continued to monitor progress towards completing actions and achieving site-based population and distribution objectives that are described in PC multi-species action plans. For example, in 2024, in collaboration with academic and government partners, drones were used to systematically photograph cliff habitat in Forillon National Park, home to about 45 rare and endangered plant species in an under-surveyed remote alpine habitat. AI-assisted technology was then used to aid in species identification.

Piping Plover Recovery: A Monitoring Success

Dedicated monitoring and conservation efforts are helping Piping Plovers make a comeback in Kouchibouguac National Park. From May to August 2024, staff surveyed the park's 25 km coastline every three to five days, tracking breeding pairs, nest activity, and chick development. Nest locations are marked, and productivity data is collected to assess survival rates. Remote cameras provide insight into predation and nest failures.

In addition to monitoring, park staff works to reduce human impact by protecting nesting areas, educating visitors, and promoting responsible beach use. These efforts contributed to a record-breaking 16 fledglings from six pairs in 2024, the highest in seven years. With a fledging rate of 2.67 chicks per pair, well above the national recovery goal of 1.67, the results are encouraging.

By combining monitoring with habitat protection and public awareness, Kouchibouguac National Park is helping secure a future for this endangered shorebird.

DFO

In 2024, DFO advanced ongoing research and monitoring projects for SARA-listed and COSEWIC-assessed species. Species at risk monitoring continues, where feasible, on a priority basis.

For the last seven years, including 2024, DFO Science has carried out a multi-species systematic aerial survey of eastern Canadian waters annually, with a focus on the North Atlantic Right Whale (NARW). The survey includes 20 areas (strata) in eastern Canadian waters, and areas around the Scotian Shelf and Newfoundland are flown on alternate years. The systematic survey supports our understanding of NARW distribution and abundance while also supporting the implementation of dynamic fisheries management measures which protect NARW from entanglement and vessel strikes. In 2024, DFO had a total of 100 sighting events of NARW (121 whales observed including duplicates).

In Focus: New technology expands knowledge of whales in the Atlantic

There are approximately 372 NARWs in the world. DFO leads the identification of NARW in Canadian waters and in 2024, DFO and partner organizations identified 135 individual NARW in Canadian waters.

In addition to aerial surveillance, DFO monitors NARW using acoustic technology, which includes both fixed and moving platforms. In 2024, DFO had a total of nine fixed buoys and a fleet of four autonomous mobile underwater platforms called gliders, all specially equipped with hydrophones for listening to whale calls. Together, these made a total of 2,299 NARW detections in near real-time.

In 2024, in addition to NARW surveillance, DFO held a national peer review meeting to undertake a Recovery Potential Assessment for the NARW. This meeting resulted in the review of 11 papers, all of which will contribute to our understanding of NARW in Canadian waters, including key threats to their recovery, their abundance and distribution, and their prey.

DFO also led research and monitoring activities directed at better understanding the threats to recovery of SRKW and the St. Lawrence Beluga.

In 2024, DFO published a research document on the [Recovery Potential Assessment for the St. Lawrence Estuary Beluga \(*Delphinapterus leucas*\) Population](#). The results suggested that recovery is theoretically feasible, and the probability of achieving it would be greater if some of the current threats to the population, such as factors leading to increased pregnancy-related and calf mortality, can be mitigated. In addition, there were sufficient data to identify important summer (June to October) and winter (January to March) habitat for the population, but not for spring and fall.

In 2024, DFO continued to undertake species at risk monitoring activities, often in collaboration with Indigenous and other non-government partners. Examples in the Maritimes Region include the annual iBoF Atlantic Salmon monitoring in index rivers, the presence and abundance monitoring of larval and juvenile Atlantic Whitefish at established monitoring locations in the Petite Rivière Lakes in Nova Scotia, and the monitoring of Rainbow Smelt springtime spawning streams in Lake Utopia, New Brunswick. In the marine environment, DFO Science from the Maritimes Region continued to undertake acoustic monitoring of White Sharks to gather information on their presence, movements and seasonal occupancy in Atlantic Canadian waters, as well as tagging and monitoring of Leatherback Turtles to better understand their habitat use and migration patterns in Atlantic Canadian waters.

10.2. Reporting

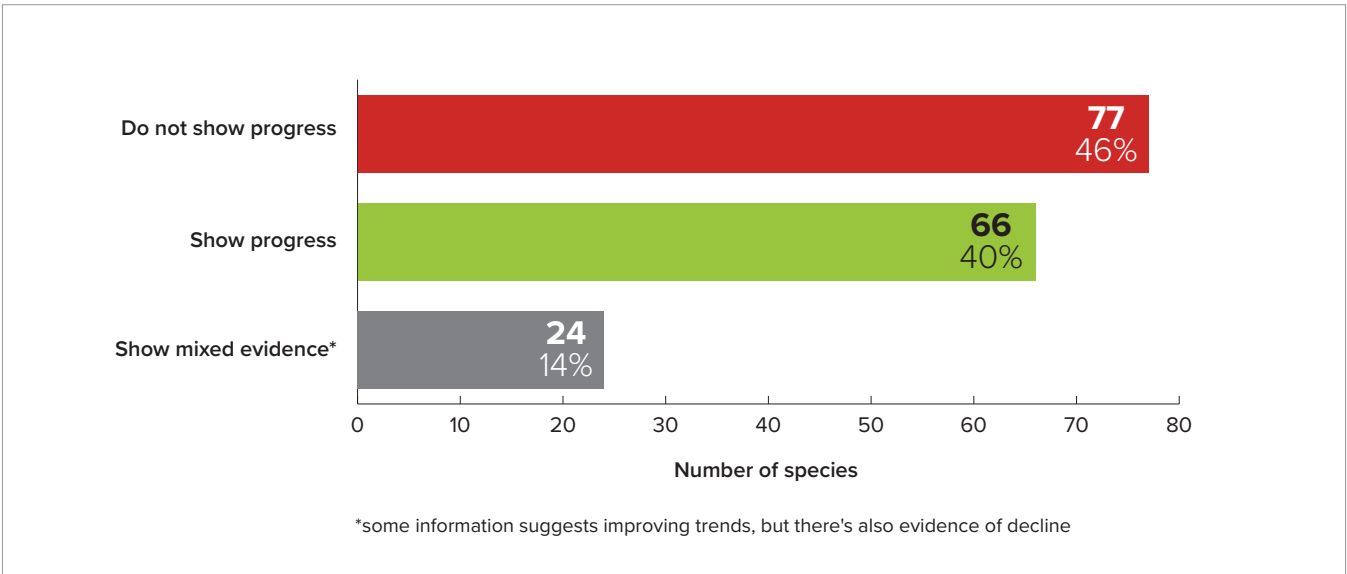
Canadian Environmental Sustainability Indicators for Species at Risk Population Trends

Progress Towards Recovery or Management Objectives

An environmental indicator is a measure that provides information on the state of a particular environmental issue. Tracked over time, indicators can show trends that reflect what is happening in the environment. The Canadian Environmental Sustainability Indicators (CESI) program presents indicators that provide a preliminary assessment of whether the trends for population (how many) and distribution (how they are spread out) of a listed species at risk are, consistent with the recovery or management objectives set out for them in planning documents including recovery strategies, action plans and management plans. Results should not be interpreted as a measure of success regarding the recovery or maintenance of species until sufficient time has passed for species to respond to actions taken, and enough information has been collected for re-assessment.

The graphic below shows the progress towards population and distribution objectives for the 167 species at risk that include population and distribution recovery objectives, and for which trends could be determined.

Figure 7. Progress of Species at Risk Towards Their Population and Distribution Objectives, May 2024

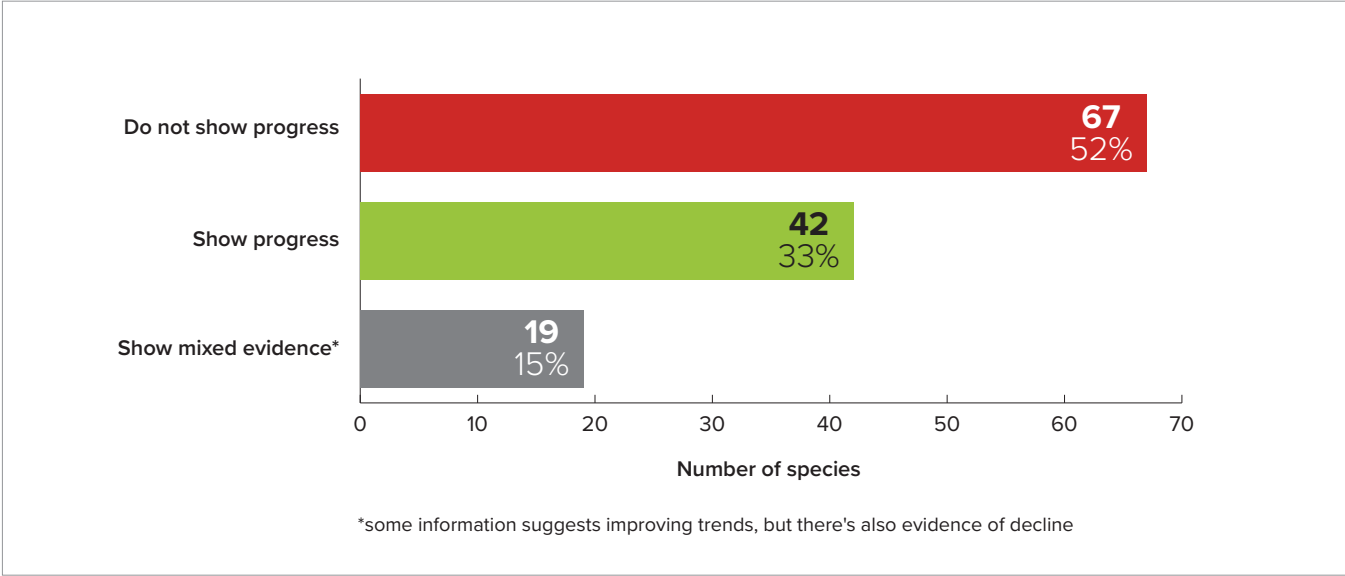

Figure 8. Progress of Extirpated, Endangered and Threatened Species Towards Population and Distribution Objectives, May 2024

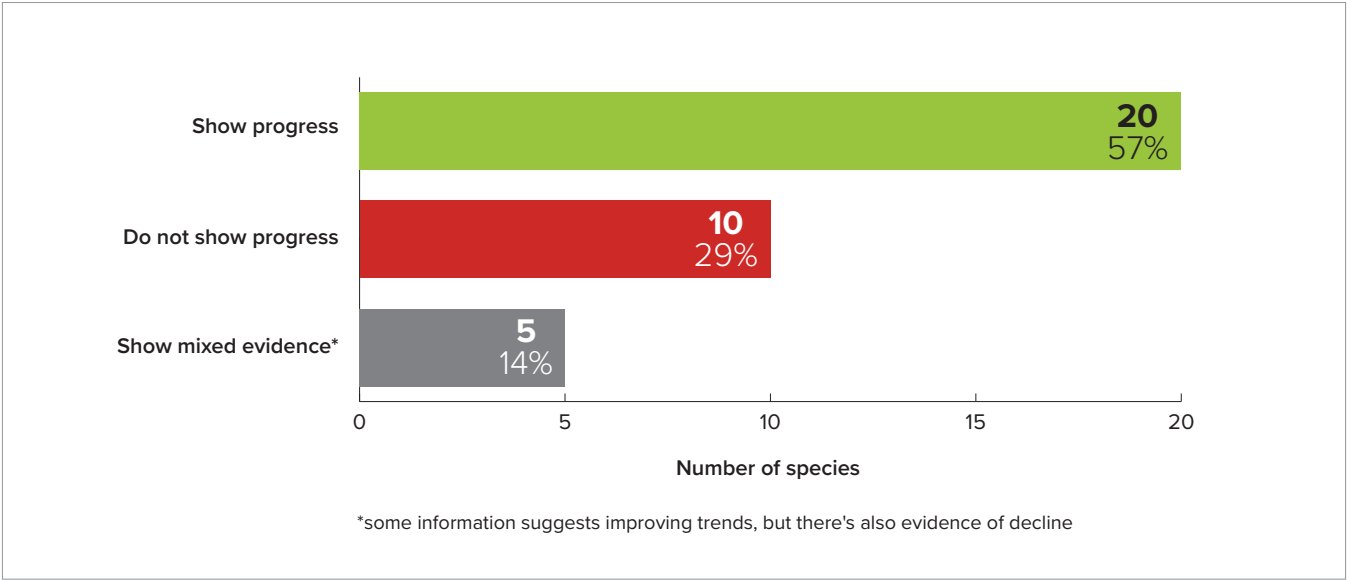

11. Outreach and Education

Education and outreach are important actions frequently undertaken to improve understanding and influence attitudes and awareness about species at risk. The goal of this work is to change behaviors that have negative impacts on species at risk and to boost practices that are beneficial to biodiversity and species at risk.

ECCC

Hundreds of outreach and education activities were carried out by ECCC partners in Priority Places in 2023–2024 to support species at risk recovery, such as:

- education and training activities including workshops on species at risk for land-use professionals, as well as training volunteers to aid in Ribbonsnake and Snapping Turtle surveys
- communicating with beach users to reduce disturbance at Piping Plover nesting beaches
- targeted outreach and education with private landowners with critical habitat for species at risk on their properties, to encourage and explore conservation options to help protect the species and their habitat
- distributing brochures and booklets to increase awareness about target species and their needs, and to encourage the reporting of species at risk sightings, as well as posting social media on species at risk habitat protection and restoration in various ecosystems

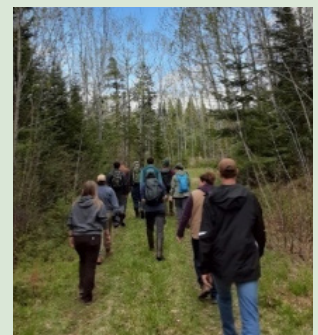

In Focus: Caring for Wildlife Habitat in Wolastoq Private Working Forests

New Brunswick forests of the Wolastoq/Saint John River Priority Place provide significant habitat for many species at risk including Canada Warbler, Wood Turtle, and Wrinkled Shingle Lichen. Through funding provided in part by ECCC, Nashwaak Watershed Association Incorporated, Canadian Parks & Wilderness Society New Brunswick Chapter, and Nature Trust of New Brunswick have partnered to maintain and improve habitat features that support biodiversity. The work involves education and outreach efforts, including guidance materials, workshops, presentations, a social media campaign, and personalized site visits to promote beneficial management practices. Through these engagement events and resources, private forest landholders have been supported to establish riparian buffer zones, avoid activities during key breeding seasons, and apply silvicultural treatments for resilience. To date, more than 18 forest landholders have been actively engaged in the stewardship of 1,927 hectares with habitat for species at risk. Site visits and workshops with professional foresters were provided to private forest landholders to discuss ecological forestry options that support habitat for species at risk.

ECCC Snapshot



Spotlight on Whooping Cranes

In 2024, ECCC participated in the first annual Northern Whooping Crane Festival in Fort Smith, NWT. The festival celebrates the recovery of the Whooping Crane and highlights conservation of species at risk in the South Slave region of the NWT. Activities included knowledge sharing sessions, Indigenous cultural learning, art exhibits, and interpretive hikes. ECCC biologists participated to share information about the conservation and recovery of this iconic species.

ECCC supported photographer and conservationist Michael Forsberg and the Cornell Lab of Ornithology as species experts to develop narrative animation that uses cutting-edge science and telemetry data to follow Whooping Crane migration through the lens of one family's 2,500-mile journey connecting critical wetland and grassland habitats along the way.

ECCC's collaborative efforts to recover Endangered Whooping Cranes was highlighted in an article in National Geographic about Whooping crane migration and conservation. The article follows John Conkin and Mark Bidwell, ECCC Whooping Crane biologists, and their colleagues in the field capturing and banding Whooping Cranes on the breeding grounds in Wood Buffalo National Park.

PC

Welcoming over 23 million visitors annually, PC has a unique opportunity to connect with the public and raise awareness about species at risk. This is done through various outreach and education programs including the Integrated Compliance and Law Enforcement Planning Process, which focuses on proactive communication with visitors to highlight the connection between their actions and the effect they have on the protection and recovery of species at risk and their habitat.

In Focus: Connected—A Parks Canada Podcast

First released in July 2024, Connected—A Parks Canada Podcast takes listeners on a journey through some of Canada's mountain national parks, uncovering the hidden stories of species at risk. Reaching over 270,000 people on social media, the podcast offers a compelling exploration of the challenges facing wildlife and plant species, and how PC teams are working to protect them.

All animals and plants are protected inside the national parks, but some need extra help. To bring more attention to these species, the Lake Louise, Yoho, and Kootenay Outreach and Education team developed six episodes for the series, focussing on Grizzly Bear, Westslope Cutthroat Trout, Black Swift, Wolverine, Whitebark Pine and Little Brown Bat. One of the species discussed, Whitebark Pine, is the only Endangered tree in Western America and is threatened by fungal pathogens like white pine blister rust, long term fire suppression, and Mountain Pine Beetle. Other species of Special Concern, like Wolverine featured in the fourth episode, are particularly sensitive to human disturbances and habitat fragmentation.

Available in both English and French, each episode features a different animal or plant and the PC specialists who work to protect them. Episodes also highlight ways individuals can get involved—whether by learning more about a species, supporting conservation efforts, or learning how to make a difference within their communities.



PC Snapshot



In collaboration with the Royal Canadian Geographical Society and Exploring by the Seat of your Pants, presentations reaching over 16,000 students were offered on the topic of endangered Beluga (at Saguenay–St. Lawrence Marine Park) and other species at risk—Atlantic Walrus, Northwest Atlantic population, Little Brown Myotis, Whitebark Pine, Half-moon Hairstreak, Olive-sided Flycatcher, Westslope Cutthroat Trout, Alberta population and Grizzly Bear, Western population (at Waterton Lakes National Park).

Visitors to Cape Breton Highlands National Park joined interpreters for an enhanced Bat Walk program, developed in 2024 to shed light on the plight of at-risk bats in Northern Cape Breton in the face of white-nose syndrome. Interpreters shared insights into the park resource conservation team's bat monitoring efforts. Guests had the chance to try detecting bats themselves using a handheld echo touch meter as they walked.



PC participated in a joint awareness campaign with DFO, the Marine Mammal Observation Network, and the Group for Research and Education on Marine Mammals to encourage visitors to observe Belugas from the shore, and to educate boaters about keeping their distance from Belugas. In all, the shore-based marine mammal observation centers welcomed 147,700 visitors in 2024. Of these, 10,500 took part in a brand-new interpretation activity showing live images of belugas. At the Pointe-Noire Observation and Interpretation Centre, 1,248 people took part in the Whales at Risk, it's our move! interpretation activity, to learn more about how to protect the St. Lawrence Beluga, Blue Whale and Fin Whale.

The Outreach team for the Cape Breton Field Unit participated in World Ocean Day with the Bras D'Or Biosphere to talk about the at-risk Atlantic Salmon Restoration Project. They reached over 110 people.



In 2024, the Lake Louise, Yoho, and Kootenay Field Unit led outreach and educational initiatives in Calgary and focused on the reintroduction strategies for threatened Westslope Cutthroat Trout and the management of aquatic invasive species. Over 200 visitors joined Hidden Lake: A Mosaic Unveiled guided conservation hike, which highlights species at risk and the ongoing Westslope Cutthroat Trout reintroduction efforts.



DFO

DFO has established an internal National Outreach Working Group (OWG) to serve as a forum to share information, support in measuring the effectiveness of outreach activities, and ensure national consistency in approaches to outreach with the goal of raising public awareness and increasing general knowledge of aquatic species at risk. The OWG maintains a national repository of materials to share resources across the country, and to track and report on outreach activities. It published the 'Species at Risk Public Outreach Survey' on the SAR Public Registry to assess the effectiveness of existing species at risk outreach activities conducted by DFO. The working group analyzed the responses to the survey, adopting some of the recommendations to improve outreach.

DFO continues to develop outreach activities across Canada. In the spring of 2024, in collaboration with Explos-Nature (an organization dedicated to environmental education and biological sciences research), the DFO Quebec Region's Species at Risk program held awareness workshops on the St. Lawrence Estuary Beluga in elementary schools located on the shores of the St. Lawrence Estuary, specifically in the Saguenay and Haute-Côte-Nord regions. In total, DFO visited 57 classes and increased awareness about the protection of the St. Lawrence Estuary Beluga to more than 900 students in 11 different cities. Each child received an awareness booklet on the St. Lawrence Estuary Beluga that had been produced by DFO in 2022.

Fishery officers play a vital role in promoting compliance through education and outreach.

Across the country, DFO's fishery officers engage with the public and partners to build awareness about species at risk and responsible fishing practices.

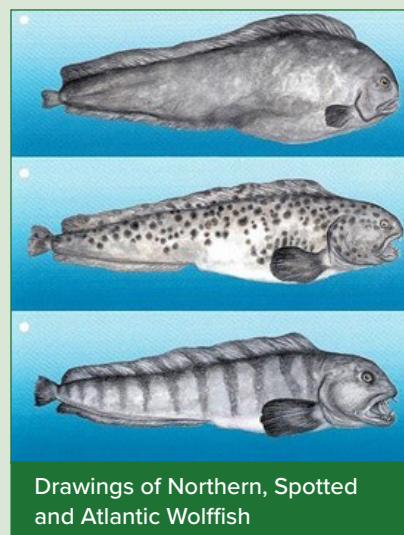
In Newfoundland and Labrador Region, fishery officers conducted 30 education and outreach sessions in 2024. These included one session for internal partners and 29 sessions with the general public, reaching audiences such as elementary and high school students, summer camp participants, Girl Guide troops, and attendees at community events, beach clean ups, and career fairs. The region also provided specialized training to 40 officers on marine mammal and sea turtle response

In the Maritimes Region, officers leveraged their dedicated outreach trailer, which includes SARA-specific tools, to support community engagement. They developed and installed educational signage to help anglers identify Atlantic Salmon, whitefish, and brown trout—reducing the unintentional retention of SARA-listed species. Fishery officers also educated the public about salmon pool closures and actively supported DFO's initiatives aimed at preventing North Atlantic Right Whale entanglements, reinforcing their commitment to species protection

Throughout the summer months, DFO collaborated with external organizations to educate Indigenous communities, the public, and the fishing industry about SARA-listed and COSEWIC-assessed aquatic species. DFO presented on SARA and the species at risk logbook to Gulf of St Lawrence fish harvesters and association representatives during Whale Safe gear engagement sessions in New Brunswick. DFO also collaborated with compliance and promotion officers at the Aboiteau wharf (New Brunswick), to educate professional fish harvesters and the public about the importance of filling out and returning information via species at risk logbooks. DFO further engaged with a youth summer camp at the Lennox Island First Nation (an Indigenous community located on Prince Edward Island) and with the public at the “Fête des amis de l’environnement” in Shippagan, New Brunswick, in collaboration with Aquarium NB.

In Focus: New Materials to Engage and Educate Youth

In 2024, Newfoundland and Labrador Region developed several new materials for outreach and education. Over the last number of years, this region developed the Species at Risk Booklet series. These booklets are intended to engage young children, as future ocean users and decision makers, giving them facts about species at risk and how everyone can help protect them. The region worked cooperatively to create a new booklet for the series on the Northern Bottlenose Whale. The program also used two bilingual mini-museums to further engage school-aged children on species at risk. The mini-museums are diorama-like glass cases with animal figurines inside and cardboard panels around all sides displaying species and habitat information. One mini-museum highlights the “whale pump” ecological process with Blue Whales by demonstrating how they transport nutrients from the deep ocean to the surface waters through their feeding and defecation patterns, supporting phytoplankton growth and the marine food web. The other mini-museum shows three Wolffish in their natural habitat, featuring a rock cave, white eggs, and Sea Urchins as their food source. Both mini-museums also have accompanying trivia cards that are meant to stir conversation and allow kids to find answers on the information panels. Additionally, in 2024 the region developed a new bilingual species ID drawing card for the Banded Killifish to help with education and identification.

DFO Snapshot



DFO participated in the 2024 World Oceans Day in a number of communities across the country to raise awareness about species at risk. The Maritimes Museum of the Atlantic on the Halifax waterfront hosted over 1,000 visitors, the Marine Institute in St. John's saw 1,900 visitors, and another 25,600 were reached virtually as part of the weeklong virtual World Oceans Day Facebook and Instagram event.



DFO hosted an interactive outreach display at the 2024 Latornell Conservation Symposium, October 8–9, 2024, which provided a hands-on interactive experience using [DFO's national aquatic SAR map](#), and highlighted a collection of 44 freshwater mussel shells. Daily attendance was roughly 500 participants.

DFO held virtual information sessions in Manitoba and Saskatchewan in January and February of 2025. The sessions outlined the SARA process, explained its purpose and defined the roles of various organizations, as well as the importance of recovery strategies and information on listed aquatic species in Manitoba and Saskatchewan.

DFO joined Dalhousie University at their Aquatron 50th Anniversary Celebration on May 11, 2024, to discuss Atlantic Whitefish with well over 2,000 attendees. Atlantic Whitefish is an endangered species found only in Nova Scotia.

DFO and ECCC delivered a training session to heavy equipment operators in Ontario and Manitoba during May–November 2024 to raise awareness about the *Species at Risk Act* and the *Fisheries Act* related to work in or near water and approaches to protect fish and fish habitat.

In 2024, DFO interacted with media to address inquiries related to species at risk in NL waters including, but not limited to, lumpfish, sharks, Sei whale, and American Eel. Other examples include a summer social media campaign asking people to share information about their whale and turtle sightings and reminding them to not disturb whales while on the water; or to help people identify sharks, including White Sharks and Porbeagles, in NL waters. The *Wolffish Progress Report* was also published.
