Annuaire des syndicis

Le présent numéro du Bulletin sur l'insolvabilité publie un annuaire des personnes détenant une licence de syndic.

L'annuaire regroupe les syndicis licenciés par districts de faillite et fournit des renseignements sur le nom, l'adresse, la firme et le numéro de téléphone tels qu'ils étaient connus du Surintendant au moment du dernier renouvellement des licences.

L'annuaire comprend également le nom des personnes ayant obtenu une licence de syndic, suite aux dernières séances des jurys d'examen.

Cet annuaire revêt une importance primordiale pour le Surintendant des faillites puisque les renseignements qu'on y trouve sont utilisés pour toutes les communications entre le Bureau du Surintendant et les syndicis (renouvellement de licence, correspondance générale, distribution du Bulletin sur l'insolvabilité, distribution des Directives, etc...).

Il se peut que des erreurs se soient glissées ou que certains syndicis aient changé d'adresse ou de numéro de téléphone depuis la préparation de la liste ou que d'autres changements surviennent au cours de l'année.

Trustees' Directory

In this issue the Insolvency Bulletin publishes a directory of persons licensed as trustees under the Bankruptcy Act.

The Directory identifies the licensed trustees for each bankruptcy district and provides information as to the name, address, firm and phone number as known by the Superintendent of Bankruptcy following the latest renewal of licences.

The directory also contains the name of individuals who have been granted a trustee licence following the last Oral Board.

The directory is most important to the Office of the Superintendent since the information contained therein is used for all communications between the Office and trustees (such as renewal of licences, general correspondence, distribution of Directives, distribution of the Insolvency Bulletin, etc...).

It may be that some of the information is incomplete or erroneous or that certain trustees have changed their address or phone number since the list was established. As well, other changes may occur during the year.
